# **QUESTION 7 (75 MARKS)**

#### Question 7 (a)

- (i) They have gone up a lot they were mostly between 1% and 5% in 2009, and mostly between 5% and 15% in 2011.
- (ii) They have gone up a lot too they were mostly between 2.3% and 4.1% in 2009 and mostly between 4% and 6% in 2011.
- (iii) There appears to be a stronger relationship in 2011 than in 2009.

#### Question 7 (a) (iii) [Scale 10B (0, 5, 10)]

5: Incomplete or partly correct statement, e.g. "They have changed" "Closer to being a line" Reference to positive

#### Question 7 (b)

You would need to know how many mortgage holders are represented by each point on the relevant diagram.

Question 7 (b) [Scale 5B (0, 3, 5)]

Some reference to the middle household
NOTE: accept (for full credit) reference to needing information about mortgage holders who are not on standard variable rates.

#### Question 7 (c)

It is a question of whether higher arrears rates cause interest rates to go up, or whether higher interest rates cause arrears rates to go up, (assuming there is a causal relationship at all).

#### Question 7 (b) [Scale 5C (0, 3, 4, 5)]

- **3**: Both may be caused by something else
  - General statement regarding correlation not implying causality no context
- 4: No reference to reverse situation, (e.g.: "It's about whether high interest rates cause high arrears rates or not.")

• Correct interpretation of concept, but not contextualised, (e.g. "It's a question of which variable causes which.")

#### Question 7 (d)

Number of properties =  $475\ 136$ Number of properties in negative equity =  $145\ 414$ Number of properties in negative equity that are also in arrears =  $11\ 644$ Number of properties neither in arrears nor negative equity =  $317\ 355$

Number of properties in negative equity but not in arrears =  $145\ 414 - 11\ 644 = 133\ 770$ Number of properties **not** in negative equity =  $475\ 136 - 145\ 414 = 329\ 722$ Number of properties that are in arrears but not in negative equity =  $329\ 722 - 317\ 355 = 12\ 367$ Number of properties in arrears =  $11\ 644\ + 12\ 367 = 24\ 011$ Number of properties **not** in arrears =  $133\ 770\ + 317\ 355 = 451\ 125$

(i)  $P(\text{Property in negative equity}) = \frac{\text{Number of properties in negative equity}}{\text{Number of properties}}$ 

$$=\frac{145\ 414}{475\ 136}=0.30605\approx 0.31$$

(ii) P(Property in arrears from those in negative equity ) =  $\frac{11\,644}{145\,414} = 0.08$ 

(iii) P(Property in negative equity from those in arrears) =  $\frac{11\ 644}{24\ 011}$  = 0.48

#### Question 7 (d) (ii) [Scale 5B\* (0, 3, 5)]

- **3**: Uses a relevant number
  - Writes  $\frac{\#E}{\#S}$  or equivalent.
  - Identifies "number of outcomes of interest = ..." or "total number of outcomes = ...".
  - Answer in form of a fraction

#### Question 7 (d) (iii) [Scale 10C\* (0, 4, 8, 10)]

- 4: Attempt to combine (i) and (ii) for part (iii)
  - Calculates total arrears and stops
- 8: Answer as a fraction
  - $\frac{11\,644}{12\,367} = 0.9415 = 0.94$

#### Question 7 (e)

Null Hypothesis  $H_0$ : P(Property is in negative equity) = 0.31 Alternative Hypothesis  $H_1$ : It has changed. P(Property is in negative equity)  $\neq 0.31$ 

At the 5% significance level the margin of error for the given sample =  $\frac{1}{\sqrt{2000}} \approx 0.0224$ 

Observed sample proportion  $=\frac{552}{2000} \approx 0.276$ 

Confidence interval = [0.276 - 0.0224, 0.276 + 0.0224] = [0.2536, 0.2984]

There is evidence to support the conclusion that the situation has changed since December 2010 because, based on the sample data, any values in the range 25.36% - 29.84% are possible values for the proportion of properties in negative equity.

So reject null hypothesis and accept the alternative hypothesis that the proportion of properties in negative equity has changed.

**IMPORTANT NOTE** This approach to finding the confidence interval is no longer used at Higher Level.

# MARKING SCHEME NOTES

## Question 7 (e) [Scale 20D (0, 7, 10, 18, 20)]

- 7: One relevant step e.g. null hypothesis stated only
  - Margin of error or observed proportion and does not continue
- 10: Substantive work with one or more critical omissions• Margin of error and observed proportion found but fails to continue
- **18**: Failure to state null hypothesis correctly and/or failure to contextualise answer (e.g., stops at "Reject the null hypothesis".
