### Maintenance

Any maintenance problems found either at the commencement of the tenancy or during the term of the same, should be reported promptly and directly to the Agent/Owner.

### **Furnishings**

Where the Inventory states fire regs labels seen, this is taken that labels are present on items of furniture that indicates these items comply with the Furniture and Furnishings (Fire Safety) Regulations 1988 (amended 1993). It is however not the responsibility of the inventory clark to state that these items do comply with these regulations.

Curtains are described with an approximation of length i.e. sill/skirting/floor length. Responsibility is not taken for noticing minor shrinkage cause by cleaning or washing.

# Fire Safety Equipments

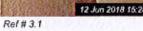

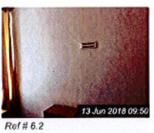

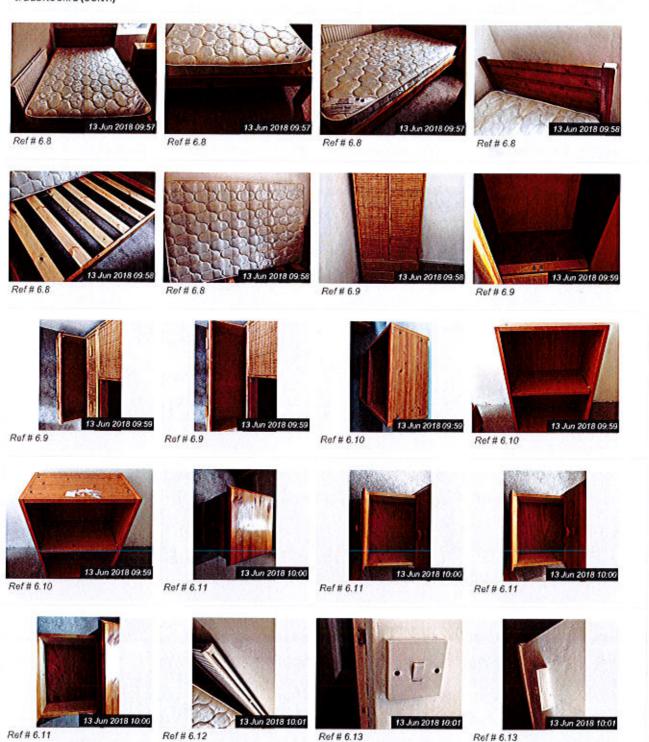
