
The Property

The existing landholding extends to approximately 0.77 Hectare (1.89 Acre).

The site, which was previously occupied by G4S, comprises of existing office and warehouse buildings. It is bounded to the East by Herberton Road, by rear gardens of residential properties to the North and West, and by industrial units to the South.

Under the Dublin City Development Plan 2022-2028, the property is zoned Objective Z10 Inner Suburban and Inner City Sustainable Mixed-Uses.

The Z10 zoning permits a broad range of uses including Office, Residential, Medical, Life Sciences, Education, Student Accommodation, Nursing Home, Retail along with many other potential uses.



Permitted Scheme

The site has the benefit of full planning permission for 113 residential units (Ref. No. LRD6020/23-S3). Dublin City Council issued a final grant of planning on 17 June 2024 for the construction of a mixed-use development across four blocks including 113 apartments, medical centre (1,490 sq m) & retail/cafe (80 sq m).

The proposed development would present as 4 blocks ranging from three to six storeys in height. The basement level is accessed

via ramp adjacent to Block B which provides 63 car spaces (60 basement & 3 surface level), 273 bicycle spaces (166 basement & 107 surface level), 5 no. motorbike spaces, alongside refuse, plant, communication and generator rooms and residential storage rooms. A public plaza and open space will be located south of Blocks C and D, while the communal open space within central courtyard and adjacent to northern, western and southern site perimeters (c. 1,186 sq m).


