LOCATION HIGHLIGHTS

- Aerodrome Business Park is one of Southwest Dublin's most recently developed parks, situated in a prime location only 550 metres from the Naas Road (N7).
- Strategically located and affording excellent access to the National Roads Network, the M50 Motorway is within 10 minutes' drive time, approx. 8.5 km to the N7 / M50 Motorway Interchange (Junction 9).
- The Outer Ring Road, accessed via the Kingswood Interchange on the N7 (3.4 km from the Rathcoole Interchange) links the Naas Road (N7) with the N4 and the Tallaght by-pass (N81).
- Occupiers in the Park include PRL Group, Catering Disposables, Fannin Healthcare, ECI JCB, Wesco, LifeStyle Sports & Iron Mountain.
