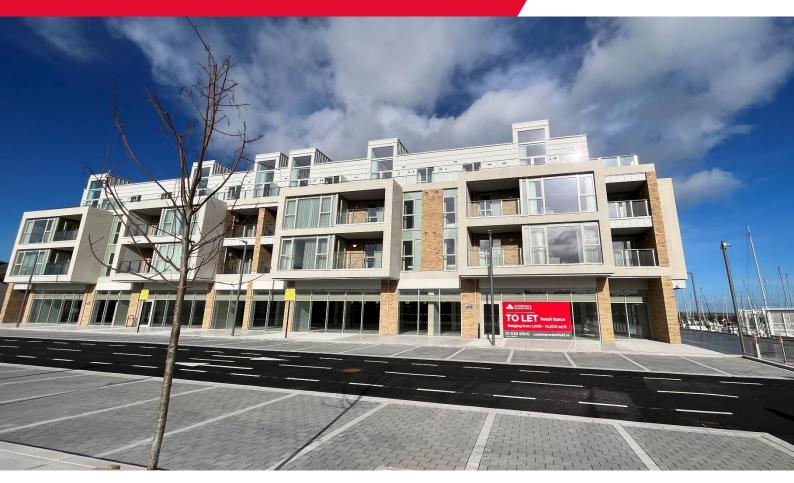
# Retail Opportunity: To Let Block D, Marina Village, Greystones

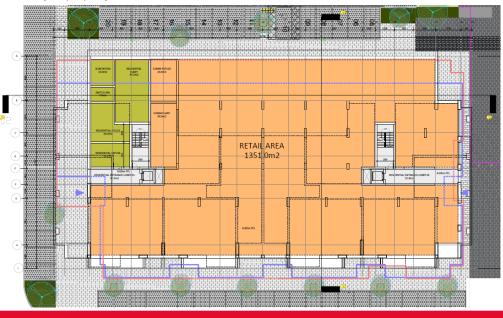
