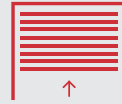

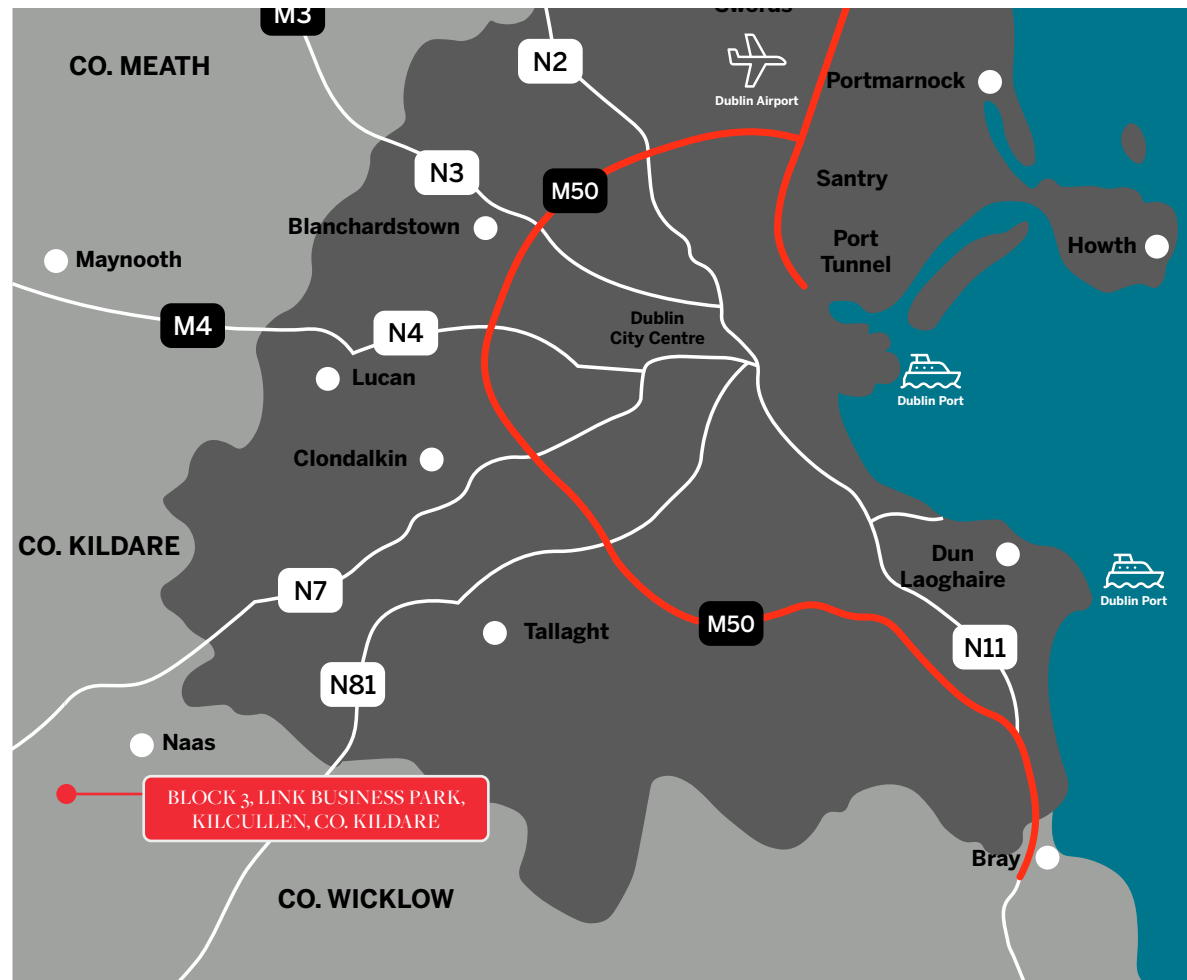

## Location

- Situated within the Link Business Park, on the western side of the R448, approximately 1.9km north of Kilcullen town centre, 8.2km south-east of Newbridge, 11.9km south of Naas town and 45km south-west of Dublin city centre.
- Other occupiers within the park include Kildare Bathroom Company, Bretzel Bakery, Heritage Bathrooms, RES Renewable Energy Systems and Animals First Veterinary Hospital.
- Kilcullen offers a small variety of retail opportunities with a wider selection of retailing and amenity options available in nearby Naas.
- Approx. 2.5km to the M9 motorway



# Description

- Comprises a refurbished detached industrial building
- Steel portal frame construction, with infill concrete block walls to 2.5m, under a double skin pitched metal deck roof incorporating translucent roof lights.
- Warehouse features a sealed concrete floor and accessed by 2 grade level roller shutter doors.
- Clear internal height of 6.6 metres.
- Property has the benefit of 9 car parking spaces together with communal overflow parking.
- Private secure gated yard to the rear.

- Installation of LED lighting throughout
- New Kitchen / Canteen, toilet & office facilities
- Installation of solar panels to produce approx. 12,000 kWh per year

- Property has recent Fire Cert, Planning Cert, Build Reg's Cert, Fire Alarm Cert & Electrical Cert.

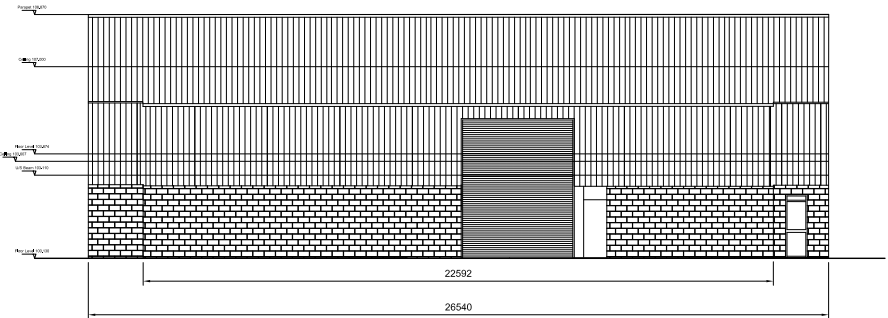

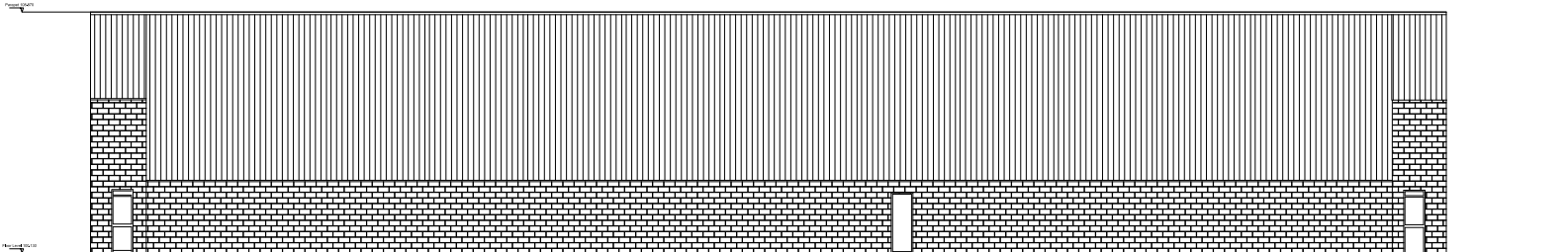
NORTH WEST ELEVATION - 1:100
