Description

The subject site extends to approximately 5 acres and occupies a strategic position on the southwestern side of Clonmel. With substantial frontage onto two principal streets, the property benefits from excellent visibility and accessibility.

The River Suir forms the full southern boundary of the lands, enhancing the site's appeal and allowing for an attractive riverside amenity within the approved scheme.

The granted planning permission allows for the delivery of a high-quality, integrated development combining residential, retail, and leisure uses, offering a compelling opportunity for developers seeking a well-connected and well-established urban location.



Location

Clonmel is the largest town in County Tipperary and a key commercial and residential centre in the region. The town benefits from strong transport infrastructure, with the N24 providing direct links to Waterford and Limerick, and connections to both the M8 and M9 motorways.

Clonmel Train Station, located under 2 km from the site, offers regular rail services, while a network of local and regional bus routes provides further connectivity. The town's population of over 18,000 (Census 2022) continues to experience steady growth, reflecting its ongoing appeal for residents, employers and investors.

Nearby amenities include schools, retail centres and recreational facilities, as well as established employment hubs within easy walking or short driving distance. Clonmel is home to major employers such as Boston Scientific, Abbott Vascular and C&C Group (Bulmers), contributing to a strong local employment base.

The town is also well served for education, with a good selection of primary and secondary schools in the area, along with TUS (Technological University of the Shannon - Clonmel Campus), which provides third-level education. Healthcare services are similarly well supported, with Tipperary University Hospital close by and a wide range of GP and specialist clinics available locally.






Planning Permission
