## LOCATION

The large commercial retail unit is situated mid-way to the eastern side of North Main Street which links from North Gate Bridge / Kyrl's Quay in the north to Washington Street, South Main Street and Castle Street. Adjoining occupiers include The Loft Furniture store, Mr Price discount store, Eurogiant, Murphy's Pharmacy and the Vicarstown Inn.

The premises also has vehicular access from Cornmarket Street, Coal Quay which is adjacent to the Bodega and across from The Cornmarket Centre featuring TK Maxx, Lidl and Chemist Warehouse.



## DESCRIPTION

The premises comprises of a modern large retail shop unit with high ceilings (3.86 Metres) and open plan shop on the ground floor comprising of 4,054 sq. ft., whilst the first floor has 3,941 sq. ft. with high ceilings and concrete floor with access by means of metal stairwell.

The unit has a canteen with ladies and gents restrooms at first floor level. The premises also enjoys vehicular access from Cornmarket Street which provides parking for 14 cars and access for deliveries.


