Location

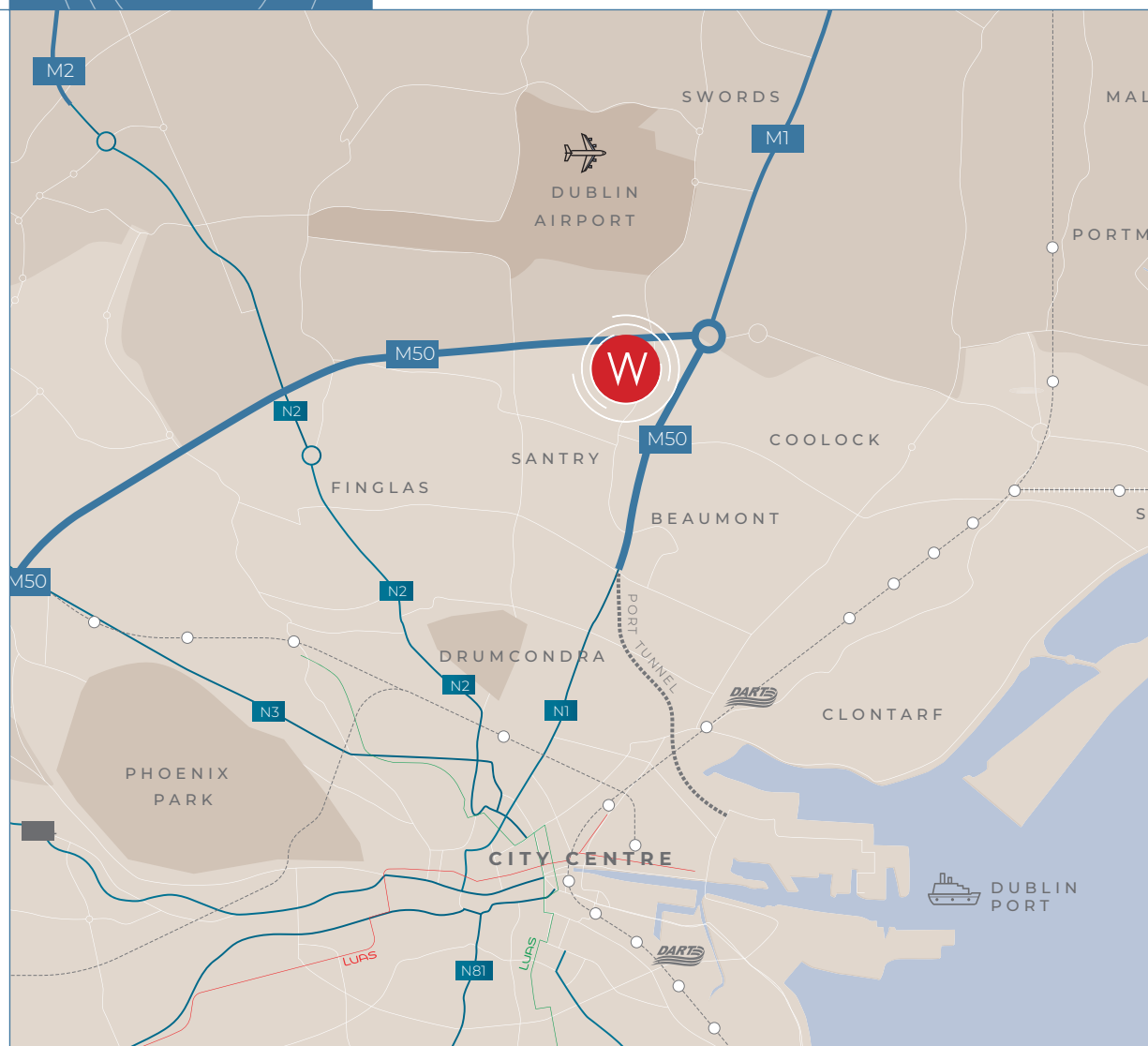
The property is located in Woodford Business Park, a prominent site facing Swords Road. The property is accessible from the old Swords Road, just minutes from the M1/M50 interchange and 2.9 km from Dublin International Airport. This location has excellent transportation links, such as the Dublin Port Tunnel. Swords Road and Santry are also well served by several bus routes that connect suburban and city centre locations.

The surrounding area is an established office location with nearby developments including: Northwood, Clonsaugh Business and Technology Park, Furry Park, and Santry Hall Business Park.

The immediate vicinity has a mixed range of commercial uses and amenities including the Crowne Plaza Hotel, Ben Dunne health and fitness center, Gulliver's Retail Park, a Sports Centre, and a Medical Centre. Santry village also has several cafes and restaurants.

Occupiers within the estate include CAE Parc Aviation, Fórsa Trade Union, McKesson Ireland, Oxendale, Keenan Property Management, and Airline Flight Academy.

Description

Block 2.3 Woodford Business Park offers a modern office building in a prominent site facing the Swords Road. The property comprises a two-storey terraced office building. Externally the block is clad with concrete, metal cladding and curtain glazing.

The available accommodation includes the first floor which extends to an estimated gross internal floor area of 7,203 sq.ft and offers occupiers fully fitted accommodation on flexible terms. The floor layout is a mix of open plan, cellular offices, computer rooms, meeting rooms, reception, and a large kitchenette/breakout area.

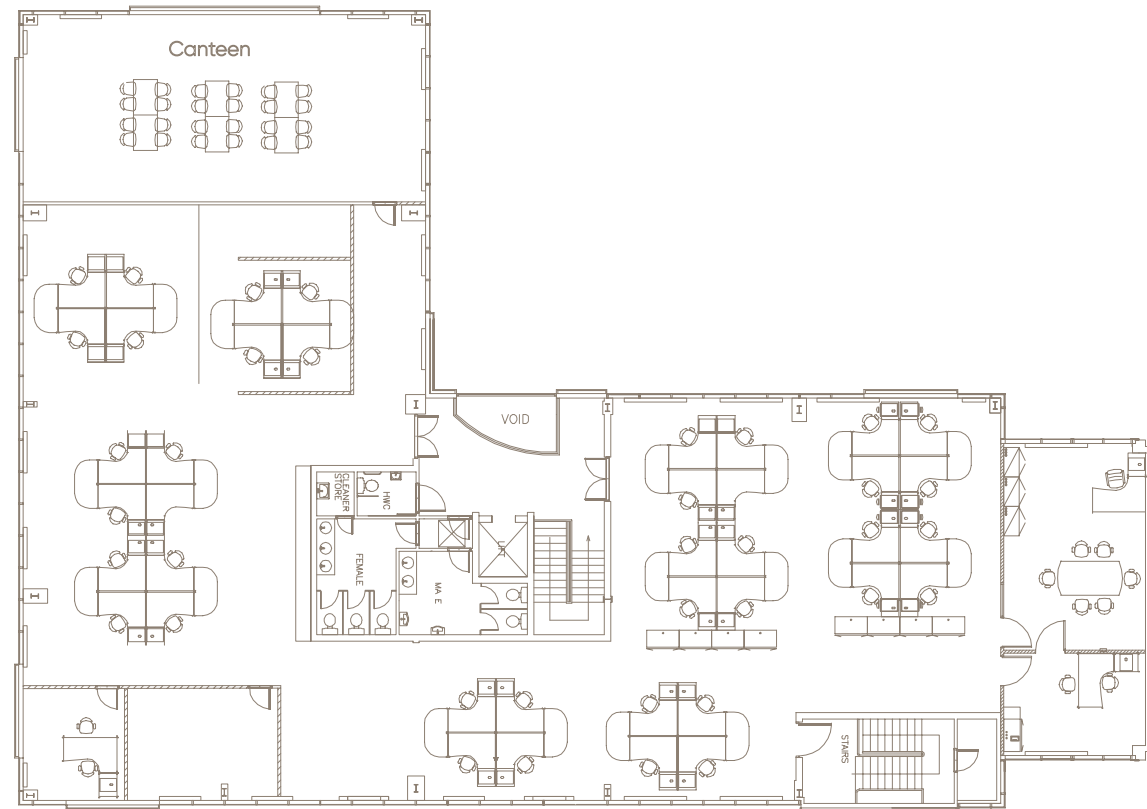
