Located in the sought-after area of Gormanstown, Kilcullen, Co. Kildare, this property enjoys a convenient rural setting with excellent access to a range of towns and transport links. Kilcullen is approximately 6 km away, with Naas located c. 15km north and Newbridge c. 18 km west. The M9 motorway can be accessed within minutes, providing an easy commute to Dublin City and surrounding areas.

The area is particularly well regarded for its strong equestrian and bloodstock connections, with close proximity to a number of leading training yards, stud farms and equestrian facilities throughout County Kildare. Punchestown Racecourse is approximately 12km away, while both the Curragh Racecourse and Naas Racecourse are easily accessible. Goffs Sales Complex at Kill is also within convenient driving distance, further enhancing the appeal of the location for those involved in the equestrian industry.

The holding comprises an extended four-bedroom detached bungalow together with c. 27.8 acres of good quality agricultural land all currently in grass and laid out in well-shaped, manageable divisions with excellent natural shelter and sections of post and rail fencing. The lands are well suited to a range of agricultural, equestrian and hobby farming uses.

Extending to approximately 1,776 sq. ft. (c.165 sq. m.), the residence is presented in good condition throughout and offers excellent potential for further modernisation and improvement.



Accommodation briefly comprises entrance hall, sitting room, kitchen/dining room, four bedrooms (one en-suite), office and family bathroom. Features include double-glazed PVC windows, PVC fascia and soffits together with oil-fired central heating.

The property is approached by a recessed entrance and is set amidst mature gardens to the front and side with additional ancillary outbuildings to the rear. The private setting together with the quality of the surrounding lands will appeal to purchasers seeking a manageable residential farm holding in a well-connected location.

The residence has been vacant for in excess of two years and should qualify for the Vacant Property Refurbishment Grant of up to €50,000, subject to the relevant terms and conditions, presenting an excellent opportunity for purchasers to refurbish and modernise the property to their own requirements.

Identification:

The deposit payable on the signing of the Contract is 10% of the purchase price.
