The property is c. 1km the M1, c. 2km from J3 of the M50, providing excellent access to the national road network, Port Tunnel, and Dublin Airport.

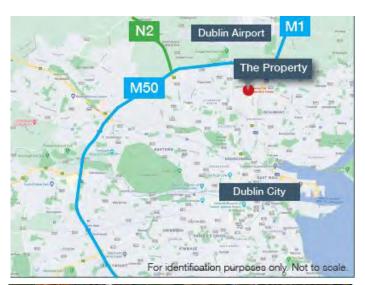
DESCRIPTION
