

MyDeez Terms of Use for Companies

Last updated: June 2016

MyDeez Technologies Ltd. ("**We**" or "**Us**" or "**MyDeez**") provides an online tool that facilitates the transfer of personal information between customers and companies and/or between individuals (the "**Services**"). These Terms of Use (the "**Terms**") govern your access and use of the Services we provide on our mobile app and on our website located at <http://mydeez.co> (collectively the "**Website**").

Please read these Terms carefully. By using the Website or the Services you signify your assent to both these Terms and our Privacy Policy, which is available at <http://mydeez.co>. Changes may be made to these Terms from time to time. Your continued use of the Website and/or Services will be deemed acceptance to any such amended or updated terms. If you do not agree to any of these Terms, please do not use the Website and/or Services.

These Terms are effective between You and Us as of the date of You accepting these Terms and in accordance with its terms and conditions as such may be updated from time to time in Our sole discretion.

1. CONSENT TO TERMS OF USE

By accessing or using the Website and/or Services, You confirm that You have read, understood, and agree to be bound by these Terms and You wish to utilize Our Services pursuant to the terms and conditions set forth in these Terms. If You are entering these Terms on behalf of a company or another legal entity, You represent that You have the authority to bind such entity and its Affiliates (as defined below) to these Terms, in which case the terms "You" or "Company" shall refer to such entity and its Affiliates.

2. DEFINITIONS

- 2.1. "Account" means the account created within the Services containing Your details.
- 2.2. "Affiliate" means any entity which directly or indirectly Controls, is Controlled by, or is under common Control with such entity. "Control," for purposes of this definition, means direct or indirect ownership or Control of more than 50% of the voting interests of the subject entity.
- 2.3. "Malicious Code" means viruses, worms, time bombs, Trojan horses and any and all other harmful code, files, scripts, agents or programs.
- 2.4. "Services" shall also include the Website and the related services that we provide, including any associated guidelines and tutorial components, and other related products and services, any and all accompanying personal support and services, if and as provided, and any changes and/or modifications of the above, which may be completed by Us from time to time, in Our sole discretion.
- 2.5. "Company" or "Companies" or "You" means any entity that uses the Website and/or Services which allows End Users or any other party to provide and update their information through the Website and/or Services.

- 2.6. "End User/s" means a customer of a Company who uses the Website and/or Services to provide and/or update his or her information to the Company; and/or individuals who use the Website and/or the Services to exchange their information
- 2.7. "User Data" means all electronic data, details and/or information, whether of the End Users or of You submitted by You or collected by Us while interacting with the Website and/or Services.

3. THE SERVICE

- 3.1. Provision of the Services. We hereby grant to You a non-exclusive, non-transferable and revocable license to electronically access and use the Website and/or Services in accordance with the terms of these Terms, which is subject to Your (i) having an Account with Us; (ii) subscribing as set forth on the Website and herein; and (iii) adhering to the terms and conditions of these Terms. In order for us to provide the Services You shall provide Us with certain details, which may include, inter alia, Your name, phone number, address, user name, and valid email address. Some features of the Website and/or Services may contain a specific identification number for the purpose of tracking the number of unique instances of such features being used by You. You must provide true, complete, and accurate registration information to Us, and it is important that You update your account and notify Us if Your information changes. Any loss caused by your failure to keep your account data up-to-date is your own responsibility. You should not reveal your password to anyone else. We will not ask You to reveal your password. If You forget your password, You can request to have a new password sent to your registered e-mail address. Your account is at risk if You let someone use it inappropriately and your account is subject to termination if You or anyone using your account violates these Terms. You agree to immediately notify Us of any unauthorized use of your account or password. If You are a business, government, or non-profit entity, You must use the actual name of Your organization. You may not use someone else's name, a name that violates any third party right, or a name that is obscene or otherwise objectionable. You may utilize the Services as long as You abide by the terms of these Terms and as long as Your Account is not terminated by either party hereto.
- 3.2. Companies Subscriptions. You shall make payments to MyDeez of the amounts set forth on a separate quotation or price list provided by MyDeez in the business agreement (the "**Agreement**"). You must make payment of such amounts according to the payment terms set forth in the Agreement and related Appendix. Payments shall be made on the first day of the month throughout the Subscription Term (as defined in the Agreement) unless earlier terminated in accordance with section 9.1 of these Terms. Late payments shall be subject to a late fee of 18% per annum or, if lower, the highest amount permitted by applicable law. We reserve the right to integrate additional components to the Website and/or Services which might be subject to additional fees at our sole discretion. All payments due to MyDeez shall be made in full without any set-off, and without any deduction or withholding on account of any tax, duty, charge, penalty, or otherwise.
- 3.3. Account. An Account is created for You by MyDeez after You sign the sales agreement, You may further complete Your subscription by providing us additional information. Unless We otherwise agree in writing, Company subscriptions are for designated Companies and cannot be shared or used by more than one Company. You are fully and solely responsible for the security of your computer system, mobile device, SIM card, phone number and all activity on your account, even if such

activities were not committed by You. MyDeez will not be liable for any losses or damage arising from unauthorized use of your account or password, and you agree to indemnify and hold MyDeez harmless for any improper or illegal use of your account, and any charges and taxes incurred, unless you have notified us via e-mail at support@mydeez.co that your account has been compromised, and have requested us to block access to it.

4. USE OF THE SERVICE

4.1. Your Responsibilities. You shall (i) be responsible for Your compliance with these Terms, (ii) be and remain solely responsible for the accuracy, quality, integrity and legality of the User Data and of the means by which You acquired the User Data, (iii) use commercially reasonable efforts to prevent unauthorized access to or use of the Services, and notify Us promptly of any such unauthorized access or use, (iv) be responsible for safeguarding all information provided as part of the Services and all usage of the Website and/or Services in the same manner you would safeguard Your own information of a confidential nature; (v) inform us of any changes in Your details, and in Your phone number in particular; (vi) use the Services only in accordance with applicable laws and government regulations. If You become aware of unauthorized access to Your Account, You must notify Us immediately. Without derogating from anything in these Terms or otherwise, You shall not (a) make the Services available to anyone other than those entities that have agreed to adhere to the terms and conditions herein, (b) sell, resell, rent or lease the Services, (c) use the Services to store or transmit infringing, libelous, or otherwise unlawful or tortious material, or to store or transmit material in violation of third-party privacy rights, or post, transmit, redistribute, upload, or promote any materials that violate or infringe in any way upon any rights of others, including without limitation, intellectual property rights such as, for example only, copyrights and trademarks (including any materials which are illegal, obscene, indecent, defamatory, incites racial or ethnic hatred, violates the rights of others, harms or threatens the safety of users or others or may otherwise constitute a breach of any applicable law), (d) use the Services to store or transmit Malicious Code, (e) interfere with or disrupt the integrity or performance of the Services or third-party data contained therein, (f) attempt to gain unauthorized access to the Services or their related systems or networks, (g) use any robot, spider, site search or retrieval application, or any other manual or automatic device or process to retrieve, index, search or data mine the Services, decompile, disassemble, reverse engineer, or otherwise attempt to derive the source code of any part of the Services, or in any way ascertain, decipher, or obtain the communications protocols for accessing any part of the of Services, or the underlying ideas or algorithms of any part of the Services, in an effort, for example, but without limitation to develop other applications or services that provide similar or substitute or complimentary functionality to such part of the Services; (h) remove or alter any trademark, logo, copyright or other proprietary notices, legends, symbols or labels contained on the Website and/or Services; (i) create derivative works based on the Services, copy, frame or mirror any part or content of the Services, other than copying or framing for Your own internal business purposes during the subscription term and for Your exclusive use; (j) access the Services in order to (a) build a competitive product or service, or (b) copy any features, functions or graphics of the Services;(k) violate any law; (l) intercept or monitor, damage or modify any communication which is not intended for You; (m) send unsolicited communications (also referred to as "SPAM", "SPIM" or "SPIT") or any communication not

permitted by applicable law or use the Services for the purposes of phishing or pharming or impersonating or misrepresenting affiliation with another person or entity; (n) use the Services to cause or intend to cause embarrassment or distress to, or to threaten, harass or invade the privacy of, any third party.

In addition, MyDeez shall provide You with several authorizations access to your Account in order to enable Your employees and/or anyone authorized on Your behalf (the "**Authorized Administrators**") to access and make use of the Website and/or the Services. You shall (i) be responsible for the use by the Authorized Administrators of the Website and/or the Services; (ii) be responsible for the compliance of the Authorized Administrators with the provisions of these Terms and of the Privacy Policy; and (iii) bear the sole liability for any breach of such provisions and/or misuse of the Website and/or Services by the Authorized Administrators.

- 4.2. Protection of the User Data. You understand that MyDeez collects the User Data you enter in the Website and/or Services, some of which User Data includes information that may personally identify the End Users or describe their personal interests or history. MyDeez may make all use of the User Data as set forth in the MyDeez Privacy Policy, which may be updated from time to time by MyDeez (the "**Privacy Policy**"). A current copy of the Privacy Policy is available at <http://mydeez.co>. You represent and warrant that by providing Us with the User Data including but not limited to End Users' cell phone number for the purpose of sending them a message or any other type of notification to access Our Services, You have obtained free, explicit and informed consent from the End User and you have been granted the right from the End User to share such information with Us.
- 4.3. Modifications and Additional Terms. Without limiting any other terms herein contained, We reserve the right in Our sole discretion to add, change, discontinue or otherwise modify elements and features to the Services at any time. We will post notifications regarding major changes on the Website. It is, therefore, important that You review these Terms regularly to ensure You are updated regarding any changes.
- 4.4. Promotional Online Alerts. By accepting these Terms and using Our Services, you affirmatively consent to receive from time to time automatic alerts and notifications, containing commercial and/or promotional content, via email and/or SMS messages. The said alerts and notifications shall contain information regarding updates and additional information with respect to the Website and the Services. You may, at any time, disable future alerts and notifications by notifying Our team at support@mydeez.co. Please note that we reserve the right to send you service related communications, including service announcements and administrative messages, relating either to your Account or to your transactions on this Services, without offering you the opportunity to opt out of receiving them unless you cancel your account.

5. PROPRIETARY RIGHTS

- 5.1. Intellectual Property. All right, title and interest in (a) the Website and/or Services, all content therein and related documentation and all enhancements, derivatives, bug fixes or improvements to the Website and/or Services; and (b) all trade names, trademarks, and logos of MyDeez shall at all times

remain solely with MyDeez and/or its licensors. All references in these Terms or any other communications to the sale, resale or purchase of the foregoing or any application shall mean only the right to use the Website and/or Services pursuant to these Terms. Subject to the limited rights expressly granted hereunder, We reserve all rights, title and interest in and to the Services and the Website and all related intellectual property rights. No rights are granted to You hereunder other than as expressly set forth herein. You acknowledge and agree the Website may include certain content (such as pictures, fonts, graphical items) which may be subject to proprietary rights of third parties, and that the Services including all components thereof is fully owned by Us and/or duly licensed to Us and may be protected under international patent, copyright, trademark or trade secret laws as well as international treaties. You further agree to not engage in the use, copying, or distribution of any of the Services other than expressly permitted herein, including any use, copying, or distribution of User Data of third parties obtained through the Services for any commercial purposes.

- 5.2. Grant of License. Company hereby grants MyDeez and its agents a worldwide, non-exclusive, royalty-free license to use, reproduce, display, distribute, prepare derivative works of, and perform Company's logo, name, trademarks and/or service marks in the Website and/or the Services for purposes of providing the Services.
- 5.3. Ownership of the User Data. The Services allow You to request User Data from End Users and submit User Data, which may be hosted, shared, and/or published as part of the Services. In connection with the User Data, you affirm, represent and warrant that the User Data and our use thereof as contemplated by these Terms and the Services will not violate any law or infringe any rights of any third party, including but not limited to any intellectual property rights and/or privacy rights. MyDeez shall be the sole and exclusive owner of the User Data it receives from you and nothing in these Terms shall be interpreted as giving you any rights or title to the User Data.

We take no responsibility and assume no liability for any User Data that you or any other End User or third party submits on the Website or Services. You shall be solely responsible for the User Data You provide Us and the consequences of submitting it. You shall further be solely responsible for ensuring compliance with all applicable data privacy law, rules and regulations of your authorized third party service providers with regard to the User Data that We may transmit them on Your behalf if You request MyDeez to do so. In such event, You hereby authorize Us to make use of Your third party service provider account username and of Your password and you hereby represent and warrant that you are entitled to give us such authorization in accordance with the terms of such third party service provider. You acknowledge and agree that MyDeez is acting as a platform in order to facilitate the exchange of User Data between You and the End Users and that as such MyDeez cannot and does not accept any responsibility for Your use of the User Data.

You understand and agree that You may be exposed to data that is inaccurate or otherwise unsuited to Your purpose, and You agree that We shall not be liable for any damages You allege to incur as a result of such data. The data presented on the Website or Services does not necessarily represent the views or opinions of MyDeez, and We make no guarantees as to the validity, accuracy or legal status of any such data.

NOTWITHSTANDING ANY VALUE ATTRIBUTED TO SUCH DATA BY YOU OR ANY THIRD PARTY, YOU UNDERSTAND AND AGREE THAT ANY USER DATA, ACCOUNT HISTORY, AND ACCOUNT CONTENT STORED ON OUR SERVERS, MAY BE DELETED, ALTERED, MOVED, OR TRANSFERRED AT ANY TIME FOR ANY REASON IN OUR SOLE DISCRETION, WITH OR WITHOUT NOTICE AND WITH NO LIABILITY OF ANY KIND.

You are responsible for backing up on your own servers the User Data that You submit or obtain through our Services. If Your subscription to our Services is terminated or expired, You hereby authorize Us to permanently delete the User Data from Our servers. You agree that We have no obligation to return User Data to You after your subscription to our Services is terminated or expired. Deleted User Data may be irretrievable.

You are solely responsible for any messages or commercial email that You send to any End User including whether such messages comply with applicable law. Please ensure that you have current and valid consent of the End User before you engage in such activities.

- 5.4. Third Parties. MyDeez does not endorse any products or services offered by any other third party. The Website and/or Services may provide links to third party websites or third party services or resources. We have no control over third-party sites, content or resources and all use of the foregoing is at your own risk.
- 5.5. Suggestions. You hereby grant us, and We hereby accept a royalty-free, worldwide, transferable, sublicenseable, irrevocable, perpetual license to use or incorporate into the Services any suggestions, enhancement requests, recommendations or other feedback provided by You relating to the operation of the Services.

6. WARRANTIES AND DISCLAIMERS

- 6.1. Mutual Warranties. Each party represents and warrants that it has the legal power to enter into these Terms.
- 6.2. Disclaimer. ALL CONTENTS FOUND ON THE WEBSITE OR SERVICE ARE PROVIDED ON AN "AS IS" AND "AS AVAILABLE" BASIS AND MAY CONTAIN DEFECTS OR ERRORS (SUCH AS BUGS OR GLITCHES). WE EXPRESSLY DISCLAIM ALL WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF QUALITY, PERFORMANCE, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT.

IF YOU USE THE WEBSITE AND/OR SERVICE YOU DO AT YOUR OWN RISK AND MYDEEZ SHALL NOT HAVE ANY LIABILITY THEREFOR.

8.1. Limitation of Liability. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL OUR AGGREGATE LIABILITY ARISING OUT OF OR RELATED TO THESE TERMS AND THE SERVICES, WHETHER IN CONTRACT, TORT OR UNDER ANY OTHER THEORY OF LIABILITY, EXCEED THE TOTAL FEES PAID TO US BY YOU FOR USE OF THE SERVICE DURING THE PRECEDING THREE MONTH PERIOD.

- 8.2. Exclusion of Consequential and Related Damages. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL WE HAVE ANY LIABILITY FOR ANY LOST PROFITS OR REVENUES OR FOR ANY INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, COVER OR PUNITIVE DAMAGES HOWEVER CAUSED, WHETHER IN CONTRACT, TORT OR UNDER ANY OTHER THEORY OF LIABILITY, AND WHETHER OR NOT THE PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. AS SUCH, IF YOU HAVE NOT MADE ANY PAYMENT TO MYDEEZ TO USE THE WEBSITE AND/OR SERVICE, MYDEEZ SHALL HAVE NO LIABILITY TO YOU IN RESPECT THEREOF.

9. TERM AND TERMINATION

- 9.1. Termination. These Terms come into effect on the day you register for the Services and continue until all Company subscriptions granted in accordance with these Terms have expired or been terminated. Either party may terminate this agreement with advance written notice of 7 days, provided, however, that MyDeez may terminate these Terms and all rights granted hereunder without notice if it shall have a reasonable belief that Company is using the Services in violation of these Terms or any applicable law, rule or regulation.
- 9.2. Term of Company Subscriptions. Company subscriptions made by You commence on the start date specified in the applicable subscription confirmation and continue for the subscription term specified therein or until the subscription is terminated in accordance with the terms of these Terms.
- Notwithstanding anything to the contrary, We may discontinue the Services at any time in Our sole discretion with no notice.
- 9.3. Surviving Provisions. Sections 5 (Proprietary Rights), 6 (Disclaimer), 7 (Indemnification), 8 (Limitation of Liability), 9.3 (Effect of Termination), and 10 (General Provisions) shall survive any termination or expiration of these Terms.

10. GENERAL PROVISIONS

- 10.1. Manner of Giving Notice. We may provide any required notices to the email address, fax number or by first class mail to other contact information You provided upon registration with MyDeez. Notices sent by email will be deemed received when they are sent by Us. Notices sent by fax will be deemed received upon the confirmation of receipt thereof. Notices sent by first class mail will be deemed received 10 days after sent by Us. Notices to Us shall be to one of the addresses detailed in the "contact us" section on the Website.
- 10.2. Relationship of the Parties. These Terms, including any of their provisions, do not create a partnership, franchise, joint venture, agency, fiduciary or employment relationship between the parties.
- 10.3. No Third-Party Beneficiaries. There are no third-party beneficiaries to these Terms.

- 10.4. Waiver and Cumulative Remedies. No failure or delay by either party in exercising any right under these Terms shall constitute a waiver of that right. Other than as expressly stated herein, the remedies provided herein are in addition to, and not exclusive of, any other remedies of a party at law or in equity.
- 10.5. Severability. If any provision of these Terms is held by a court of competent jurisdiction to be contrary to law, the provision shall be modified by the court and interpreted so as best to accomplish the objectives of the original provision to the fullest extent permitted by law, and the remaining provisions of these Terms shall remain in effect.
- 10.6. Changes to These Terms. We shall occasionally update these Terms to reflect changes in Our practices and services. When we post changes to these Terms, we will revise the "Last Updated" date at the top of these Terms. If we make any material changes in the way we collect, use, and/or share Your personal information, we may notify You by sending an email to the email address You most recently provided Us, and/or by sending a push notification or posting notice of the changes on the Website. By continuing to access or use the Services and/or the Website after those changes become effective, you are agreeing to be bound by the revised terms. We recommend that You check the Website from time to time to inform Yourself of any changes in our Privacy Policy or any of Our other policies.
- 10.7. Assignment. You may not assign any of Your rights or obligations hereunder, whether by operation of law or otherwise, without the prior written consent of Us. Notwithstanding the foregoing, We may assign these Terms in their entirety, to any third party, including to Affiliates. Subject to the foregoing, these Terms shall bind and inure to the benefit of the parties, their respective successors and permitted assigns.
- 10.8. Governing Law & Venue. These Terms shall be governed by and construed in accordance with the laws of the State of Israel. Each party consents to, and agrees that each party is subject to, the exclusive jurisdiction of the competent courts of Tel-Aviv, Israel, for any litigation arising out of these Terms.
- 10.9. Anti-Corruption. You have not received or been offered any illegal or improper bribe, kickback, payment, gift, or thing of value from any of Our employees or agents in connection with these Terms. If You learn of any violation of the above restriction, You will use reasonable efforts to promptly notify Our team at info@mydeez.co.
- 10.10.
