- Provide details of two people who can comment on your work professionally. Please indicate how long and in what capacity your referees have known you. Referees will not be contacted without your permission.

Please note that it is likely we will seek to take up two references for candidates prior to making an offer. This will be discussed at the first interview.

Introduction

New Adventures is an iconic, ground-breaking British dance-theatre company, founded by celebrated choreographer Matthew Bourne, famous for telling stories with a unique theatrical twist. Since 1987, New Adventures has changed the popularity of dance in Britain, creating works that have altered the public perception of what is possible when it comes to telling stories without words.

First established in 1987 as Adventures in Motion Pictures with the support of a start-up grant from Arts Council England, early works included Town & Country; Spitfire, which was most recently seen online as part of BBC's Dancing Nation and on stage as part of the British Ballet Gala at the Royal Albert Hall in June 2021; and Highland Fling. Following these small-scale successes, Matthew went on to reimagine the worlds of The Nutcracker and his now iconic Swan Lake. This production had a huge impact on the dance world, inspiring young male dancers, and the future of the company. After experiencing worldwide success with Swan Lake, the company relaunched as New Adventures in 2003 and since then has gone from strength to strength.

New Adventures has received numerous international awards and an incredible 6 Olivier Awards and 12 Nominations. We have created 13 full-length productions and a triple-bill of short works. The company tours nationally and internationally, our award-winning repertoire inspiring and thrilling millions of people worldwide.

The company was established as a charity in 2008, enabling us to reach more people and grow our work offstage in schools, communities, and training institutions. After the national success of Lord of The Flies bringing together young boys and men with little or no experience of dance with a professional company of dancers, we joined the Arts Council England National Portfolio in 2015. We are passionate about diversifying the dance landscape and investing in the future of dance through delivering inclusive projects for people of all ages, abilities, and backgrounds alongside development opportunities for emerging artists. We deliver a wealth of transformative programmes year-round.

Producing shows since 1967, Cameron Mackintosh remains the world's most prolific producer of musicals in theatre history. As well as producing three of the world's longest running musicals, *Les Misérables, The Phantom of the Opera* and *Cats,* his legendary productions include *Miss Saigon, Mary Poppins* (co-produced with Disney), *Oliver!, Side By Side* By Sondheim, *Little Shop Of Horrors, Song And Dance, Tomfoolery, The Witches of Eastwick* and *Five Guys Named Moe.* His acclaimed new productions of *My Fair Lady, Oklahoma* and *Carousel* have all been international successes, as have his reinvented new productions of *Les Misérables, Miss Saigon* and *The Phantom of The Opera.* Cameron is also co-producer with Jeffrey Seller of *Hamilton* in London and on tour in the UK.

About the Role

The placement will be in the role of WHAM Assistant for the 2-year period and will involve gaining experience and working in of all aspects of the WHAM department, as well as external mentoring and training in related skills.

This is a specially funded 2-year position as part of the **Theatre Artists Fund Pilot Programme**, recognising the importance of the creative and technical theatre workforce and the way organisations are forming their recovery, following the impact of COVID-19 on UK theatres. The position will run from January 2024 until January 2026.

In this role, you'll work with the touring productions' WHAM team on tour, alongside a Head of Department, a Deputy Head and other Assistants.

Initially, this will be on New Adventures' production of *Edward Scissorhands* which is currently at Sadler's Wells Theatre in London and which will head out on tour from 23 January, starting in Canterbury. This will involve weekly touring around the UK until the end of May and a week in Amsterdam at the end (see attached tour schedule). You should therefore be prepared to tour within the UK (and occasional international dates). Initially, duties would take place on a Tuesday — Saturday inclusive with a Sunday to travel and a Monday off.

From June, your placement will move to be with Cameron Mackintosh Ltd on one of their productions, based either on tour or in London.

From October 2024, you will join New Adventures' revival of their iconic production of *Swan Lake* which will tour until the following June 2025. You will then move back to Cameron Mackintosh Ltd to work on another of their productions until October 2025, when you will start your final placement with New Adventures until the end of the placement in January 2026.

We are interested in hearing from mid-career applicants who have already got experience in WHAM in a theatrical environment. This is not an entry-level position for applicants who are seeking their first job out of college or with no theatrical experience.

You should have the right to work in the UK and will need to undergo a DBS check, the cost of which will be covered by the employer.

Duties and Responsibilities

The WHAM Placement's responsibilities will include:

- Help coordinate the efficient management and maintenance of the wigs department;
- Take care of all wigs ensuring that they are maintained and stored appropriately;
- Assist with wig fittings as required;
- Fulfil any make-up requirements needed for the show at the request of your manager;
- Learn and carry out wig show plots as required;
- Pre-setting wigs correctly and assisting artists into them where necessary;
- Maintaining accurate records of your wig plots and updating them as necessary;
- Attend get-in, fit-up and get-outs of each venue as required;
- Assist with teaching plots and supervision of local venue staff on tour;
- Assist with preparing wigs in line with daily cast changes;

- Undertake cast hair-cuts if appropriate and required;
- Help ensure requests from supervisors or the creative team are carried out;
- Attend any promotional events or events held by the Theatre Artists Fund regarding your placement as required as requested by your manager;
- Attend meetings as requested by your manager;
- being aware of the Producer's health and safety policies and ensuring that requirements in relation to health and safety are met within the department;
- upholding and promoting at all times the Producer's child protection policy and related procedures and guidelines;
- Any other duties as may be reasonably required in the course of your duties or training as WHAM Placement and as instructed by your manager.

You will also undertake external training in specialist courses which you can choose in conjunction with New Adventures and Cameron Mackintosh Ltd to tie-in to your skill set and the productions you will be working on. These might include: barbering, wig-knotting, period styling and Afro styling.

Any fees for these training courses will be covered by the employer, as will expenses to attend. These will be scheduled by mutual agreement.

You will also be assigned a mentor from the industry who will have regular sessions with you to monitor your progress.

Contract: Employed contract, full-time

Hours: 48 hours per week on a buyout basis

You will be employed on a standard theatrical touring schedule, with duties on a Tuesday — Saturday inclusive with a Sunday to travel and a Monday off. This may vary later in the placement and

in tech weeks.

Location: On tour

Reports to: Head of Wigs

Probationary Period: Three months during which period two weeks' notice is required

by both parties.

Subsequent Notice Period: Following successful completion of Probationary Period, four

weeks' notice is required.

Paid holiday entitlement: 4.8 weeks of holiday per year to be taken at mutually agreed

dates.

Pension scheme: If the postholder meets the qualifying criteria, they will be

automatically enrolled into the company pension scheme, which is with NEST. The employer's contribution is 3% and employee

5%.

Mentoring: Provided on a regular basis with an external mentor

Identity checks: The successful applicant will need to provide official documents

to confirm that they have the right to work in the UK and undergo an enhanced check with the Disclosures and Barring Service.

New Adventures will pay for a DBS check if needed.
