Any Changes to the below requirements will only be honored if accepted by ARTIST and MANAGEMENT, in advance in writing.

1. Purchaser must supply **professional sound equipment, lighting, and performance requirements, which include:**

A. **House system:** House system should be capable of producing consistent clean sound throughout the venue with sufficient sub bass.

B. **Monitors:**

- 1 (one) to 2 (two) monitors with corresponding cords. (If only one monitor, position it on the right side.)

C. **Required Equipment **NO EXCEPTIONS TO BELOW TECHNICAL REQUIREMENTS****

- 2 (two) Technic 1200 Turntables (Any Model) turned battle style. (Tone arms facing away from the artist.) Turn tables MUST be placed battle style and sitting directly next to the mixer on each side of the mixer. No Spaces. Turntables must be in perfect working condition.
- 1 (one) SERATO SCRATCH LIVE SET UP including Serato Box and USB Cable.
- 1 (one) Pioneer DJM 900nexus Mixer or DJM S9****NO EXCEPTIONS****
- 1 (one) Laptop stand positioned directly over the mixer with at least 6" inch clearance from the mixer
- 1 (one) microphone

D. **Additional DJ Booth Needs**

- 1 (one) 6' x 4' Table at least 3.5 FEET HIGH for DJ Equipment to be situated on (COFFINS are NOT Acceptable) **NO FOAM UNDER THE TURNTABLES!**
- Sufficient Lighting (Brighter than a candle lit) for both base/main table and additional table space.
- Sufficient snakes, cables, and mic stands must be provided to patch above equipment.

E. **Hospitality**

- 1 (one) bottle of Grey Goose and mixers
- 6 (six) cans of Red Bull
- 4 (four) bottles of water
- 4 (four) cloth towels

2. Purchaser agrees to the following **safety conditions:**

- Equipment (Mixer, & Turntables) must be situated away from any bar or beverage areas.
- ARTIST area must not be accessible to the general public from the front sides, and especially from behind.
- During the entire span of the artists performance, there will be no persons inside the booth besides authorized staff or artists representatives/friends.

3. Purchaser agrees to the following **travel accommodations** when applicable:

- 1 (one) full fare COACH round-trip Airline ticket *Itinerary must be approved by artist.
- All Ground Transportation from time of arrival to departure.
- 1 (one) King Bedroom at Artist Approved hotel.
- All necessary work, travel, and entrance visas and/or permits.

4. Purchaser agrees to the following **additional items:**

- ARTIST reserves the right to play whatever music DJ wishes to play unless a specific music/song request is provided and agreed to prior to signing of this agreement.
- ARTIST does not need to attend sound check and will arrive approximately 30 minutes prior to scheduled performance time.
- ARTIST requires at least 10 guests, allowed to attend at anytime during the event. Upon purchasers approval, Sleeping Giant Music will run a guestlist that closes at 5pm for additional guests to attend. A point of contact via email must be provided prior to the completion of this contract.
