

# HMO Buy to Let

## Key information sheet



Our extensive range of buy to let products designed specifically for deals involving an HMO property could make the funding process easier for your customer's next deal.

### Key points of interest

- ▶ Up to 80% LTV available, including new build flats and houses.
- ▶ Loan size: up to £1m available at 70% LTV, £750k at 75% LTV and £500k at 80% LTV.
- ▶ **IMPROVED** Portfolio: up to 20 properties to a value of £10m with Precise Mortgages, unlimited properties with other lenders.
- ▶ Interest coverage ratio (ICR) from 125% - Bespoke ICRs available based on individual circumstances to help customers achieve the loan they want
- ▶ Minimum age: 25 years - Maximum age: 80 at the date of application (maximum term of 35 years)
- ▶ HMO properties in England and Wales only.
- ▶ Minimum valuation £250k in London, £100k elsewhere. Refer to HMO product guide for details.
- ▶ No minimum income requirements on loans up to £1m.
- ▶ Accept self-employed with 12 months trading.
- ▶ Occupational/private pension income acceptable (subject to an underwriter review).
- ▶ Terms available between 5-35 years.
- ▶ Fees can be added to the loan above the product LTV limit.
- ▶ Bridge to HMO available.
- ▶ Multiple lets permitted.
- ▶ Available to experienced landlords.
- ▶ Adverse according to Tier 1 guidelines allowable (see below).
- ▶ Maximum 8 bedrooms.
- ▶ Conveyancer to confirm, prior to completion, that licence application has been made if applicable.

### Allowable adverse

The below provides information on the maximum allowable adverse on our HMO buy to let product range.

**Defaults:** 0 in 24 months.

**CCJ:** 0 in 24 months.

**Missed mortgage/secured loan arrears:** 0 in 36 months.

**Unsecured loan arrears:** 1 in 12 months, 2 in 36 months.
