

**What is Abuse?** Child and Young Adult abuse is in any form of physical, emotional or sexual mistreatment or lack of care that leads to harm or injury qualifying as neglect. It commonly occurs within a relationship of trust or responsibility and is an abuse of power or breach of trust. Abuse can happen to any children regardless of their, age, gender, race or ability.

**What is Discrimination?** Discrimination occurs when people receive less favorable treatment on any grounds which cannot be shown to be justified. This covers race, ethnic or national origin, sexual orientation, disability, responsibility for other dependents, social class or where the person lives.

**What is CSE?** Sexual exploitation of young persons under 18 involves exploitive situation where a young person received something (e.g. food, alcohol, cigarette, affection, gifts or money) as a result of them performing, and/or another or others performing on them sexual activities.

**What is FGM?** It is the illegal act of partial or total removal of external female genitalia for non-medical reasons.

**What is Prevent Duty:** A duty on schools to recognise that some children are vulnerable to radicalisation and there is a clear safeguarding procedure in place to act upon any concern. It is a STATUTORY REQUIREMENT.

**What has increased the risk of radicalisation?** Social media and the ability of organisations, such as ISI, to communicate their message to young people in other countries that would previously have been more difficult.

## Welcome to our school

**ST MARY'S CATHOLIC PRIMARY SCHOOL** is committed to safeguarding children and promoting children's welfare. **The school expects all staff, governors, volunteers and visitors** to share this **commitment and maintain a vigilant and safe environment**. It is our willingness to work in a safe manner and challenge inappropriate behaviour that underpins this commitment.



### Visitor Procedures:

- ⇒ All visitors must sign into the school
- ⇒ All visitors will be issued with an appropriate pass which must be displayed at all times whilst on the school site.
- ⇒ Visitors will be asked to remain under the supervision of a designated member of staff whilst on site
- ⇒ All visitors must sign out at the Main Reception before leaving the site
- ⇒ Do not give any personal information to pupils, such as your mobile number, email address or social networking information.

### E-safety:

- ⇒ **Mobile phones:** to protect our children we respectfully ask that you do not use your mobile phone during your visit. Please ask a member staff about the appropriate place where you can take calls if you are expecting one.
- ⇒ **Photographs:** under no circumstance should you take photographs of our children whilst at our school

### What do I DO if I am worried about a child?

If you become concerned about:

- ⇒ Something a child says
- ⇒ Marks or bruising on a child
- ⇒ Changes in behaviour or demeanour

Please report these concerns to the class teacher who, if they feel is appropriate, will pass the information on to one of the school Designated Safeguarding Leads. Child abuse happens to all children regardless of gender, culture, religion, social background and those with or without a disability.

### What do I Do if a Child Discloses they are being harmed?

- ⇒ Whilst this can be an alarming situation, is it important that you know what to do in such an eventuality and for you to stay calm and controlled.
- ⇒ Listen carefully to the child, practically what is said spontaneously.
- ⇒ Remember not to show shock or disbelief.
- ⇒ Do not promise confidentiality. Reassure the children but do not make promises that might not be possible to keep.
- ⇒ Do not interrogate or ask leading questions.
- ⇒ Reassure the child that it is not their fault and stress that it was right to tell.
- ⇒ Record carefully what the child says in their words including how and when the account was given. Date, time and sign the record. Pass it on to one of the safeguarding Leads
- ⇒ Reassure the child that you will tell a Teacher or the Headteacher who will be able to help them further and keep them safe.

### Health and Safety :

**Fire:** In the event of a fire alarm please use the nearest fire exit and make yourself known to the member of staff.

**Accidents and illness:** All accidents, regardless of severity need to be reported to a first aider. Staff will inform you of the first aider nearest to where you are based. All accidents will be logged in the accident book.
