Types of SEN provided for at the Academy 2016-17

The range and numbers of pupils with special educational needs changes on an annual basis. In the previous academic year, the following types of SEN were provided for:

Communication and Interaction

- Speech, language and communication difficulties
- Social interaction difficulties
- Autistic Spectrum Disorder

Cognition and Learning

- Cognitive delay
- Dyslexia

Social/Emotional and Mental Health

- Anxiety

Speech, language and communication difficulties represent a common of difficulty for children joining the Academy. The direct employment of a speech and language therapist ensures than any difficulties highlighted by the class teacher or parent/carer can immediately be referred, assessed and an appropriate intervention planned. Over the course of 2017-18, 24 children were supported by the Speech and Language Therapist, 7 of which were discharged from the speech and language therapist's caseload as their goals had been achieved. Communication and Interaction continues to be the largest area of need throughout the school and we are fortunate to

have key members of support staff who specialize in Autistic Spectrum Disorder as well as being trauma informed practitioners. For any other form of SEN which has been identified, the class teacher and SENCO, with advice from external agencies if appropriate, will devise and ensure appropriate targets are set and reviewed as stated

Admissions and Inclusion

- All the teachers in the Bishops' C of E Learning Academy are teachers of children with Special Educational Needs & Disabilities. As such the Bishops' C of E Learning Academy adopts a 'whole school approach' to special educational needs & disabilities which involves all the staff adhering to a model of good practice. The staff are committed to identifying and providing for the needs of all children in a wholly inclusive environment. Inclusion is regarded as essential to the policy, in line with that of Children, Schools & Families. The Academy operates an equal opportunities policy for children with special educational needs & disabilities and medical conditions who are afforded the same rights as other children. This includes those children with Statements of Special Educational Needs & Disabilities or Education, Health Care Plans and all pupils with additional and different provision.
- The National Curriculum is accessible for all pupils. Where pupils have special educational needs & disabilities, a graduated response will be adopted (assess, plan, do review cycle). The Academy will, in other than exceptional cases, make full use of classroom and Academy resources before drawing on external support.
- The Academy will make provision for pupils with special educational needs & disabilities to match the nature of their individual needs and the class teacher and SENCo will keep regular records of the pupils' special educational needs & disabilities, the action taken and the outcomes.

Identification and assessment of SEN

- The Academy offers a differentiated curriculum. When a pupil fails to make expected progress over a period of time, despite targeted interventions and shows signs of difficulty in some of the following areas: acquiring reading, writing and maths skills; presenting persistent social emotional & mental health difficulties; has sensory or physical problems or communication or interaction difficulties, the Academy will place the pupil at SEN Support and support that is additional to and different from the differentiated curriculum will be provided through an SEN Support Plan in a range of ways including:
 - Classroom organisation and management
 - In-class support by teacher/teaching assistant
 - Withdrawal, if necessary, for individual/small group work
 - Emotional coaching
 - Use of specialist equipment/resources
 - Alternative teaching strategies

- The resources allocated to pupils who have special educational needs & disabilities will be deployed to implement these SEN Support Plans at SEN Support as outlined in the revised Code of Practice. Parents will be informed and pupils will be involved in decisions taken at this stage. **(please refer to the section on partnership with parents and carers on page 8)**
- If a pupil does not make progress, despite the Academy taking the action outlined, advice will be sought from the appropriate support services **(please refer to page 2 for a list of these agencies)** and the SEN Support Plan will be amended accordingly.
- If progress is still not achieved the child may be assessed, bearing in mind the County's criteria, with a view to initiating a statutory assessment of special educational needs & disabilities under the 1996 Education Act. The appropriate forms are used for recording and referral as necessary.
- Identification of special educational needs & disabilities will be undertaken by all staff, with support from the SENCo and the appropriate records and Children Schools & Families forms will be maintained. Records will be developed through a process of continuous assessment by the class teacher or as a result of standardised tests of educational achievement administered by the class teacher or the SENCo together with continuous progress monitoring and end of Key Stage attainment tests. Assessments allow the pupil to show what they know, understand and can do, as well as to identify any learning difficulties. Where necessary, pupils will be referred to the SENCo for further assessment to construct a profile of the child's strengths and weaknesses, and further referrals may be made to appropriate external agencies.
- The progress of children with special educational needs & disabilities will be reviewed through formative and summative assessments as outlined in the Code of Practice. SEN Support Plan reviews will be held termly. Additionally, the progress of children with a Statement of Special Educational Needs & Disabilities and Education Health Care Plans will be reviewed annually, as required by legislation.
- Detailed records and Education Health Care Plans will be kept of the pupils receiving additional and different provision. These may include: phonic check-lists, regular assessments of outcomes in small group provision and the results of any standardised and diagnostic tests. A summary of these will be passed on to any receiving school.

Types of additional and different provision for pupils with SEN 2017-18

- The Academy provides a variety of interventions which are needs led. The pupils receiving interventions are assessed and monitored by their class teachers, subject leaders, senior leadership team and staff carrying out specific interventions, overseen by the SENCO. Intervention groups were monitored and clearly defined outcomes were measured, both on a holistic basis as well as considering children's progress in the core subjects of numeracy and literacy.
- Almost all children participating in these groups made progress according to academic measures and excellent holistic outcomes were achieved in terms of targets such as : listening and attention; self-esteem; social communication.

Pupil progress according to data outcomes in the core subjects 2017-18

This data was provided by ASP 2017-18 which tracks all pupils' achievement at the end of each key stage in all schools in England (at the Bishops', this will be Reception, Year 2 and Year 6) and the pass rate for the Year 1 phonics screening test.

Foundation Stage Data

At the end of the academic year, 33% of pupils designated at SEN Support achieved the Early Learning goals across the seven areas of learning in the Early Years Foundation Stage (EYFS) curriculum, compared with an average of 24% in Cornwall. 79% of all pupils achieved a good level of development, compared with a 74% average in Cornwall. All pupils with SEN support made at least expected progress in the majority of areas of learning, with all children working with SEN support making accelerated progress in a number of areas including reading and mathematics.

Year 1 Phonics Screening

22.2% of pupils designated at SEN Support passed the phonic screening check (national level = 44%)

Year 2 SATS

The eight pupils designated as SEN Support in Year 2 did not achieved age related expectations for the end of Year 2 in reading, writing or mathematics but they did make progress from their starting points.

Year 6 SATS

Of the two pupils designated as SEN Support, one did achieve age related expectations in reading, writing and mathematics. The other pupil did not achieve age related expectations but made progress from their starting point.

Training and expertise of staff supporting SEN

- The SENCO has many years of experience working with children with a range of SEN and has undertaken the National Award in SEN Coordination at Masters Level. The SENCO provides advice and support to all classroom staff to support pupils with SEN as well as undertaking various diagnostic tests such as the dyslexia screening test. The SENCO refers to external agencies for additional advice where appropriate and has excellent links with the Early Years Support Service who have

- The Academy benefits from the expertise of the TLAT speech and language therapist, who is able to offer advice and training on a regular basis to all staff at the Academy on speech, language and communication issues.
- The assistant SENCO and pastoral worker is a trained 'social worker' and is able to offer advocacy and strategies to all staff working with pupils with social/emotional and mental health issues
- Various staff have received training in areas such as: speech, language and communication difficulties; ASD awareness, positive handling, sensory integration difficulties.

Answers to Frequently asked Questions

1. How does your Academy know if children need extra help and what should I do if I think my child may have special educational needs?

We use a variety of assessment strategies which are monitored regularly to ensure the progress of all children. If your child is not making progress then a range of appropriate assessments will take place to ascertain the nature of your child's difficulties.

2. Who is responsible for the progress and success of my child in Academy?

The overall responsibility for your child's success lies with the Head Teacher, senior leadership team and Local Advisory Board (governing body), supported by class teachers, the SENCO, teaching assistants, yourselves and your child.

3. What should I do if I think my child may have special educational needs?

In the first instance, please discuss your concerns with the class teacher. The class teacher will then advise the SENCO who will discuss this with both you and the teacher. Your child will also be involved in these discussions, as appropriate. You and the school will decide on the best course of action which will involve assessing your child's needs, planning the next steps which may involve an appropriate intervention and/or referral to an external agency. Any goals set will be regularly reviewed.

4. How will I know how my child is doing and how will you help me to support my child's learning?

The Academy works in partnership with all parents and carers. Parents and carers are invited to attend progress review meetings. Two reports are sent home each year. If your child has been identified and assessed as requiring SEN Support or has a Statement or Education, Health Care Plan, you will be invited to review your child's progress three times throughout the year. SEN Support plans are devised in conjunction with the pupil and their parents or carers.

5. What support will there be for my child's overall wellbeing?

Our Academy has a family centred approach which promotes the emotional wellbeing of all of our pupils. If your child is experiencing a particular difficulty with any aspect of their social and emotional well-being, the class teacher, SENCO and you will decide on a plan to support them which may involve a range of intervention programmes.

6. How do I know that my child is safe in Academy?

Risk assessments and safety policies are in place to ensure all children are safe within the Academy.

7. What SEND training have the staff at Academy had or are having?

Our SENCO has completed the National Award for SENCOs. A member of the SEN team is an 'autism champion'. All Academy staff can consult with the speech and language therapist when she is visiting for additional support on communication difficulties. All classroom staff have received forms of training, where the need has been identified, in a variety of areas such as safeguarding, speech, language and communication difficulties, autism awareness, language for learning, visual and hearing support awareness.

8. How will my child be included in activities outside the classroom including Academy trips?

Provision is made for all children to take part in all learning activities.

9. How are the Academy's resources allocated and matched to children's special educational needs?

Appropriate resources, whether equipment or additional staffing, are available in all classrooms to help all children.

10. How is the decision made about what type and how much support my child will receive?

Additional and different provision for your child will be assessed and reviewed on a need basis. The Academy follows the graduated response outlined in the SEN Code of Practice (2014) where the 'Assess, Plan, Do, Review' cycle is employed to ascertain the type of provision required, its duration and outcomes are carefully measured. Your child may have specific and high level needs, which means they will only achieve good outcomes academically, socially and emotionally with continuous support and specialised, differentiated provision. In this case, the decision may be taken in consultation with you and external professionals, to apply for an Education, Health Care Plan (previously known as a Statement of Special Educational Need).

11. Who can I contact for further information?

12. What should I do if I feel that my child's needs are not being met?

If you disagree with the Academy's provision for your child with SEND the following procedure should be followed: please discuss your concerns with your child's class teacher. If your disagreement is not resolved at this point, you will be referred to the SENCO and the Principal. If, after having talked, the parent and school are still in disagreement then the parent will be referred to seek advice from SENDiASS (formerly the Parent Partnership) and asked to access the Informal Disagreement Resolution Service provided through Children, Schools & Families, and refer to the Academy Complaints Policy. The same procedure applies for looked after children and the designated teacher for looked after children will also be involved to support and liaise with the child's carers.
