THE SEATON VALLEY SCHOOL SPORT PARTNERSHIP AGREES TO PROVIDE THE FOLLOWING ANNUALLY:

- A Partnership Manager who will lead and co-ordinate the running of the Partnership.
- Management of the PE and sports premium provision.
- Financial management of the school's PE and sports premium funding.
- Selection and management of external providers and sports coaches, to meet the individual needs of the school; ensuring that necessary skills, qualifications, DBS clearance and child protection policies are in place.
- Advice on safe practice in PE and school sport.
- Support to schools in applying for external funding.
- Quality assurance of the PE and sports premium provision, through observation of a sample of sessions and seeking regular feedback from schools
- Termly reports meeting DfE / Ofsted requirements.
- The services of specialist sports coaches to help deliver or support the delivery of physical education (for lessons / blocks of lessons agreed at least a half term in advance).
- Age appropriate leadership and volunteering training and opportunities for pupils.
- Extra-curricular clubs led by qualified PE teachers / sports coaches (agreed at least a half term in advance).
- Testing to identify the most able pupils within PE, followed by a 5 session multi skills academy to develop fundamental skills.
- A pre-agreed bespoke programme of opportunities for physical activity which promote health and well-being.
- An offer of at least one Partnership festival per term in addition to the School Games offer.
- Transport to Partnership competitions, festivals and other events up to £100.
- Development of links between sports clubs, other organisations and schools.

THE MEMBER SCHOOL AGREES THE FOLLOWING:

- Payment of £5760 to the Seaton Valley Sports Partnership which will be requested in two instalments of £3360 in October 2016 (to cover Sept 2016-Mar 2017) and of £2400 in May 2017 (to cover April-August 2017), transferred by journal via Northumberland County Council.
- To have a named member of staff as the main contact for PE and sports premium provision.
- Monitoring and evaluation of PE and sports premium activities to demonstrate impact.
- Termly review / planning meetings with the Sports Partnership Manager.
