In-school barriers (issues to be addressed in school, such as poor oral language skills)

- **A.** Low attainment of EYFS PP cohort. These children will enter year 1 lower than their peers and will need support to make accelerated progress.
- **B.** PP reading progress for year 2 2015-2016 was lower than their NOT PP peers.
- **C.** Learning can be affected by some emotional well-being issues for a minority of children with PP.

#### **External barriers** (issues which also require action outside school, such as low attendance rates)

**D.** There is a small number of PP children across all year groups with poor attendance. Although PP attendance is 95.3% overall for 2015-2016. NOT PP 96.6%
