This fundraising event is really simple and can be done in your own home or garden. Each child chooses a physical activity to do for 5 minutes, it can be bouncing / jumping / hopping (or anything that works for you and your child) and they are sponsored for their efforts. You can either sponsor them per bounce / skip or give a total amount no matter how many they do – see the sponsorship form on the next page.
