Introduction

At Christ Church CE Primary School, we are committed to providing a fully accessible environment which values and includes all pupils, staff, parents/carers and visitors regardless of their academic, physical, sensory, social, spiritual, emotional and cultural needs. We are committed to developing a culture of awareness, tolerance and inclusion and to challenge negative attitudes about disability.

As a school we recognise our duties under the Equality Act 2010 and the SEN and Disability Act 2001 include:

- not treating disabled pupils less favourably for a reason related to their disability;
- making reasonable adjustments for disabled people, so that they are not at a substantial disadvantage;
- planning to make reasonable adjustments to the school buildings where necessary to meet the needs of disabled pupils;
- increasing the extent to which disabled pupils can participate in the school curriculum;
- reviewing and improving the school environment to increase the extent to which disabled pupils can take advantage of education and associated services.

Vision and Values

We believe that every person should reach for their potential or "Reach for the Stars" within a supportive, Christian environment with love at the centre. We teach our Christian values implicitly and explicitly across the curriculum. We instil in our children caring, sharing, respect, an understanding of difference and the need to persevere and maintain friendships. It is our desire therefore to ensure that all people within our school and community are given equality of opportunity and enabled to access what the

school has to offer. We strive to ensure that we make reasonable efforts to include and actively seek out and remove any barriers to inclusion that there might be. Our policies for Equal Opportunities, SEND, Behaviour and Inclusion reflect these beliefs.

Accessibility Plan

At Christ Church CE Primary School, there is an ongoing programme of review and evaluation of accessibility issues in order to increase accessibility for all pupils, staff and visitors to the school. The accessibility plan contains relevant action to:

- review and where appropriate improve access to the physical environment of the school, including specialist facilities if considered necessary;
- increase access to the curriculum for all pupils with a disability, developing the curriculum where necessary, to ensure that pupils with a disability are equally prepared for life as able bodied pupils are;
- improve the delivery of information to pupils, staff, parents/carers and visitors with disabilities.

Below is an action plan relating to the key aspects of accessibility. This plan will be reviewed, evaluated and adjusted on an annual basis by the SLT and the governing body. New plans will be developed every three years. We acknowledge that there is a need for ongoing disability awareness training for staff and governors. This plan should be read in conjunction with the Special Educational Needs Policy, the Christ Church CE Primary School SEN Local Offer and the Anti-Bullying Policy.

Adaptations within the current school building include:

- disabled toilets on the ground floor of the building;
- lift allowing wheelchair access to both floors of the building;
- ramps at both main entrances;
- wheelchair access via a ramp to all areas of the Early Years yard;
- automatic main and inner doors;
- wide corridors and doors allowing ease of access throughout the building;
- handrails fitted to all stairs to support those with mobility issues;
- electronic whiteboards in all teaching rooms to support those with visual impairments;
- evac-chair to carry people downstairs in case of fire;
- employment of support staff with medical training to coordinate medical care and first aid support.
