## ST ANNE'S CATHOLIC SCHOOL AND SIXTH FORM COLLEGE ADMISSIONS POLICY 2020-2021

### PREAMBLE:

St Anne's is an 11-18 Catholic School and Sixth Form College and became a converter Academy in 2012. The Academy is in the trusteeship of La Sainte Union Religious Congregation and is situated in the Catholic Diocese of Portsmouth.

St Anne's draws applications from a wide geographical area covering the New Forest, Southampton, Eastleigh, Winchester, Fareham, the Isle of Wight and beyond.

St Anne's is a Catholic school committed to teaching the Christian faith and to providing an excellent education for all the girls in our care, founded on the Gospel values of Jesus Christ. By seeking a place for their daughter at St Anne's, parents commit to supporting the Catholic ethos of the school and confirm that they wish their daughter to have a Christian education celebrating Gospel values.

We do not expect everyone to be a practising Christian but we do expect the Catholic ethos of the school to be respected and supported. By applying to St Anne's, practising Christians and other girls receiving a Christian education at primary school can continue their Christian education in an 11 to 18 environment; an education within which girls of other faiths and of no faith are fully included. We are an inclusive school united by our shared values and not divided by our differences. Our expectation is that all girls will take a full and active part in the spiritual life of the school; this includes but is not limited to, reflection days, Mass and worship in assemblies.

The Governing Body is responsible for admissions and they have determined the policy. All parents have the right to apply and be considered for a place for their daughter at St Anne's school. Please note, although St Anne's is a girls' school, gender alone does not guarantee a place at the school and a preference for a single-sex education (regardless of reason) will not be considered when applications are ranked.

The published admission number (PAN) for 2020-2021 in Year 7 is 200.

## ADMISSIONS POLICY 2020-2021

The Governing Body of St Anne's will admit 200 girls to Year 7 in 2020-2021

The Governors consider all applications received by the deadline simultaneously according to the criteria below. All applicants need to complete the Supplementary Information Form (SIF) except if they are applying under criterion 12. **We expect all SIF to be submitted by 31<sup>st</sup> October 2019 at the latest. If a completed SIF is not submitted when requested, governors can only consider the application on the information in the CAF.** For all of the following criteria please see below for full definitions and evidence required.

**Musical aptitude tests will take place in July 2019 (when your daughter is in Year 5). If you wish for your daughter to sit the musical aptitude test you must complete an application and return a SIF by Friday 21<sup>st</sup> June 2019. Applications for this category will not be received after this date.**

6	Girls who have a sibling already on roll at the time of application.
7	Girls who attend a named Catholic primary school at the time of application.
8	Girls of staff at St Anne's.
9	Unbaptised girls with at least one parent who is a Baptised Catholic (Heritage Catholics).
10	Girls who attend a named primary school with a strong Christian foundation at time of application.
11	Girls of other Faith traditions.
12	Girls who do not fall in to any of the above categories.

### OVERSUBSCRIPTION:

Applications within each criterion will be given priority in the following order:

- Girls with siblings attending the school at the time of application (see "sibling" under definitions).
- Girls attending named Catholic primary schools or named schools with a strong Christian foundation (see below for a list of schools).
- Girls living nearest the school. (See "distance" under definitions).
- The distance category will also be used to further distinguish between applicants within the same category.

In the instance where the distance is the same for both applicants and only one place is available the tiebreaker will be an independent random allocation supervised by the LA.

## NOTES AND DEFINITIONS:

### *LOOKED AFTER CHILD (LAC) AND PREVIOUSLY LOOKED AFTER CHILD:*

'A looked after child' has the same meaning as in Section 22(1) of the Children Act 1989 and means any child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services function (e.g. child with foster parents) at the time of making an application to a school.

'Previously looked after children' are children who were looked after, but ceased to be so because they were adopted. This includes children who were adopted under the Adoption Act 1976 (see section 12 adoption orders) and children who were adopted under the Adoption and Children Act 2002 (see section 46 adoption orders) or became subject to a child arrangements order 18 or special guardianship order 19).

Child arrangements orders are defined in s.8 of the Children Act 1989, as amended by s.12 of the Children and Families Act 2014. Child arrangements orders replace residence orders and any residence order in force prior to 22 April 2014 is deemed to be a child arrangements order. Section 14A of the Children Act 1989 defines a 'special guardianship order' as an order appointing one or more individuals to be a child's special guardian (or special guardians).

*CATHOLIC:* For the purposes of these admissions arrangements, Catholic means a baptised member of a church in communion with the See of Rome or a person received into the Catholic Church evidenced by a certificate of baptism/evidence of reception into the Catholic Church, or statement from the parish in which the reception took place.

*AN APTITUDE FOR MUSIC:* The aptitude test is based entirely on responses to aural tests and does not require any knowledge of music theory or previous musical knowledge. The test consists of four main types of questions namely pitch, melody, texture and rhythm. If the candidate misses the test, a medical certificate will be required for any requests for a late test. Please see attached sheet for further details and **please note the earlier date for submission of SIF and application.**

*MEMBERS OF ANOTHER CHRISTIAN DENOMINATION:* Children who belong to other churches and ecclesial communities which, acknowledging God's revelation in Christ, confess the Lord Jesus Christ as God and Saviour according to the Scriptures, and, in obedience to God's will and in the power of the Holy Spirit commit themselves: to seek a deepening of their communion with Christ and with one another in the Church, which is his body; and to fulfil their mission to proclaim the Gospel by common witness and service in the world to the glory of the one God, Father, Son and Holy Spirit. An ecclesial community which on principle has no creedal statements in its tradition, is included if it manifests faith in Christ as witnessed to in the Scriptures and is committed to working in the spirit of the above.

The above description includes, but is not limited to churches that are members of Churches Together in England (website [www.cte.org.uk](http://www.cte.org.uk)), CYTUN, Evangelical Alliance or Vineyard Churches UK and Ireland. Girls need either;

- i) a letter confirming membership of their Christian denomination signed and dated by the appropriate minister: the letter must be on headed paper and should include a signed declaration that the child is a member of a community which agrees with the statement which defines a member of another Christian Denomination as shown above **or**
- ii) a certificate of baptism/christening certificate from the church-this should be returned to the school at the same time as the SIF.

*SIBLING:* Sibling refers to sister/brother, half-sister/half-brother, adopted sister/adopted brother, step sister/step brother, foster sister or foster brother or the child of the parent's/carer's partner where the child for whom the school place is sought is living in the same family unit at the same address as that sibling. A girl is considered to have a sibling connection, for the purposes of the School's Admission

Criteria, if their sibling is on roll at St Anne's School/Sixth Form at the date of application. To be clear, siblings are not cousins, aunts or other close family members. Only the definition in this policy is relevant for admission to the school.

*NAMED CATHOLIC PRIMARY SCHOOLS:* These schools are our Catholic Cluster Primary Schools and two schools within travelling distance to St Anne's:

Specifically and exclusively; Holy Family Catholic Primary School Southampton, Springhill Catholic Primary School Southampton, St Anthony's Catholic Primary School Fareham, St Jude's Catholic Primary School Fareham, St Patrick's Catholic Primary School Southampton, St Peter's Catholic Primary School Winchester, St Swithun Wells Catholic Primary School Chandlers Ford, Our Lady and St Joseph Catholic Primary School Lymington.

*GIRLS (CHILDREN) OF STAFF AT ST ANNE'S:* The criteria for the category of girls of staff at St Anne's is as follows:

- i) The member of staff has been employed at the school for two or more years at the time at which the application to the school is made, **or**
- ii) Has been recruited to fill a vacant post for which there is a demonstrable skill shortage.

*NAMED PRIMARY SCHOOLS WITH A STRONG CHRISTIAN FOUNDATION:* These are schools with whom we have a relationship of outreach and transition and who share our Christian ethos.

Specifically and exclusively: Brockenhurst Church of England Primary School; Freemantle Church of England Community Academy; Highfield Church of England Primary School; Durley Church of England (Controlled) Primary School; Nursling Church of England Primary School; Rownhams St John's Church of England Primary School.

Schools that are Church/Christian schools and are NOT named on our policy are NOT schools which would mean that a child is placed under category 7 or 10.

*GIRLS OF OTHER FAITH TRADITIONS:* Girls need a letter confirming their membership of their Faith community signed and dated by the appropriate **religious leader**. The letter must be on headed paper and should be returned to the school at the same time as the SIF.

*DISTANCE:* Distances will be measured by the shortest walking route from the front door of the girl's house or block of flats to the main school door at St Anne's using the Local Authority's computerised measuring system with those living closer to the school receiving the higher priority. Should parental responsibility be equally shared, the home address will be considered to be the one at which the child is registered with a GP or alternatively where the child stays the majority of the school week.

*ADMISSION OF TWINS, TRIPLETS, OTHER CHILDREN OF MULTIPLE BIRTHS and SAME ACADEMIC YEAR SIBLINGS:* Where fewer places within a category can be offered than there are, the Governing Body has the discretion to treat this as an exceptional case and may admit girls from multiple births or same academic year siblings living at a single address, in order not to split the family.

*GIRLS WITH AN EDUCATION, HEALTH AND CARE PLAN (EHCP):* Girls who have an Education, Health and Care Plan which names St Anne's Catholic School, Southampton in Part 4 of the Statement, will be awarded a place after consultation with the Governing Body, the Headteacher and SENCO regarding whether the school is able to meet the EHC plan for the child concerned. They will count towards the Published Admission Number.

*WAITING LIST:* After the initial allocation of all available places, the Governing Body will maintain a waiting list of applicants. The waiting list is open until the 31st December 2020. Applicants will be placed on this list in the same order of priority as specified in the criteria enumerated above and places will be offered in that sequence as and when they become available. Each added child will require the

list to be ranked again in line with the published oversubscription criteria. Should a vacancy occur it will be offered in strict order of priority, and will be held open for a maximum period of ten days from the date of offer.

Pupils who are LAC, previously LAC, those with an EHCP\* (see definition above) and those allocated a place at the school through the Fair Access Protocol, take precedence over those on the waiting list.

*IN YEAR FAIR ACCESS PROTOCOL:* St Anne's School participates in the agreed Local Authority Fair Access Protocol for all admissions outside of the usual admissions process.

## *PROCESS FOR MAKING AN APPLICATION:*

Parents will need to apply for a secondary school place via the Admissions online application system relevant to their Local Authority. Parents will receive instructions on how to apply directly from their Local Authority.

Parents are strongly encouraged to use the online application system. We recommend that all parents complete an on-time application. **We would like to remind parents of the different deadline for applications for musical aptitude.**

In addition to the online application, **if parents/carers are applying for a priority place, they need to complete a separate supplementary information form (SIF) to provide additional information. The additional information on this form assists governors in placing applications in the correct oversubscription category. If no supplementary information form is submitted, governors can only rank the application on the basis of the information contained in the on line application. The supplementary information form is also available on line and should be returned to St Anne's Catholic School. Failure to complete this form on time and submit the required supporting evidence may result in your daughter being placed in the wrong category.**

Parents will be notified by the LA of an offer of a place  
on behalf of the Governing Body in March 2020.

### *LATE APPLICATIONS*

Late applications will be dealt with in accordance with the Local Authority's Coordinated Admissions Scheme.

### *RIGHT OF APPEAL*

In accordance with Section 94 of the School Standards and Framework Act 1998, parents whose child is refused a place have a right of appeal. Appeal forms can be obtained from the Clerk to the Governors at St Anne's and the school website (see "admissions"). Forms must be returned to the Clerk to the Governors at St Anne's via reception or post. Appeal forms should be placed in an envelope and should be clearly labelled "Admissions Appeal." Forms cannot be submitted electronically.

## APPLICATIONS OUT OF THE MAIN ADMISSIONS ROUND

Applications out of the main admissions round will be processed by the Governors of St Anne's Catholic School as its own Admissions Authority. Parents should in the first instance contact the Admissions Officer at the school. Documentation will be sent to the parent including the SIF to allow us to place on the waiting list should this be required. The Governors will consider such admissions using the criteria set out above. If a completed SIF is not submitted, pupils will be automatically placed in category 12. Documents will also be available on the school website.

Proof of address will be required for all direct applications made to the school and not via the Local Authority. Girls transferring from another school in the city must submit a completed In-Year Transfer form stamped by their current school. Direct applications made to the school will not be processed without the above information.

There is no musical aptitude criteria for applications out of the main admissions round.

*WAITING LIST:* When a year group is full, applications outside of the main admission round, will be placed on a waiting list. The waiting list is open until the 27<sup>th</sup> July 2021. Applicants will be placed on this list in the same order of priority as specified in the criteria enumerated above and places will be offered in that sequence as and when they become available. Each added child will require the list to be ranked again in line with the published oversubscription criteria. Should a vacancy occur it will be offered in strict order of priority, and will be held open for a maximum period of ten days from the date of offer.

Pupils who are LAC, previously LAC, those with an EHCP\*(see definition above) and those allocated a place at the school through the Fair Access Protocol, take precedence over those on the waiting list.

## ADMISSION OUTSIDE THE NORMAL AGE GROUP

Parents may seek a place for their child outside of the normal age group, for example, if the child is gifted and talented or has experienced problems such as ill health. Children should only be educated out of the normal age group in very limited circumstances.

If parents wish to seek a place for their child outside of the normal age group, they should submit a request in writing to the school as early as possible. The school will make a decision based on the circumstances of each case and in the best interests of the child concerned. This will include taking account of the parent's views, information about the child's academic, social and emotional development, where relevant, the child's medical history and the view of a medical professional; whether they have been previously been educated out of their normal age group; and whether they may naturally have fallen into a lower age group if it were not for being born prematurely. The views of the Headteacher of the school will also be taken into account.

## SIXTH FORM

There is a separate policy for entrance to the Sixth Form.
