Eligibility Guidance

Evidence of current entitlement to receive a relevant benefit will be checked on a secure government website. Therefore, you may not need to supply evidence with your application.

The criteria below may be amended following the government's changes to the benefit system later in the year.

You **do not** need to supply paper evidence with your application if you receive any of the following. Your child is likely to be eligible for Free School Meals if you receive:

- Income Support for Income-based Jobseekers Allowance of Income-related Employment and Support
- Evidence of support under Part VI of the Immigration & Asylum Act 1999 from the National Asylum Support Service (NASS) or Social Services Asylum Team.
- Child Tax Credit provided you are not entitled to Working Tax Credit, and have an annual income of £16,190 or less.

If you receive either/both of the following you **will** need to provide paper evidence with this form to support your claim:

- The Guarantee element of State Pension Credit.
- Working Tax Credit "Run-on" – the payment someone may receive for a further four weeks after they stop qualifying for Working Tax Credit.

Please note this is the only circumstance which will entitle you to claim for free school meals if you receive Working Tax Credit.

If you receive Contribution based Jobseekers Allowance or Contribution Based Employment and Support Allowance your child is not eligible for Free School Meals.

Important information

Once we have your details we will perform regular checks on your eligibility, please make sure that if any of your details change you let us know.

Any incorrect information we have about you could affect the result of our regular checks and could cause us to think that you are no longer eligible for Free School Meals.

Please contact us as soon as possible if you have any changes in circumstances.
