Including day and residential trips?</b></p> <p>All lessons are inclusive with adjustments made where necessary depending on need. All children with SEND are supported by staff and given appropriate/differentiated work. Visual time-tables and reminders and rewards systems are available. Children with SEND are included on all school trips and residential where 1:1 support is provided, if necessary.</p> <p><b>What proportion of children at the school have SEND?</b> 14.3% total</p> <p>14.3% - 5 children SEN support</p>

	<ul style="list-style-type: none"> <li>● Pupil Profiles, inclusion and intervention sheets are discussed with parents.</li> <li>● Parents meet people from outside agencies both at home and in school.</li> <li>● Parents are asked for and provide views and information.</li> <li>● Parents are involved in the implementation of the profile plan.</li> <li>● COSA forms are completed with staff and parents and, where appropriate, children.</li> <li>● Where needed, behaviour diaries are shared with parents.</li> </ul>
