

Pupil premium grant expenditure- website information

An overview of the Pupil Premium

The Pupil Premium is designed to ensure that funding to tackle disadvantage reaches the pupils who need it most. The funding is allocated to Local Authorities and schools from Reception to Year 11 who have been eligible for free school meals (FSM) at any point in the last 6 years, are looked after or who have parents who are currently in the armed forces. The funding allocation was £1320 per pupil in receipt of FSM at any point in the last 6 years; £300 per pupil for those in armed forces families; £1900 per pupil who is post-looked after/adopted.

Intervention

Outcomes to date including the effect of expenditure on the educational attainment of those pupils eligible for the PPG:

<u>Attainment and Progress</u>: Across the school, the attainment and progress of the children eligible for the PPG is the same, or better, than the rest of the children in their year.

Attendance: Their attendance across the school was 95.7% compared to whole school attendance of 96.4%.
