PE & SPORT PREMIUM PAGE CONTENT

The government has confirmed that the primary PE & Sport Premium will continue at £320 million for the 2020/21 academic year.

This funding is ring fenced and allocated directly to primary schools across England, providing them with a dedicated resource to buy in invaluable expertise and support. Funding is allocated through a lump sum for each school and a per-pupil top-up mechanism. The formula references the number of primary-aged pupils (i.e. children between the ages of 5 and 11).

We want our children to be resilient, empathetic, ambitious and independent. These life skills can be learned through the delivery of quality PE and daily physical activity.


The impact on PE, school sport and physical activity is measured against the 5 indicators:

Primary PE and Sport Premium - Key Indicators

Schools must use the funding to make additional and sustainable improvements to the quality of PE and sport they offer. There are 5 key indicators that schools should expect to see improvement across:

- 1.** The engagement of all pupils in regular physical activity - the Chief Medical Officer guidelines recommend that all children and young people aged 5 to 18 engage in at least 60 minutes of physical activity a day, of which 30 minutes should be in school
- 2.** The profile of PE and sport is raised across the school as a tool for whole-school improvement
- 3.** Increased confidence, knowledge and skills of all staff in teaching PE and sport
- 4.** Broader experience of a range of sports and activities offered to all pupils
- 5.** Increased participation in competitive sport

- spending overview is editable, and the spending breakdown should have intended impact for start of year converted to actual impact by 31st July.
- Reminder of what we are legally obliged to publish:
 - The amount of premium received
 - A full breakdown of how it has been spent (or will be spent)
 - What impact the school has seen on pupils' PE and sport participation and attainment
 - How the improvements will be sustainable in the future
 - What percentage of pupils within their year 6 cohort for academic year 2019 to 2020 can do each of the following:
 - Swim competently, confidently and proficiently over a distance of at least 25 metres
 - Use a range of strokes effectively
 - Perform safe self-rescue in different water-based situations
- Statement to be uploaded for start of academic year as a work in progress document – detailing what you have spent against the criteria and what the intended impact will be, replaced with actual impact by deadline of July 31st
- Report also includes sustainability to outline what would happen if the money stops
- The government has stated that any underspend from last year can be used to support children's wellbeing on a return to school. This year's spend can be used to support well-being post COVID-19 by linking to indicators 1 & 4.
