Remote learning plan - Cusgarne School

We would like to share with you our current intentions should your child need to be learning at home due to awaiting a test, self-isolating, participating in a bubble lockdown or if we should enter another 'lockdown' with total school closure. Hopefully such an event will not occur, but we are preparing for such eventualities.

From Monday 5th October we will implement remote learning from your child's first day of absence if it is Covid-19 related. **EYFS content will be delivered through Tapestry E-Classroom. KS1 and KS2 content will be delivered through Google Classroom E-Classroom.** Please ensure that you have a login for the above so you can access learning for your child/ren immediately. Pupils are learning in school how to use Google classroom effectively and how to respond online. Work needs to be shared on Google Classroom and not returned in paper form.

Our staff in Robin (Year 1 only) Puffin, Starling and Kingfisher class will share Maths and English tasks on Google Classroom each day so that if your child cannot be in school you will know what is being covered in the classroom and will be able to support them at home to keep in step with the learning. For the EYFS children Tapestry is being used to support home learning for the children. Could we please emphasise that if a child is self-isolating the teacher will not be contactable during the school day as they will be teaching.

If either the KS1 or KS2 bubble is subject to a closure (possibly fourteen days) the staff will be asked to continue setting the daily English and Maths for their class. They will also share on the Google Classroom other activities relevant to the topic. They will signpost key specific online resources such as White Rose, Twinkl, BBC and Bitesize to support the learning.

During a total school closure a member of staff will regularly timetable a phone call to each family, to support the learning. This will be communicated to you

through an Arbor message. Google classroom and Tapestry will also be used to feedback on work, when submitted. Pupils can ask their teacher questions about their learning using Google Classroom. The teacher will have the discretion to send home paper resources and workbooks if they feel it is appropriate for the learning, in which case they will be quarantined for 48 hours beforehand.
