In-School Barriers:	
1. Progress at KS2 in writing and maths has been poor in recent years, particularly for children from disadvantaged backgrounds.	
2. The number of children from disadvantaged backgrounds working at greater depth in Reading, Writing and Maths at EYFS, KS1 and KS2 is significantly lower than other children nationally.	
3. Social and emotional barriers have led to children having fixed mind-sets, low levels of confidence and motivation.
