Government guidance for schools states:

“The safety of children and staff is our utmost priority.”

“The advice seeks to support staff working in schools, colleges and childcare settings, to deliver this approach in the safest way possible, focussing on measures they can put in place to help limit the risk of the virus spreading within education and childcare settings.”

“In education, childcare and social care settings, preventing the spread of the coronavirus involves dealing with direct transmissions (for instance, when in close contact with those sneezing and coughing) and indirect transmission (via touching contaminated surfaces.) A range of approaches and actions should be employed to do this.”

Government guidance for parents concerning re-opening of schools states:

“We have provided guidance and support to schools, colleges and child care settings on implementing protective measures in education and childcare settings to help them **reduce the risk of transmission as more children and young people return.**”

“Whilst such changes are likely to look different in each setting, as they will depend upon individual circumstances, they are all designed to minimise risks to children, staff and their families.

Schools and colleges continue to be best placed to make decisions about how to support and educate their pupils during this period. This will include:

Consideration of the pupils’ mental health and wellbeing.

Early years and primary age children cannot be expected to remain 2 metres apart from each other and staff. In deciding to bring more children back to early years settings and schools, we are taking this into account. Schools should therefore work through the hierarchy of measures set above:

- Avoiding contact with anyone with symptoms
- Frequent hand cleaning and good respiratory hygiene practices
- Regular cleaning of settings
- Minimising contact and mixing

Where settings can keep children and young people in those small groups 2 metres away from each other, they should do so. While in general groups should be kept apart, brief transitory contact, such as passing in a corridor is low risk.

Social distancing charter created for and with the children – including how many children using resources and how, (include instructions how to line up, physical contact, use of toilet, moving around the classroom etc)</li> <li>4. Charter re-visited and modelled many times a day and linked to school behaviour system – lots of praise for adherence and sanctions for non-compliance.</li> <li>5. Resources and activities planned to reduce shared contact and individual learning.</li> <li>6. Staff allowed to stay at adult height – no requirement for getting to child level for interactions</li> <li>7. Interactions carried out where possible from a distance.</li> <li>8. <span style="color: red;">Teacher and TA are assigned to these children and stay with these children throughout the day and week.</span></li> <li>9. <span style="color: red;">Children stay in the classroom/ designated outdoor area for the majority of the day and do not mix with other groups.</span></li> </ol>

Games discussed which encourage social distancing – football passing, catch, hoola hooping.</li> <li>4. Staff supervision throughout – actively encouraging and insisting on social distancing.</li> <li>5. Break time supervised by bubble staff.</li> <li>6. Allocated dinner supervisor for each bubble.</li> <li>7. Castle, tyres, trim trails, stage and willow dens not to be used to prevent cross contamination between bubbles.</li> </ol>

Soft toys and furnishes including bean bags removed from the classroom before opening.</li> <li>6. Nothing to be brought in from homes.</li> </ol>

Staff meeting – virtually – to discuss concerns and shared control measures</li> <li>3. HT contactable every day for staff to share concerns with</li> <li>4. Risk assessments reviewed after day one then weekly.</li> <li>5. Designated ‘staff areas’ areas for different groups of staff – set up staff rooms in meeting room/ PPA room so each ‘bubble’ have their own break/lunch area.</li> <li>6. Planned time for planning and preparation and Class Dojo within the week within their ‘bubbles’</li> <li>7. PPE masks / face coverings / visors offered to staff working with children if requested.</li> </ol>

<ol style="list-style-type: none"> <li>1. Hand gel outside of all classrooms.</li> <li>2. Hand gel order in large quantities.</li> <li>3. Handwashing PHSE lessons, songs and rhymes.</li> <li>4. Extra soap and re-fills in each classroom.</li> <li>5. Children hand wash or hand gel on entry to school, before break, after break, before lunch, after lunch, leaving school, using the toilet and any time they cough or sneeze.</li> <li>6. Washing hands posters replaced in all washing areas.</li> <li>7. Reminders how to wash hands properly – videos and posters</li> <li>8. Lidded bins in all classrooms and toilets which will be emptied each lunchtime and after school.</li> <li>9. Where possible, doors and windows to be kept open to help ventilation.</li> </ol>

Soft furnishings and soft / cloth toys will be removed from use in classrooms</li> <li>3. Resources on each day list given to cleaners to ensure these resources are cleaned at the end of the day.</li> <li>4. Enhanced cleaning schedule in place.</li> <li>5. Extra cleaning products bought.</li> <li>6. Each class to have their own cleaning equipment for regular cleaning throughout the day.</li> </ol>

Issuing of all relevant risk assessments to staff concerning re-turning to work – and allow them to comment and contribute.</li> <li>5. Separate risk assessment for staff who are clinically vulnerable.</li> </ol>
