### **NURSERY PARENTS ONLY:**

Dear Parents/Carers of **NURSERY** pupils

Following the next Government update which is due within the next two weeks regarding lock down, we may need to review our childcare provision. We are looking at planning ahead to get an idea of how many families have **one key worker**. The next phase of our reopening to homes will be extending NURSERY provision to homes who have **one keyworker** if it is possible and safe to do this under current guidelines.

In order to know if we can do this, we need to gain an understanding of the number of homes that require this provision.

Please follow the link below to our online form which asks if you will **require childcare provision** for the week commencing **4th May** for **families with at least one key worker** who is critical to the Coronavirus response for NURSERY aged pupils. Thank you.

**ALL HOMES:** We intend to update homes and families over the next few weeks about provision extending out more widely, but only if it is safe and appropriate to do this. We are waiting for Government guidance on this. However, it is predicted that the **second phase** to this will be extending out to the wider group of key workers that will begin to return to work. At present this looks likely to be construction workers and possibly further commercial outlet workers. When this is announced and made clear by the Government the school's intention will be as follows:

1. We provide our childcare provision for pupils in Reception/1/2/3/4/5/6 to families that have **two key workers in their home** (as this may increase numbers with the extension of 'new' keyworkers returning to work. A Microsoft form will be available for those families that then find themselves **now** in this

category and requiring provision from school. This will be made available at some point week beginning May 11<sup>th</sup>, once lockdown reviews have been announced.

2. The provision will then be organised and available to those families from May 18<sup>th</sup>.

This is obviously subject to change depending on Government announcements and guidance.
