## Terms and Conditions

Revised June 2021

1. Bookings will be available to view and pay on the 'Schoolmoney' system at the beginning of every half term and all payments must be made in FULL the Friday before the last week of the half term. The payment date will be sent out by text message at the beginning of the new half term and subsequent reminders throughout the half term. (Payment via cash, and childcare vouchers are also accepted). If payment is not received by the specified date, the booking will be cancelled and the space will be offered to the waiting list.
2. Children will be provided with a drink and healthy snack, unless otherwise requested. He/she will also have access to drinking water as and when required.
3. Please note Woodpeckers' opens from 7.30am, we cannot allow entry before this time. Early arrival for the 8.00am session will be charged at the earlier 7.30am session.
4. I consent to my child attending Woodpeckers Before & After School Club and understand that Woodside C of E Primary School manage this club in accordance with policies in place within the school.
5. I understand that Woodpeckers Before & After School Club is a wrap-around care service and that Woodside C of E Primary School will be responsible for my child whilst in attendance. If my child attends an afterschool club or activity, the staff of that club will have responsibility for my child during his/her attendance at it until Woodpeckers Before & After School Club staff collect him/her.
6. I understand that there is **NO** reimbursement for any sessions missed, unless 24hrs notice is given by text, telephone or email. I agree to notify the Manager by telephone if my child will not be attending a session that day which has been previously booked.
7. Prompt collection is required at the end of the booked session, I understand that I will be charged for the next session if I am late collecting and understand the last session ends promptly at 5.30pm, late fees will apply at the rate of £1 per minute after 5.30pm.
8. If I do not collect my child by 5.30pm and staff have been unable to reach me or any other emergency contact, I understand that the staff will follow the school's procedure for uncollected children held within the Safeguarding policy. (available to download from the school website)
9. I have read the school's Behaviour Policy and understand that the staff working within Woodpeckers Before & After School Club will adopt the main principles held within it. Children are expected to show good behaviour and respect to staff and other children. I understand that if staff have any concerns regarding my child's behaviour they will notify me the same day.
10. In line with school policy, Woodpeckers Before & After Club cannot accept responsibility for valuables.
11. I understand that I will need to give one weeks' notice should I wish to cancel permanent weekly sessions booked.
