

School

The school will do its best to:

- Provide an environment which has been risk assessed in response to the COVID-19 infection;
- Adhere to the social distancing rules as set out by the government as much as we reasonably can;
- Provide a curriculum that meets the needs of your child's well-being, mental health and academic needs;
- Contact parents/carers if your child displays symptoms of COVID-19;
- Inform you if staff or children in your child's 'bubble' show symptoms of COVID-19 as this will mean you will all need to self-isolate for at least 14 days if the test comes back positive;
- Continue our clear and consistent approach to rewards and sanctions for children as set out in the Behaviour Policy and its additional appendix as well the expectations outlined in this agreement;
- Communicate between home and school through notices, newsletters, text, email and the school website.

Parent/Carers

The parents/carers will do their best to:

- If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school, we will self-isolate for 14 days as a family, I will get them tested and I will let the school know as soon as possible via telephone;
- If my child, or another child in the group, shows symptoms of COVID-19 at school, I will collect my child from school when contacted and asked to do so;
- When dropping my child off and picking them up, I will adhere to the 2 metre social distancing rules.
- When dropping off and picking up, I will strictly stick to the school timings for my child;
- I will ensure only one person will drop off/ pick up my child at/from school
- Ensure I follow the guidance displayed on the signs outside the school building;
- My child must not bring any additional items into school with them or take items home from school;
- I will remind my child about social distancing rules but accept they are difficult to follow and that my child may not always do this successfully
- My child will be taught and need to use good respiratory and hand hygiene;
- Send my child to school in freshly washed clothing and wash each day;
- I understand that if I need to speak with a member of the office that I will remain behind the glass screen and I am aware that only one person at a time will be allowed in the building;
- I understand that I will not be allowed into the school – I will communicate with the members of staff with my child via telephone or email;
- I will support all staff in their efforts to create an 'as safe as possible' environment during this crisis;
- Read all letters/messages/emails that are sent home;
- I will inform the school immediately of any changes to parents/carer and emergency contacts details.
- I understand that if my child is deemed unsafe, he/she will be sent home and cannot return to school until they can be safe.
- Inform the school on the Wednesday before the week I intend them to return, if I wish for my child to attend.

Child

The children will do their best to:

- Adhere to the social distancing rules in class and in the playground;
- Tell an adult if I feel unwell;
- Not bring additional things into school from home, or take things home from school;
- Only use the equipment provided to me by school and no other;
- Not mix with any other children in other 'bubbles' in the school;
- Only enter and exit the school building from the designated doors and gates when entering the site;
- Follow good respiratory hygiene: coughing and sneezing into elbow or tissue (catch it-bin it-kill it);
- Follow good hand hygiene – use soap and water for 20 seconds/ hand sanitiser;
- Behave well at all times to maintain the safety of myself and others;
- Follow these expectations and know that if I don't, I will be sent home and will not be able to come back into school until I can be safe.
