We have almost completed our third full week back; it has been incredible to see and hear all the learning experiences and opportunities taking place during the start of the Autumn term so far. All our pupils have again shown exceptional resilience and a commitment to ensuring their learning journey continues with a positive start.

Social distancing

A massive thank you to all our parents who are adhering to the social distancing advice and remaining 2 meters apart where possible and 1 metre when 2 metres isn't possible. Please see the Government SPACE advice below.

SPACE - Stay 2 metres apart from people you do not live with where possible, or 1 metre with extra precautions in place.

We would like to send out a polite reminder to ask parents and carers to remain socially distanced during our staggered drop off and collection times. It is extremely helpful for the staff dismissing the pupils if the adults collecting pupils stand in a clear line, following the social distancing queue symbols on the pavement/ground outside each collection point. A few parents and carers have expressed that they are feeling vulnerable at collection times due to a lack of social distancing. We want to ensure everyone in our community is kept safe and would appreciate everyone being more aware of these potential concerns at collection times.

Reading (Reminder from Miss Devonport)

We hope that you like your child's brand-new reading record! Each class has a different age-appropriate style which allows you to fully support your child's progress in this crucially important (and fun!) element of their learning.

Daily reading practice is important for all children from Early Years through to Year 6. Please record this in your child's reading record along with any comments you may wish to pass on to the class teacher. While teachers will not write comments back, they will get in touch via phone if necessary. Records will be checked 2-3 times a week and ticked in pink pen by an adult.
