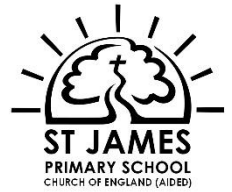




# Godalming Confederation of Schools

The primary phase of the Godalming Confederation (children’s centres, nursery, infant, junior, primary schools) schools are working together to form a new cooperative education partnership.

These schools currently collaborate to provide training and development opportunities for staff; review each other’s performance; share good practice and develop common strategies and practices to further improve standards of learning and outcomes for all children in our area.

Over the last two years, discussions between the schools have led to the conclusion that the partnership working is valuable and should be developed further through a legal structure which also protects each school’s autonomy.

The proposed model is a cooperative learning Trust, which will offer benefits for all of the Confederation schools including:

- **Sustainability:** a formal co-operative legal entity with powers to commission shared support, contracting and other work as agreed jointly
- **Opportunity:** further expansion of shared training, professional development, staff retention and recruitment and curriculum enrichment for our learners.
- **Flexibility:** the choice of agenda and priorities, negotiated between the schools
- **Autonomy** with accountability: continuing independence for each school, with shared goals for school performance and school improvement

## A Legal Consultation

In order to set up the co-operative Trust, four community schools: Busbridge Infant School, Godalming Junior School, Milford School and Moss Lane School are proposing to change their legal school category from community to foundation. This then allows the legal entity of the Godalming Learning Partnership (GLP) to come into being.

The other schools in the Confederation then need to decide if they want to join the GLP as equal partners; many have already expressed their wish to do so. The Confederation has worked closely with the Diocese of Guildford and the status and character of the Church schools in the Confederation remains unchanged. The proposed Trust has the full support of the Diocese.

There are no changes to individual school management, staffing, uniforms or day to day routines – the Trust will create new opportunities which can be used when appropriate.
