2. Barriers to future attainment (for pupils eligible for PP including high ability)	
In-school barriers	
A.	Communication and language skills on entry to school are lower for some pupils eligible for PP than for other pupils.
B.	The % of pupils achieving ARE at the end of KS1 and KS2 is lower for those eligible for PP funding than for those not eligible in reading, writing and in maths, with the biggest gap at KS1. By the end of KS2 the gap is less than at KS1, but the gap in writing particularly is significant. At the end of KS1 the gap is greatest in reading.
C.	A number of pupils eligible for PP funding have a range of social, emotional and mental health needs which are affecting their readiness to learn and make progress.
External barriers (issues which also require action outside school, such as low attendance rates)	
D.	Attendance rates for pupils eligible for PP are 95% which is lower than that of pupils not eligible for PP funding (96.9%). This reduces their school hours, causing them to fall behind.
E.	Many of our pupils eligible for PP funding have less experiences and opportunities outside of school than other pupils.
F.	Several of our pupils who are eligible for PP funding come from homes where families are unable to support their learning outside of school for a variety of reasons, e.g. poor literacy and numeracy skills, lack of resources to support learning at home, complex issues within the family, lack of engagement with school etc.

The social and emotional wellbeing of vulnerable children is protected and enhanced, pupils are able to learn and make progress	Vulnerable pupils across the school are identified at the earliest opportunity and their social, emotional and mental health needs are appropriately addressed. Pupils receiving support for SEMH needs will make progress, this will be seen both in the results of the questionnaires carried out pre and post intervention and in their attainment.

D.	An increase in the rate of attendance for pupils eligible for PP funding	There will be an increase in the attendance of pupils eligible for PP funding to 97%, or at least to match that of pupils not eligible.
