The school will endeavour to:

- Provide an environment which has been risk assessed in response to the COVID-19 infection.
- Adhere to the social distancing rules as set out by the government.
- Provide a curriculum that meets the needs of your child's well-being, mental health and academic needs.
- Explicitly teach the behaviour rules, as outlined in this agreement.
- Continue our clear and consistent approach to rewards and sanctions for children as set out in the Behaviour Policy as well the expectations outlined in this agreement.
- Contact parents/carers if your child displays symptoms of COVID-19.
- Inform you if staff or children in your child's 'bubble' show symptoms of COVID-19 as this will mean you will all need to self-isolate for at least 14 days or until the test comes back negative.
- Communicate between home and school through ParentMail, newsletters, text and the school website.

To help my child at school, I know that:

- If anyone in my household, shows symptoms of COVID-19, I will not send my child to school, we will self-isolate for 14 days as a family. We will be tested and let the school know the results via email.
- If my child, or another in the group, shows symptoms of COVID-19, I will collect my child from school immediately.
- When dropping off and picking up, I will stick to my allocated time slot and adhere to 2 metre social distancing rules at all times.
- My child will not bring any items into school each day apart from a names water bottle and coat.
- My child's temperature will be taken during the day if they feel or present as being unwell.
- My child will need to use good respiratory and hand hygiene.
- I will not be allowed into the school building.
- I will communicate with school via email or phone.
- I agree to support staff in their efforts to create an 'as safe as possible' environment during this crisis & will reinforce behaviour expectations with my child.
- I will read all letters/messages/emails sent to me.
- I will inform the school immediately of any changes emergency contacts details.
- If my child is deemed unsafe they will be sent home and not be permitted to return to school until I am advised it is safe for them to do so.

I will do my best to:

- **Always** listen to instructions given by the adults in school
- Follow the 2 metre rule and observe markings and walk sensibly with my grown up, when coming in to and leaving school.
- Stay with my class group at all times.
- Keep my distance from my friends and grown-ups, when I am told to, both in the classroom and on the playground.
- At all times, follow the new rules in place to keep me safe.
- Tell an adult straight away if I feel unwell.
- Take care of any equipment given to me and avoid touching any equipment not in my own tray.
- Always try to remember "Catch it, Bin it, Kill it!" when I cough or sneeze.
- Wash my hands thoroughly with soap for a minimum of 20 seconds every time I am instructed to do so and always after using the bathroom.
- Behave well at all times to keep myself and others safe.
