Curriculum focus of PPG spending 2017/18

Regardless of their ability, or prior attainment, those children eligible for Pupil Premium, receive additional support within their classroom.

The primary support for pupils includes the development of skills in English and Mathematics including focused work on phonics/reading where appropriate and participation in a spelling intervention programme. Pupils also receive support in other subject areas to ensure they are able to apply the development of these skills across the whole curriculum.

Measuring the impact of PPG spending

The impact of Pupil Premium funding and the details of additional support provided by the school will be evaluated half-termly.

Evaluation will focus on individuals' progress in Reading, Writing and Mathematics.

The impact on pupils' confidence, self-esteem, well-being and attitude to learning will be reviewed.

The school's Governing Body will receive progress reports at each meeting. There is a named governor (Mr Andrew Naughton) with responsibility for monitoring the progress of Pupil Premium children. This includes monitoring visits (with Learning Walks) and meetings with the Headteacher/Senior Leadership Team, discussions with pupils and the outcomes and impact of regular scrutiny of work books.

End of Year Summary (July 2018)

Foundation Stage:

5 out of 6 (83%) of PPG pupils achieved a *Good Level of Development*

Year 1 Phonics Check:

2 out of 2 (100%) of PPG pupils achieved the *Required Standard*

End of Key Stage 1:

7 pupils were eligible for PPG funding (including 1 pupil who was not assessed)

5/7 (71%) achieved the Expected Level for Reading; 2 of these achieved at Greater Depth within the Expected Level

3/7 (43%) achieved the Expected Level for Writing; 1 of these achieved at Greater Depth within the Expected Level

4/7 (57%) achieved the Expected Level for Mathematics

End of Key Stage 2:

7 pupils were eligible for PPG funding (including 1 pupil with an EHC Plan who was disapplied from the SATs)

4/7 (57%) achieved the Expected Level for Reading; 3 of these achieved at Greater Depth within the Expected Level

4/7 (57%) achieved the Expected Level for Writing; 2 of these achieved at Greater Depth within the Expected Level

4/7 (57%) achieved the Expected Level for Mathematics; 3 of these achieved at Greater Depth within the Expected Level

5/7 (71%) achieved the Expected Level for Grammar, Punctuation and Spelling; 3 of these achieved Greater Depth with the Expected Level
