Aims of this session

- To explore pupil online communication and networking.
- To be aware of the safeguarding risks to pupils online

What is Safeguarding?

Safeguarding is a framework to protect the health, well-being and human rights of <u>all</u> individuals so they live free from abuse, harm, and neglect.



Online safety is part of safeguarding:

- We need to safeguard children from potentially harmful and inappropriate experiences online
- Peer-on-peer abuse (including bullying), sexual harassment, and extremist radicalisation can all happen online

What does 'on-line' mean?

Using a computer or any electronic device to connect to other telecommunication systems-electronic devices, servers, networks, databases etc

Which electronic devices do your children use?

- Mobile phones
 - ► Computers
 - **Laptops**
- ▶ Tablets/Ipads
- ▶ Game consoles

Which sites or apps do your children use online?

In 2020, the use of apps and the internet in general became vital to being social and keeping on top of school. Every minute, there were:

- ▶ 4.1 million different searches on Google
- ▶ 1.3 million Facebook logins
- ► 698,000 Instagram scrolls
- ► 194,000 Twitter tweets
- 59 million messages sent on WhatsApp and Facebook Messenger
- ▶ 1,400 downloads from TikTok
- 1.2 million views on Twitch
- 400,000 apps downloaded
- £1.1 million spent online

There are plenty of positives when it comes to the internet:

- Things like online games enhances creativity and teamwork
- Children have easy access to a wealth of knowledge
- Households with computers/online devices tend to perform better academically
- It can help improve visual intelligence and hand-eye coordination (not just with games)
- A 2020 Ofcom report found that 89% of 8-11 year olds said that using social media made them feel happy. 82% said it helped them feel closer to their friends.

What skills do your children learn whilst online?



A Balanced diet of Online Use:

- The internet opens up a wealth of opportunities for children and has become a big part of how they develop, discover and see the wider world.
- With everything, including technology use, moderation is key.

Various studies have found that technology can affect:

- Sleep cycles
- The central nervous system (which can impact mood, attention, alertness, and decision-making)
- Memory
- Focus
- Empathy
- How children are impacted by marketing

What are your online concerns as a parent?

Parental Concerns

- Studies show that parent concerns typically peak when a child is 11-12 years old which coincides with the transition to secondary school. The main parental concerns from the 2021 Ofcom report were:
- Websites and content that encourages self-harm
- How their child's privacy is affected and data collected
- Cyberbullying
- Being radicalised by extremist groups
- Spending too much time looking at a screen

What does 'On-line safety' mean?

The 4 Cs of On-Line Safety

The 4 main types of risk

1. CONTENT:

being exposed to illegal, inappropriate or harmful material online (e.g. pornography, fake news, racist or offensive views, radical or extremist views, underage apps or gaming).

2. CONTACT:

being the victim of harmful interactions online, whether between children or by adults (e.g. bullying, grooming, aggressive advertising, pressure to spend money).

3. CONDUCT:

behaving in a way online that causes harm or increases the likelihood of it (e.g. bullying others, making, sending or receiving explicit images, sexually harassing others).

4. COMMERCE:

risks like online gambling, inappropriate advertising, phishing or financial scams Children could also stray into cyber-crime such as hacking, 'booting' (overwhelming a computer, network or website with traffic to make it unavailable) and involvement with malicious software like viruses.

Signs of online safety issues to look out for:

A child might:

- Spend more time on their phone or online than usual
- Seem distant, upset or angry after using their phone or the internet
- Be secretive about who they're talking to and what they're doing online
- Have lots of new contacts
- Show changes in their mood, behaviour or appearance, or do less well at school

How we teach On-line Safety at OGPS

Today's pupils are growing up in an increasingly complex world, living their lives seamlessly on and offline. This presents many positive and exciting opportunities, but also challenges and risks.

We want schools to equip their pupils with the knowledge needed to make the best use of the internet and technology in a safe, considered and respectful way, so they are able to reap the benefits of the online world.

Teaching Online Safety in Schools-June 2019-DFE

OGPS Whole School Approach to Online Safety

- Relationship and Health Education (which is compulsory for all Primary-aged children):
- pupils are taught about online safety and harms- this includes being taught what positive, healthy and respectful online relationships look like, the effects of their online actions on others and knowing how to recognise and display respectful behaviour online.
- Online Safety is taught in an age-appropriate way that is relevant to pupils' lives.

OGPS Whole School Approach to Online Safety

Computing Curriculum

Pupils are taught how to use technology safely, responsibly, respectfully and securely and where to go for help and support when they have concerns about content or contact on the internet or other online technologies.

PSHE including Citizenzenship:

- this covers media literacy distinguishing fact from opinion as well as exploring freedom of speech and the role and responsibility of the media in informing and shaping public opinion.
- Pupils are also taught about the concept of democracy, freedom, rights, and responsibilities as well as behaviours and relationships.

OGPS Whole School Approach to Online Safety

- School IT filtering and monitoring systems- all our online access is filtered through the LGFL filtering system. Teachers also have live viewing access to all computers in use by pupils in the ICT suite.
- ❖ Assemblies- Pupils are reminded of how to keep safe online through regular assemblies and National Online Safety and Safer Internet Day each year in February.
- * Reminders through displays around the school.
- * Reinforcing key messages when incidents arise.
- Our in-school counsellor has explored Online use and safety with our Year 5 and 6 pupils as part of our transition and gender-based workshops.
- Regular training for all staff in the school.

Teaching all our pupils the 'SMART' rules for using the internet:

S is for SAFE

Never give out personal information if you are chatting or posting online.

Personal information:-

your name
your school
where you live
email address
phone number
passwords

M is for MEETING

Meeting someone you have only been in touch with online can be dangerous. Only do so with your parents' or carers' permission and even then only when they can be present.

Remember online friends are still strangers even if you have been talking to them for a long time.

A is for ACCEPTING

Accepting emails, instant messages, or opening files, pictures or texts from people you don't know or trust can lead to problems - they may contain viruses or nasty messages!

R is for RELIABLE

Someone online might lie about who they are. Information on the internet may not be true. Always check information with other websites, books or someone who knows. If you like chatting online it is best to only chat to your real world friends and family.

T is for TELL

Tell your parent, carer or a trusted adult if someone or something makes you feel uncomfortable or worried, or if you or someone you know is being bullied online.

HOW TO SUPPORT YOUR CHILD AT HOME

Although there are a number of online risks that children may be exposed to, it's important to note that these do not directly lead to harm.

Being informed about the risk and implementing safeguards to limit the likelihood of your child being exposed is the first line of defence.

Internet Matters gives five tip to help parents manage their children's screen time:

- 1. Set a good example with your own device use. Children will tend to model their behaviours on you, so if you start reading a book, they may follow your lead.
- 2. Communicate regularly: ask your children about their online usage and stress the importance of being private online.
- 3. Agree on helpful mediation strategies: speak with your child about what can be done if they find themselves in harm's way; build trust.
- 4.Once you've agreed on an appropriate length of time that they can use their device, put in place a family agreement to set some boundaries and don't break them. A good resource for this can be found on Childnet.

- 5. Create rules such as 'no phones at the table' or 'no devices between 6 and 7 pm.
- 6. Have family tech-free days.
- 7. Turn off notifications on apps to avoid constant pings.
- 8. Buy alarm clocks rather than using devices in the bedroom.
- 9. Keep your phone on silent and out of sight when picking kids up from school.
