Part A: Pupil premium strategy plan

Statement of intent

At Oliver Goldsmith School our pupil premium strategy focuses on ensuring that disadvantaged pupils access the targeted support required to achieve their full potential. The funding issued is used to narrow and close the gap between the achievement of these pupils and their peers. We monitor the impact of our strategy by tracking and reviewing pupil outcomes termly. The Pupil Premium Grant is used to provide additional educational support in order to improve the progress and to raise the standard of achievement for eligible pupils.

Inspiring a love for learning, high quality teaching and targeted support are at the heart of our approach to support disadvantaged pupils. We invest in teacher development which enables us to provide an ambitious and engaging curriculum.

In addition to targeted academic support, we also provide enrichment opportunities such as subsidised music lessons, clubs and school trips that come at an additional cost throughout the academic year.

We ensure that our pupils have a range of support to promote positive mental health and wellbeing. Social and emotional needs are invested in to enable best outcomes. We also prioritise investing in targeted support to best prepare our pupils for the next stage in their educational career.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1.	Closing the gap and setting ambitious challenge:
	Overall, our pupil premium children are attaining lower outcomes than our non-pupil premium pupils. In addition, less of our pupil premium children are achieving greater depth in comparison to their non-pupil premium peers.
2.	Additional needs
	For some children there are multiple vulnerabilities including SEND, EAL and challenging family circumstances.
3.	Pupil premium children's limited access to enrichment opportunities in order to develop their 'cultural capital'
	There must be an ongoing commitment to ensure that our most disadvantaged children continue to access a range of additional enrichment opportunities to

	reach their full potential and develop their 'cultural capital' equipping them to achieve future success.
4.	Access to appropriate resources outside of school
	Many families are unable to support their child's learning at home due to lack of appropriate resources. It is vital that the school provide a range of good quality resources to support learning.
5	Supporting positive mental health and wellbeing
	Promoting children's wellbeing is a key part of keeping them safe, helping them develop and ensuring they have positive outcomes into adulthood (Public health England 2021)

To ensure that all disadvantaged children have access to correct school uniform and stationery.

Stationery will be provided by school in all classes enabling all children to maximise learning time. Stationery will be replenished regularly to ensure every child has the resources required that equip them to learn.

Good quality second hand uniform sales will continue to be well attended.

Families in receipt of pupil premium will all benefit from being given funding for a school jumper (only logoed item of uniform) per academic year.

SLT will continue to monitor the presentation of pupils and will offer support to families as and when required.

Children will have their social and emotional needs met. Positive mental health and wellbeing will be invested in to enable best outcomes for the future.

Pupils will have access to a range of different approaches to support their individual social, emotional and mental health needs.

School counsellor 1:1 sessions for targeted children will have successful outcomes.

Year 6 children will feel prepared for their transition to high school through additional support from our school counsellor.

The schools universal offer to support mental health and wellbeing will be extended to KS1 and Reception with a focus on an emotional regulation programme. Pupils will be able to use self help strategies to help regulate emotions.

KS2 children will continue to use emotional regulation strategies with a growing independence when needed.

Additional targeted support both in class and in the playground will be available and effective in supporting social, emotional and mental health needs.

EYFS

There were eight pupils in receipt of the Pupil Premium grant in Reception 2022-2023. Five of the eight children achieved a GLD.

Year 1 Phonics screening

In June 2023 all Year 1 pupils completed the statutory phonics screening check. All four children in receipt of pupil premium funding achieved the required standard.

There was a good uptake for free uniform items and we have received positive parent feedback regarding reducing the logoed items in our new uniform policy. Learning time in class continues to be maximised as stationery is available to all children.

Attendance of children in receipt of pupil premium funding at After School Clubs has increased from last academic year to 40%.

Eight out of twelve Year 5 children in receipt of Pupil premium funding attended our residential trip in May 2023.

Senior Mental Health Leader has successfully completed the DFE accredited training. We have introduced weekly sessions with our link NHS wellbeing practitioners as part of Mental Health support team programme. All KS2 children successfully completed NHS Brain buddies emotional regulation programme supporting positive mental health and wellbeing. Classes are now using a consistent approach to supporting children to regulate their emotions. Our school counsellor continues to see children on a 1:1 basis to deliver targeted support.

Additional learning support focusing on social and emotional needs has been introduced, enabling timetabled reflection times and bespoke approaches to meeting the social and emotional needs of individual learners.

Quality first teaching is embedded across school using the Rosenshine Principles. LSA's have completed CPD focusing on the EEF's recommendations for effective teaching assistants and use of the scaffolding triangle. This is now incorporated into daily practice.

Year 6 pupils have been supported for their next academic transfer with a preparation for high school programme which included both 1:1 and group sessions with school counsellor.

Music outcomes continue to be successful. Children with an interest and flair for music have benefitted from additional small group enrichment sessions with our specialist music teacher. 11/46 children played a musical instrument with financial support from PPG.
