Relationships Education is set in the context of clear values, including the value of family life, marriage, civil partnerships and the importance of loving and stable relationships to bring up children. It supports lifelong learning about physical, moral and emotional development and is part of our personal, social, health and citizenship education (PSHCE) programme. It is not about the promotion of sexual orientation or sexual activity. The school uses the "Jigsaw" PSHE scheme which we adapt to meet the needs of our pupils.

1. Aims

The aims of relationships education and health education at OGPS are to:

- Provide a framework in which sensitive discussions can take place.
- To provide age appropriate knowledge and information to which all pupils are entitled.
- Teach pupils the correct vocabulary, age appropriate, to describe themselves and their bodies.
 - In KS1, the use of private areas/parts will be used in line with NSPCC 'Underwear Rule' initiative
 - In KS2, the use of the correct terminology for body parts will be used in KS2.
- To raise pupils' self-esteem, emotional wellbeing and confidence, especially in their relationships with others. This will help pupils to form and maintain positive relationships based on respect for themselves and for others, at home, at school and in the wider community.
- To develop skills for a healthier, safer lifestyle and enable pupils to recognise and reflect qualities that help them to grow and develop.
- Prepare pupils for puberty and adulthood, understanding the importance of health and hygiene.
- To help pupils develop relationship and communication skills to cope with the influences of their peers and the media.
- To safeguard children from abuse and protect them from being exploited.

2. Statutory requirements

As a maintained primary school we must provide relationships education to all pupils as per section 34 of the Children and Social work act 2017.

However, we are not required to provide sex education but we do need to teach elements of the national curriculum contained in the science curriculum related to the human body and reproduction (see appendix 1).

In teaching RSE, we must have regard to <u>guidance</u> issued by the secretary of state as outlined in section 403 of the <u>Education Act 1996</u>.

At Oliver Goldsmith Primary School, we teach Relationships Education and Health Education as set out in this policy.

3. Policy development

This policy has been developed in consultation with governors, staff and parents. The consultation and policy development process involved the following steps:

- 1. Review a working group from the staff team, including the PSHE Leader, Deputy Headteacher and Headteacher pulled together all relevant information including relevant national and local guidance as well as our current PSHE scheme of work, Jigsaw.
- 2. Staff Consultation all school staff were given the opportunity to look at the policy and make recommendations.
- 3. Parent/stakeholder consultation parents and interested parties were invited to take part in the consultation in the following ways;
 - a. The policy was sent home (paper & e-copy) for parents to read. Parents had an opportunity to provide their feedback and opinions.
 - b. An opportunity to speak to senior leaders and members of the board of governors at the parents' evening in Spring 2020 to ask questions or share their feedback and opinions related to the policy.
 - c. An opportunity to attend parent time meetings to hear about the policy and share their feedback and opinions.
- 4. Pupil consultation we investigated what pupils wanted to learn about in PSHE/Relationships and Health Education lessons. This was carried out by the School Council.
- 5. Governor Discussion governors reviewing the policy in light of the consultation feedback gathered.
- 6. Ratification –the policy was ratified by the board of governors and will be reviewed every 3 years.

4. Definition

Relationships and health education is about the emotional, social and cultural development of pupils, and involves learning about relationships and healthy lifestyles.

Relationships and health education involves a combination of sharing information, and exploring issues and values.

Relationships and health education is **NOT** about the promotion of sexual orientation or sexual activity.

At Oliver Goldsmith Primary school, we will be covering the statutory aspects of;

- KS1 & KS2 Science Curriculum (see appendix 1)
- · Relationships Education for primary schools
- Health Education

5. Curriculum

Our curriculum is set out in the appendices at the end of this policy but we may need to adapt it as and when necessary. It builds upon the personal and social development work carried out to meet the Early Learning Goals at the Foundation Stage. It builds a foundation of emotional and social skills which is central to all later relationships and health education work.

The curriculum has been adapted from the Jigsaw PSHE scheme of work by senior leaders and our PSHE leader. It has been developed taking into account the age, needs and feelings of our pupils. If pupils ask

questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online.

6. Delivery of Relationships and Health Education

Relationships and health education is taught within the personal, social, health and economic (PSHE) education curriculum. Some aspects are taught within science, computing and design technology. We also use our assembly programme to support the curriculum.

Our PSHE scheme, Jigsaw, has six key themes which ensure there is progression in the teaching of relationships and health education from the start of key stage one to the end of key stage two. The six key themes are:

- > Being Me in My World
- > Celebrating Difference
- > Dreams and Goals
- > Healthy Me
- > Relationships
- > Changing Me

Relationships and health education is delivered using participatory methods for learning and these include whole class discussion, circle time and the use of small groups. Teaching in single sex groups is used in years five and six.

Resources such as books, photographs will be age appropriate to the learning.

We have a commitment to ensure that all pupils have equal access to the relationships and health education curriculum following guidelines in the special educational needs and equal opportunities policies. We use inclusive strategies to support the learning of all pupils e.g. pictures, word banks, key words, writing frames, ICT, dual language resources as well as using Learning Support Assistants to support pupils who have additional needs.

We have a commitment to providing all children with an equal entitlement to relationship and health education regardless of race, gender, culture, disability or class.

Areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families structures include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

7. Roles and responsibilities

7.1 The governing board

The governing board will approve the relationships and health education policy, and hold the headteacher to account for its implementation.

7.2 The headteacher

The headteacher is responsible for ensuring that relationships and health education is taught consistently across the school.

7.3 Staff

Teaching Staff are responsible for:

- > Delivering relationships and health education in a sensitive and inclusive way.
- > Modelling positive attitudes to relationships and health education.
- > Monitoring progress.

> Responding to the needs of individual pupils, including the effective use of Learning Support Assistants
Staff do not have the right to opt out of teaching relationships and health education. Staff who have concerns are encouraged to discuss this with the headteacher.

7.4 Pupils

Pupils are expected to engage fully in relationships and health education and, when discussing issues, treat others with respect and sensitivity according to the Jigsaw charter which we review at the start of each academic year.

The Jigsaw charter, which links closely to our own school rules, says;

- We take turns to speak.
- We use kind and positive words.
- We listen to each other.
- We have the right to pass.
- We only use names when giving compliments or when being positive.
- · We respect each other's privacy.

8. Parents' right to withdraw

Parents <u>do not</u> have the right to withdraw their children from relationships education and health education or science lessons derived from the national curriculum. Where parents have questions, they can contact the headteacher via the school office.

9. Training

This key policy will be part of the staff induction process. Staff are trained on the delivery of relationships and health education, it is included in our continuing professional development calendar.

The headteacher may also invite visitors from outside the school, such as school nurses to provide support and training to staff teaching relationships and health education.

10. Monitoring arrangements

The delivery of relationships and health education is monitored by the PSHE leader alongside senior members of staff (Assistant Headteacher, Deputy Headteacher and Headteacher) and members of the school leadership team through the use of planning scrutinies, learning walks, pupil interviews and book looks.

Pupils' development in relationships and health education is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by the PSHE leader every three years. At every review, the policy will be approved by the board of governors

Appendix 1: National Curriculum for Science in KS1 & KS2

Science Curriculum Map

KEY STAGE/ YEAR GROUP	TOPIC/THEME DETAILS
Key Stage 1: Year 1	To identify, name, draw and label the basic parts of the human body and say which part of the body is associated with each sense.
Key Stage 1: Year 2	To notice that animals, including humans, have offspring which grow into adults.
Key Stage 2: Year 5	To describe the differences in the life cycles of a mammal, an amphibian, an insect, a bird and describe the life process of reproduction in some plants and animals.
Key Stage 2: Year 5	To describe the changes as humans develop to old age.
Key Stage 2: Year 6	To recognise that living things produce offspring of the same kind, but normally offspring vary and are not identical to their parents.

Mental Wellbeing	 That mental wellbeing is a normal part of daily life, in the same way as physical health. That there is a normal range of emotions (e.g. happiness, sadness, anger, fear, surprise, nervousness) and scale of emotions that all humans experience in relation to different experiences and situations. How to recognise and talk about their emotions, including having a varied vocabulary of words to use when talking about their own and others' feelings. How to judge whether what they are feeling and how they are behaving is appropriate and proportionate. The benefits of physical exercise, time outdoors, community participation, voluntary and service-based activity on mental wellbeing and happiness. Simple self-care techniques, including the importance of rest, time spent with friends and family and the benefits of hobbies and interests. Isolation and loneliness can affect children and that it is very important for children to discuss their feelings with an adult and seek support.
