





# 52 Olsen Court, Lincoln

This is a good sized first floor apartment in what is an attractive and well located block of twenty one homes for the over 55's age group, built for and managed by Lace Housing, a locally based provider of housing, care and support services for older people in Lincoln.

Lace Housing offers a wide range of communal facilities, support services and additional care as and when required and their offices are just a few yards walk away from the apartment block.

There are pleasant views out towards the nearby Carlton Shopping Centre and the attractively landscaped Carlton Community Garden. Communal areas within the building are very well presented and maintained and also communal car parking.

# ACCOMMODATION

From the secure main entrance to the apartment building, there is a well presented communal entrance hall with a staircase and lift up to the second floor.

**Entrance Hall** of good proportions having an electric panel heater and power points.

Living Dining Kitchen of excellent proportions and having a very pleasant north westerly outlook from the French doors with a Juliet balcony out towards the Carlton Centre Plaza and the very attractively landscaped Carlton community garden. The kitchen area is well appointed having a range base, drawer and wall units, work surface areas with single drainer stainless steel sink unit inset and room for kitchen white goods below. Built in brushed style steel oven below surface, ceramic style hob inset with brushed style steel cooker hood above. Space to one corner for an upright fridge/freezer, fluorescent lighting strip and power points.







**Living Dining area** well- proportioned having two electric wall panel heaters, coving, TV aerial point, telephone point and power points.

**Bedroom 2** with a westerly aspect; fitted wardrobe space to one corner, electric panel heater, telephone point and power points.

**Bedroom 1** with a north westerly view out towards the shopping centre piazza, fitted wardrobe space and chest of drawers across one wall, large walk-in airing cupboard containing the Elson Coral E hot water cylinder, electric panel heater, TV aerial point and power points. Door through to:

**Jack'n' Jill En-suite Shower** Room also accessible from the entrance hall; having a large built-in shower cubicle to one wall with shower fitting and accompanying wall tiling with mobility fittings; pedestal wash hand basin with tiles splash back and low-level WC. Mirror panelled toiletry cabinets, electric bathroom heater, electric shaver socket point and extractor event.

# THE AREA

The Olsen Court building is no more than one hundred metres away and provides a very good range of amenities including, Post Office, Boots chemist, dentist, building society, a café/restaurant and yet more. There is a large Lidl supermarket on the opposite side of Outer Circle Road and just beyond off Wragby Road there is the city's largest Tesco's superstore.

The famous uphill Lincoln Cathedral Quarter with the accompanying castle and its museums', the Bailgate and historic Steep Hill shopping areas with their quaint boutiques, bistros and more; are but a short drive or bus ride away.


