

Experimental Section

General Procedures. All chemicals purchased from commercial suppliers were used as received. All reactions involving air- or moisture-sensitive reagents were performed under a nitrogen atmosphere using dry solvents. All compounds were purified to ≥95% purity as judged by HPLC with UV and MS analysis. Proton (1 H) and carbon (13 C) NMR spectra were recorded at ambient temperature. Solutions were typically prepared in deuterated dimethylsulfoxide (DMSO-d6), deuteromethanol (CD₃OD), or deuterochloroform (CDCl₃), with chemical shifts referenced to solvent as an internal standard. 1 H NMR data are reported indicating the chemical shift (δ), the multiplicity (s, singlet; d, doublet; t, triplet; q, quartet; m, multiplet; etc.), the coupling constant (J) in Hz, and the integration (e.g., 1H). MS experiments were performed on

a Waters Acquity, Waters 2777, or Waters 2700 UV-HPLC system and a Waters Xevo G2 TOF, Waters LCT Premiere, Waters LCT, or Waters QTOFmicro mass spectrometer. Compounds were named using IUPAC Name ACD (version 10.06).

5-(2-Aminopyrimidin-5-yl)-7-chloro-2-[(1S)-1-cyclopropylethyl]-2,3-dihydro-1H-isoindol-1-one (3).

A flask containing K₂CO₃ (277 mg, 2.00 mmol), **19** (210 mg, 0.67 mmol) and 5-(4,4,5,5-tetramethyl-1,3,2-dioxaborolan-2-yl)pyrimidin-2-amine (148 mg, 0.67 mmol) in water (2 mL) and dioxane (2 mL) was degassed. PdCl₂(dtbpf) (21 mg, 0.03 mmol) was added and the resulting mixture was heated to 70°C. After 1h the reaction mixture was diluted with EtOAc and washed sequentially with saturated NaHCO₃ and brine. A flask containing K₂CO₃ (71 mg, 0.51 mmol), **23** (58 mg, 0.17 mmol) and 3-chloropyrazin-2-amine (22 mg, 0.17 mmol) in water (1 mL) and dioxane (1 mL) was degassed. PdCl₂(dtbpf) (5 mg, 0.09 mmol) was added and the resulting mixture was heated to 70°C for 1.5 h. The reaction mixture was diluted with EtOAc and washed sequentially with saturated NaHCO₃ and brine. A microwave vial was charged with 2-bromo-5H-pyrrolo[2,3-b]pyrazine (232 mg, 1.17 mmol), **23** (400 mg, 1.17 mmol), PdCl₂(PPh₃)₂ (82 mg, 0.12 mmol), 1M aqueous Na₂CO₃ (3.52 mL) and acetonitrile (7 mL). The vial was sealed, evacuated and purged three times with nitrogen and heated to 140°C for 30 minutes in a microwave reactor. Cooled to rt, EtOAc and water were added, organic phase separated and the aqueous phase was extracted with DCM. The combined organic layers were filtered through a phase separator and concentrated. PdCl₂(dppf) (30 mg, 0.04 mmol) was added to a microwave vial containing **23** (140 mg, 0.41 mmol), Cs₂CO₃ (535 mg, 1.64 mmol), and 3-amino-6-bromo-*N*-methylpyrazine-2-carboxamide (95 mg, 0.41 mmol) in DMF (4 mL) and water (0.05 mL). The vial was sealed and heated to 100°C for 30 min in a microwave reactor. The crude reaction mixture was filtered through Celite and washed with DCM. The filtrate was concentrated and chromatographed (silica gel; 50 to 100% of EtOAc in heptane) and the obtained material was further purified by

preparative HPLC to give the title compound (27 mg, 18%). After being cooled to rt the mixture was filtered through Celite and the solvent was removed under reduced pressure. 8 (92 mg, 0.24 mmol), 2-methoxyethanesulfonamide (53 mg, 0,38 mmol), K_2CO_3 (98 mg, 0.71 mmol), allylpalladium(II) chloride dimer (2 mg, 5.90 μ mol) and tBuXPhos (50 mg, 0.12 mmol) in Methyl THF (1 mL) in a sealed vial was heated to 80°C over night. The reaction mixture was filtered through a silica plug, concentrated and then dissolved in DCM and washed with water. The organic phase was filtered through a phase separator and concentrated. K₂CO₃ (0.88 g, 6,4 mmol) was added to a flask containing methyl 4-bromo-2-(bromomethyl)-6-chlorobenzoate (2,20 g, 6,4 mmol) and (*R*)-1-Cyclopropylethanamine (0.55 g, 6.4 mmol) in DMF (10 mL) and the resulting mixture was heated to 80°C and stirred for 2 h. Biological assays.

PI3K biochemical assays:

Enzymatic activity assay for rec human PI3K α , β , γ , and δ : The activity of recombinant human PI3Ky ((aa144-1102)-6His) and α , β , δ (6-His(p110-p85a)) was determined by measuring the ADP level after phosphorylation of DiC₈-PIP2 using a commercially available ADPGloTM kit from Promega. The assay was carried out in white low volume 384 well plates in a final volume of 14 µL at rt. The assay contained the following: 50 mM Tris buffer pH 7.4, 2.1 mM DTT, 5 mM MgCl₂, 0.05% CHAPS, 20 µM ATP, 80 µM DiC₈-PIP2 and 1.2 nM PI3K α, β, γ or 0.6 nM PI3Kδ. Potential inhibitors were dissolved in DMSO and then diluted in the assay to give a final concentration of not exceeding 1% (v/v) DMSO. A 10-point half-log dilution series of the inhibitors (highest concentration typically 1 μ M for γ and 33 μ M for α , β , and δ) was tested and the pIC50 determined using a 4-paramater logistic equation in a nonlinear curve fitting routine. Routinely, inhibitors were pre-incubated with 3 µL of enzyme for 10 min prior to the addition of 2 µL substrate mixture for a further 60 min enzyme reaction. The phosphorylation was stopped with the addition of 3 µL ADP-GloTM reagent (stop solution) followed by a 40 min incubation. Prior to detection 6 µL of ADP-GloTM Kinase Detection Reagent was added and the plates were read in a micro plate reader using a Luminescence filter. All additions were followed by a short centrifugation step.

A 10-point half-log dilution series of the inhibitors (highest concentration typically 1 μ M for γ and 33 μ M for α , β , and δ) was tested and raw data output was analyzed in Screener software (Genedata AG) and pIC₅₀ values calculated using a four parameter logistic fit. Variability of the enzymatic activity assays for a reference compound (pIC₅₀ (mean \pm SD)): PI3K γ 7.40 \pm 0.12 (n = 100), PI3K α 7.65 \pm 0.10 (n = 144), PI3K β 6.87 \pm 0.11 (n = 136), PI3K δ 7.34 \pm 0.09 (n = 161).

PI3Kγ cell assay:

Inhibition of p-Akt in in RAW264 cells: PI3Kγ inhibitors were identified by measuring the phosphorylation of AKT (at Ser473) using HTRF® technology (Phospho-AKT (Ser473) kit, Cisbio) in RAW264 cells – mouse monocytic cell line (ATCC). Cryo preserved cells were thawed rapidly in DMEM + Glutamax medium (10% FBS) at 37°C. Cells were plated in white low volume 384 well plates at a density of 2.5E6 cells/mL in assay buffer (DMEM + 1% FBS). Potential inhibitors were made up in DMSO and then diluted in the assay to give a final concentration of not exceeding 1% (v/v) DMSO. Inhibitors were incubated with 8 μL of cells for 15 minutes at 37°C prior stimulated with 2 μL C5a (2 nM) in assay buffer. After an incubation of 3 min at 37°C the cells were lysed for 30 min at rt on a plate shaker at 500 rpm. A 5 μL mix of d2/cryptate were added to the plates and the FRET signal were read in a micro plate reader after 3 – 4 h at 620 nm & 665 nm. The signal at 665 nm was divided by the signal at 612 nm and multiplied by 10,000 to generate a signal ratio value for each well. A 10-point half-log dilution series of the inhibitors (highest concentration typically 1 μM) was tested and

raw data output was analyzed in Screener software (Genedata AG) and pIC₅₀ values calculated using a four parameter logistic fit.

PI3K α , β , γ , and δ enzyme and PI3K γ cell inhibitory potencies with standard deviations (SD) for compounds **3-18**.

Rat LPS in vivo model

The present study was approved by the local ethical committee in Gothenburg (188-2012) and the approved site number is 31-5373/11.

We tested compound **15** in the rat lipopolysaccharide (LPS) model. Female Wistar (substrain Hannover GALAS) were obtained from Taconic Europe, Denmak. The rats were challenged with 0.125 mL LPS (E. coli (026:B6, powder, Sigma-Aldrich, Sweden Lot: 091M4054), 5 μ g/mL diluted in sterile NaCl, 0.9% solution (B. Braun medical AB, Sweden)) using intratracheal route of administration. 2h prior to challenge, the rats were orally treated with 0.1, 0.5, and 2.5 mg/kg of compound **15** and sacrificed 4h later. Broncheo-alveolar lavage (BAL) was performed by manual perfusion of the whole lung and the lung neutrophil infiltration for compound treated LPS challenged animals (n = 8 per group) was compared to LPS vehicle controls (n = 10) using total and differential cell count with SYSMEX XT-1800i Vet (SYSMEX, Kobe Japan).

Determination of the mPI3Kδ crystal structure.

The expression and purification of mouse PI3K δ followed the same procedure as previously described. 6 Compound 9 was solubilised to 50 mM in DMSO and 0.4 µL of compound stock was mixed with 3 μL of 5% w/v n-dodecyl-β-D-maltoside (DDM) from Hampton Research® prior to the addition of 25 μL mPI3Kδ (at 5 mg/mL in 20 mM Tris pH 7.2, 50 mM ammonium sulfate, 1% ethylene glycol, 1% betaine, 0.02% CHAPS and 5 mM DTT). The mixture was left to incubate for 1 hour and then centrifuged at 13000 rpm for 30 minutes. Hanging drops were set up with a one to one ratio of protein solution and well solution around condition G6 of the Morpheus screen (Molecular Dimensions®): 50% ethylene glycol/PEG 8000, 0.1 M carboxylic acids mix, 0.1 M Buffer system 2 pH 7.5. Streak seeding improved the size and quality of the crystals. For data collection crystals were flash frozen in liquid nitrogen without the addition of any cryo-protection. All data was collected at the European Synchrotron Radiation Facility, France; compound beam line ID29 complex. Structure of mPI3Kδ was determined by Molecular replacement using the program "Molrep" using internal structures as search models. Manual fitting and inspection of structures were carried out in the program Coot⁸ and refinement carried out using the program Refmac.⁹ The X-ray structure has been deposition with deposition code 6FTN.

Analytical HPLC/MS

Analytical HPLC/MS was conducted using UV detection, and conditions descibed below:

- (A) BEH C18 column (2.1mm × 50 mm, 1.7 μm,) using a gradient of 5% v/v MeCN in H₂O (ammonium carbonate buffer, pH 10) to 90% v/v MeCN in H₂O over 2.5 minutes. Detection at 210 nm. Ionisation mode was ESI⁺.
- (B) CSH C18 column (2.1×50 mm, 1.7 µm), using a gradient of 5% v/v MeCN in H₂O (ammonium formate buffer, pH 3) to 90% v/v MeCN in H₂O over 2.5 minutes. Detection at 230 nm. Ionisation mode was ESI⁺.

All tested compounds were determined to be \geq 95% pure based on the peak area percentage.
