Experimental Procedures

General Information

Synthesis and General Instrumentation: Unless otherwise stated, reagents and solvents were purchased from commercial sources and used without further purification. $[\text{Ir}(\text{ppy})_2(\text{dtb-bpy})]\text{PF}_6$ was prepared according to a literature procedure.¹

Analytical Thin Layer Chromatography (TLC) was carried out using aluminium-backed Merck Kieselgel KG60 F254 silica plates. Preparative TLC was conducted using Analtech silica gel matrix preparative TLC plates (1.00 mm). The plates were visualized by irradiation with short-wave ultraviolet light. Flash chromatography was performed on SiliaFlash® P60 R12030B 40-63 micron silica gel.

All light promoted reactions were performed using two PR160 (40 W, 440 nm) Kessil LED lights (www.kessil.com) (Figure S1). Vials were placed on a square metal frame fitted with PC cooling fans and heat sinks for temperature control (internal temperature of reactor typically reaches $27 \pm 5^\circ\text{C}$ overnight). The power of the light source can be varied with four levels of intensity control.

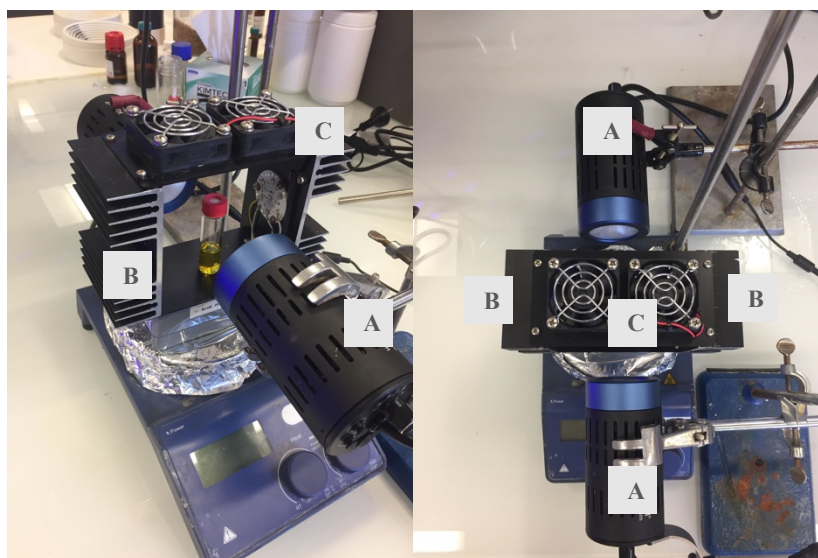


Figure S1. Photoreaction assembly; a) Kessil 440 nm LED light; b) heat sinks; c) PC cooling fans.

^1H NMR, ^{13}C NMR and ^{19}F NMR spectra were recorded on Varian MR-400 (400 MHz), Agilent DD2 (500 MHz) and Varian INOVA (600 MHz). Chemical shifts are expressed in parts per million (PPM) and are referenced to the internal solvent peaks.

Mass spectrometry

Accurate mass measurement was performed by the Monash Analytical Platform using an Agilent 6220 Accurate Mass LC-TOF system with Agilent 1200 Series HPLC. MS was fitted with the Agilent Multimode Source (ESI/APCI). Reference mass correction used for all accurate mass work was Purine/HP0921 mix. **Scan** from 100 m/z to 3000 m/z; **Source Conditions:** 8 L/min N_2 , 325 degrees drying gas temp. Capillary voltage – 3000V. Samples were directly injected into the source using a syringe pump (KD Scientific Syringe pump running at 600uL/h).

Transient absorption (TA) spectroscopy

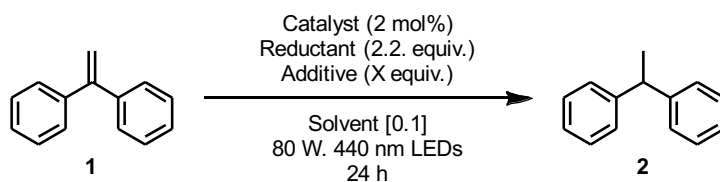
Nanosecond transient absorption measurements were performed using the 355 nm output from a nanosecond optical parametric oscillator (Eskpla NT340) as the excitation source (pump) (~5 ns pulses at 10 Hz). A Xenon lamp (ILC Cerman) was used as probe with a monochromator (Acton SpectraPro 300i), a long-pass filter (370 nm), photomultiplier tube (Hamamatsu R928), and digital oscilloscope (Teledyne/LeCroy WaveSurfer 10). The wavelengths detected were 380 nm and 540 nm.

Fluorescent quenching experiments

Steady-state luminescent spectra were recorded using an Agilent Cary Eclipse Fluorescence Spectrophotometer. Samples were excited at 440 nm, slit widths were 5 nm and the area under the spectra were used for determining the Stern-Volmer quenching values.

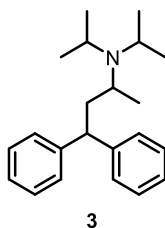

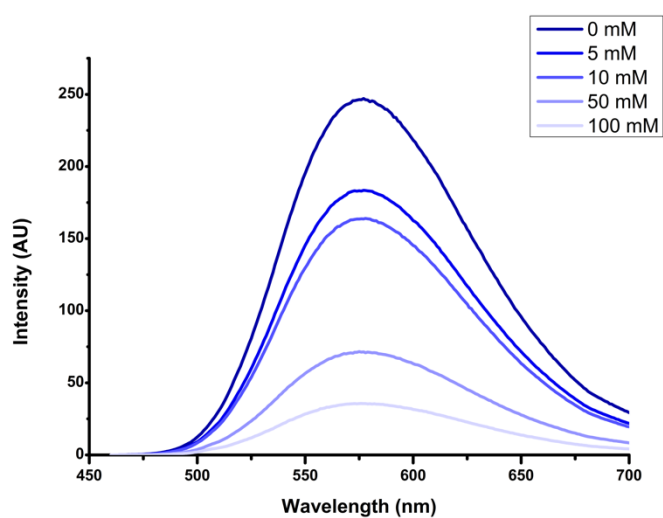
Mechanistic Studies

Stern-Volmer Fluorescence Quenching Studies

Quenching of $[\text{Ir1}]^{**}$

A standard solution of $[\text{Ir}(\text{ppy})_2(\text{dtb-bpy})]\text{PF}_6$ in methanol (0.1 mM) was prepared in a 10 mL volumetric flask. An aliquot (2 mL) was transferred to a septum capped quartz cuvette. A solution containing an appropriate amount of quencher in methanol (1 mL) was added. The sample was sparged with N_2 for 1 min prior to fluorescence measurement being taken.

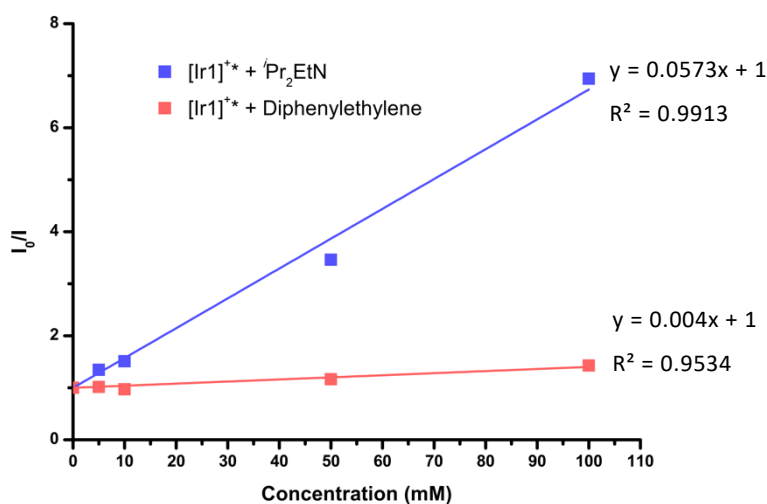

Quenching of $[\text{Ir}2]^{0*}$:

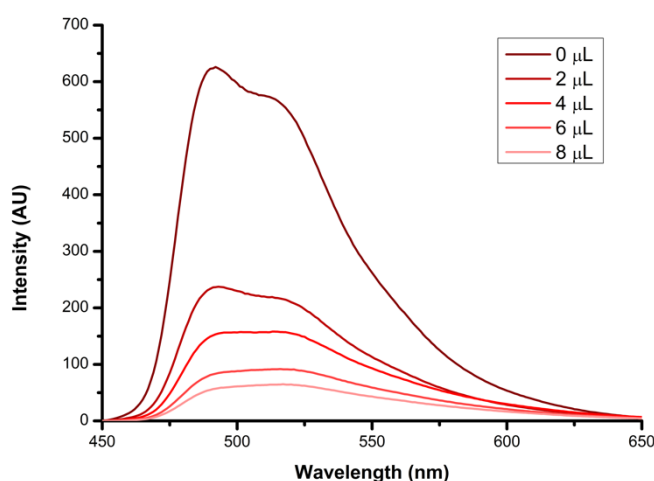
Emission from $[\text{Ir}2]^{0}$ in the absence of the quencher:*

A standard solution containing $^i\text{Pr}_2\text{EtN}$ (50 mM) and $[\text{Ir}(\text{ppy})_2(\text{dtb-bpy})]\text{PF}_6$ (0.1 mM) in methanol was prepared in a 10 mL volumetric flask. An aliquot (3 mL) was transferred to a septum capped quartz cuvette, degassed for 1 min with N_2 and irradiated for 10 min with 14W, 447 nm blue LED light, under a positive pressure of N_2 . Fluorescence measurement was taken immediately after the sample was removed from the blue LED reactor.

Quenching studies:

Neat diphenylethylene was added, in 2 μL increments, to the quartz cuvette via an air-tight microsyringe. Following each incremental addition, the sample was sparged with N_2 for 1 minute and irradiated with 14W, 447 nm blue LED light under a positive pressure of N_2 for 10 minutes. Each time the fluorescence measurement was taken immediately after the sample was removed from the blue LED reactor.

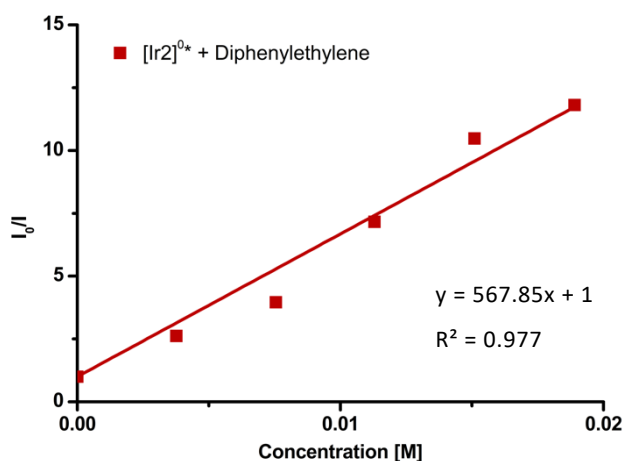

Transient Absorption Spectroscopy

Samples for transient-absorption studies were prepared in the following manner:

A standard solution containing $^i\text{Pr}_2\text{EtN}$ (50 mM) and $[\text{Ir}(\text{ppy})_2(\text{dtb-bpy})]\text{PF}_6$ (0.1 mM) in methanol was prepared in a 10 mL volumetric flask. An aliquot (3 mL) was transferred to a septum capped quartz cuvette. Neat diphenylethylene (53 μL) was added to the cuvette via an air-tight microsyringe, and the sample was sparged with nitrogen for 1 minute, and irradiated with 14W, 447 nm blue LED light under a positive pressure of N_2 for 10 minutes. The transient absorption measurement was then recorded immediately after the sample was removed from the blue LED reactor.

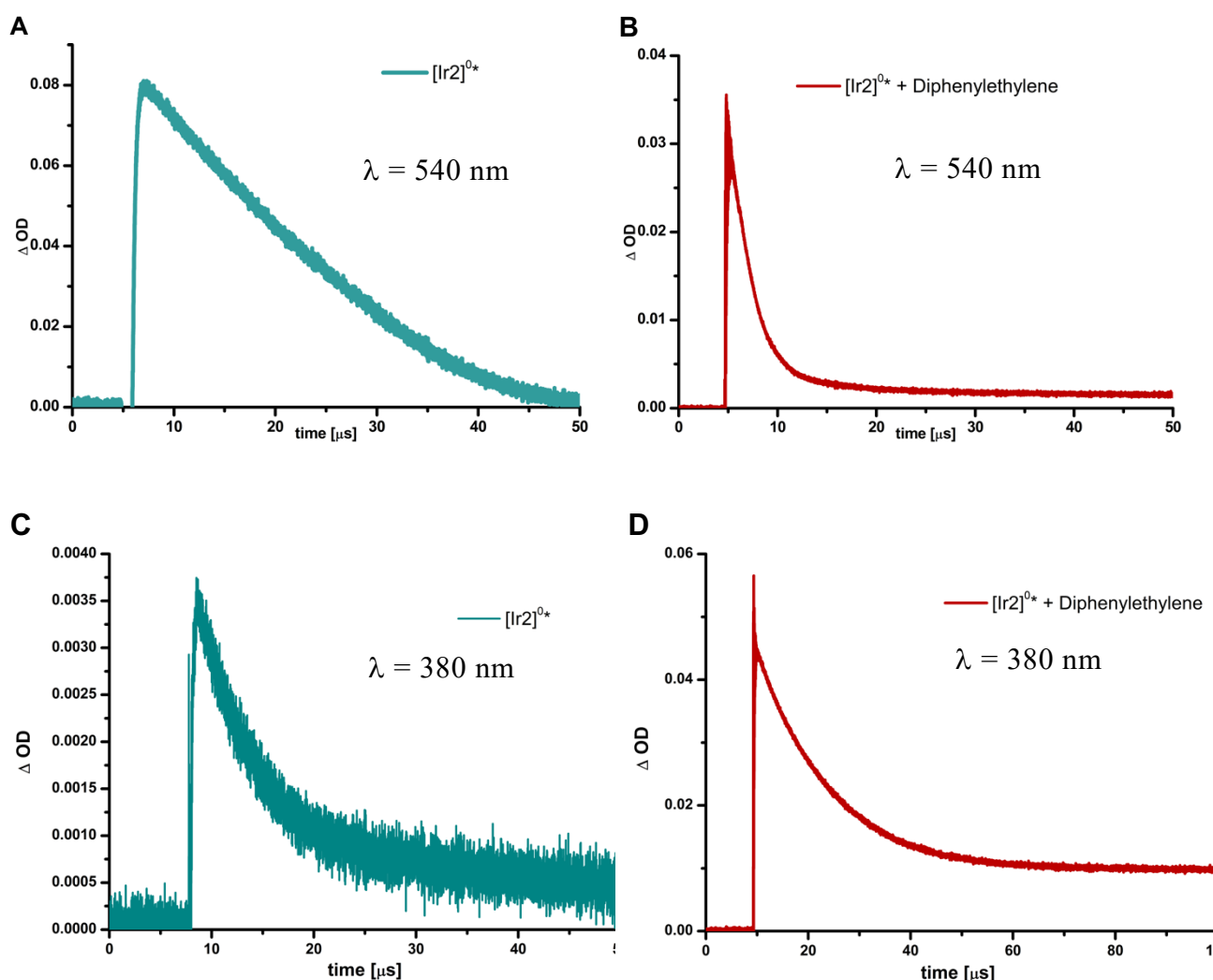

Radical Clock Experiment

In polar solvents, a radical anion derived from diarylethylene (**Int-A**) is quenched by a proton donor resulting in a formation of a neutral radical at the more stabilized benzylic position (**Int-B**).² To enable detection of **Int-B** in our reaction, we subjected (1-cyclopropylvinyl)benzene (**39**) to the optimized photoredox hydrogenation protocol. The tertiary benzylic radical **Int-B39** has been reported to undergo a relatively slow ($k \approx 4 \times 10^5 \text{ s}^{-1}$)³ ring opening rearrangement resulting in the formation of open chained product **40**. Thus, it was hypothesized that there should be competition between formation of **40** and **41** if **Int-B39** is an intermediate along the main reaction pathway.

As shown in Figure S5 below, rearranged open-chain olefin **40**, the reduced unrearranged **41** as well as and the Markovnikov methanol adduct **42** were detected in the ¹H NMR spectrum of the crude reaction mixture (Figure S5 below), in the ratio of approx. **40** : **41** : **42** = 1 : 1.6 : 0.4. All three products derive from **Int-B39**. Oxidation of the benzylic radicals to a carbocations, followed by a nucleophilic attack by solvent is known,^{2, 4} and yet it is a minor product here despite high nucleophilicity of the C-C bond in the cyclopropane ring.

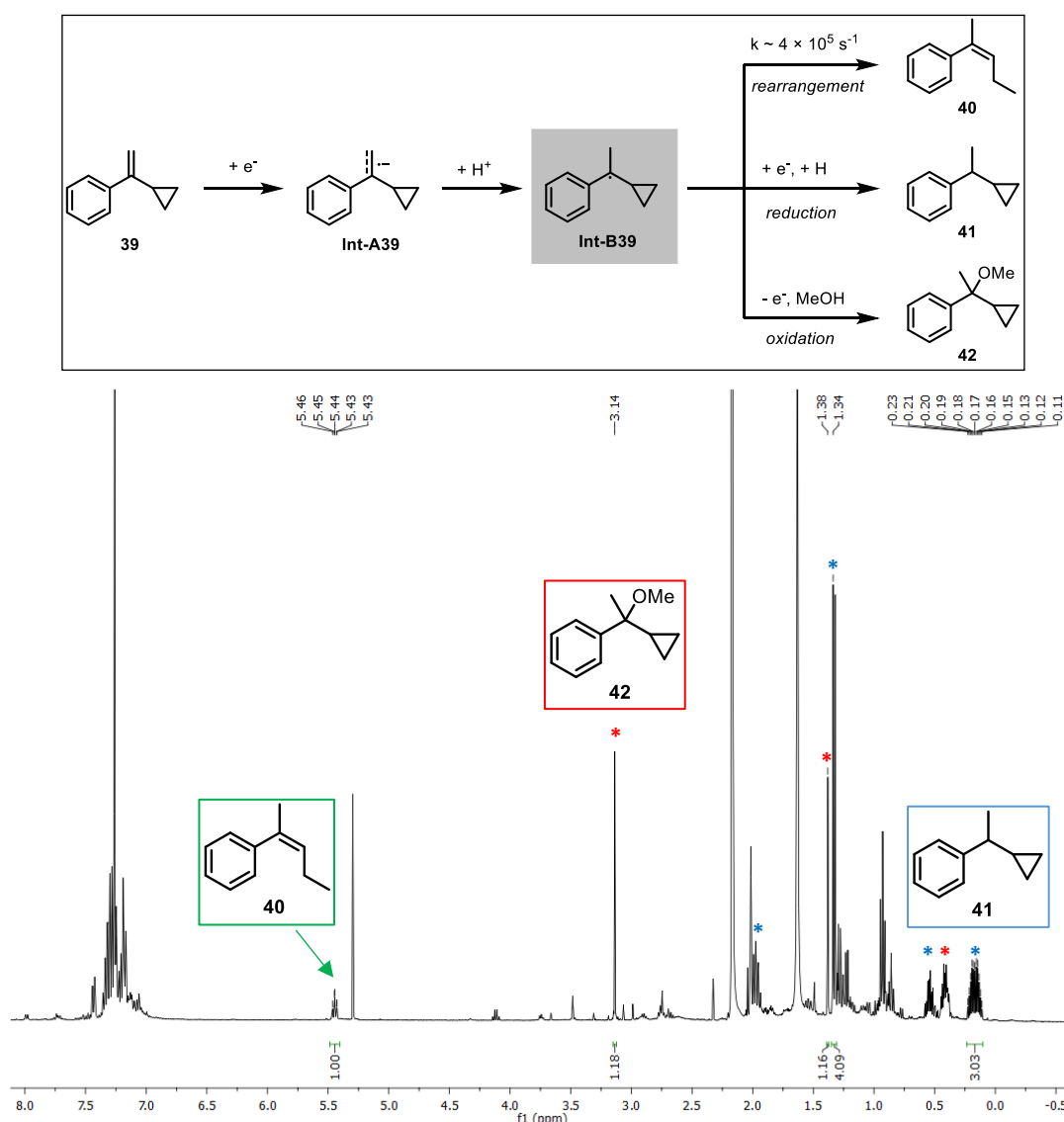

Reactivity of Int-B

To determine how **Int-B** converts into fully hydrogenated product, we conducted deuterium labelling experiments using substrate **16a**. Two plausible pathways were identified. Path A involves a hydrogen atom transfer (HAT) from the $^i\text{Pr}_2\text{EtN}^{\bullet+}$ radical cation, a mechanism previously reported for transfer hydrogenation of ketimines under similar reaction conditions,⁸ or the ammonium formate complex.⁹ In path B, a sequential single electron transfer (SET) step generates an anionic **Int-C**, which is quenched by protic solvent or formic acid. Alternatively, **Int-A** could undergo direct HAT from the ammonium formate complex to give **Int-C** in one step.

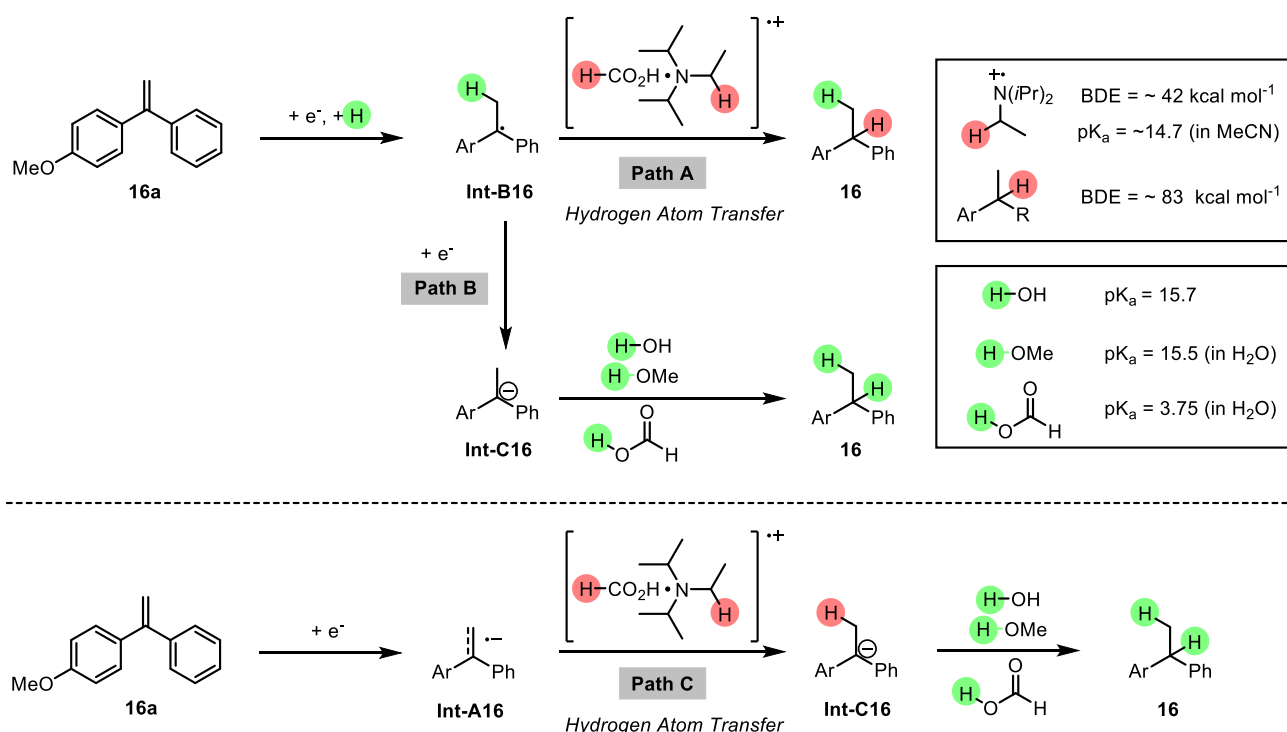
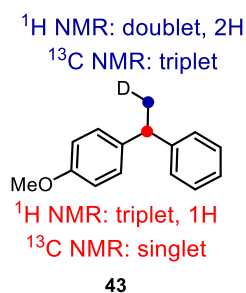
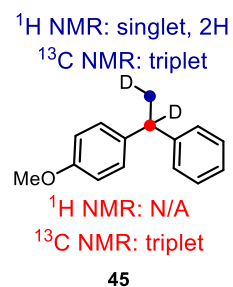
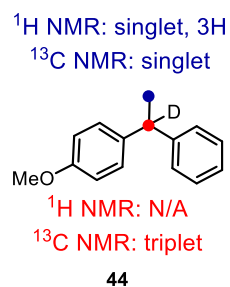

Replacing $^i\text{Pr}_2\text{EtN}$ with $\text{d}_{15}\text{-NEt}_3$ was not informative, as only traces of the reduced product could be detected in the ^1H NMR spectrum of the crude reaction mixture. Consequently, $\text{d}_4\text{-MeOH}$, D_2O and HCO_2D were used as solvents with $^i\text{Pr}_2\text{EtN}$ as the reductive quencher. Mass spectrometry of the crude reaction mixture revealed that both mono-deuterated products, **43** and/or **44** (m/z = 214.12) and bis-deuterated product **45** (m/z = 215.13) were generated under these reaction conditions. Reduced product **16** with no deuterium incorporation was not detected in the ^1H NMR spectrum of the crude reaction mixture.

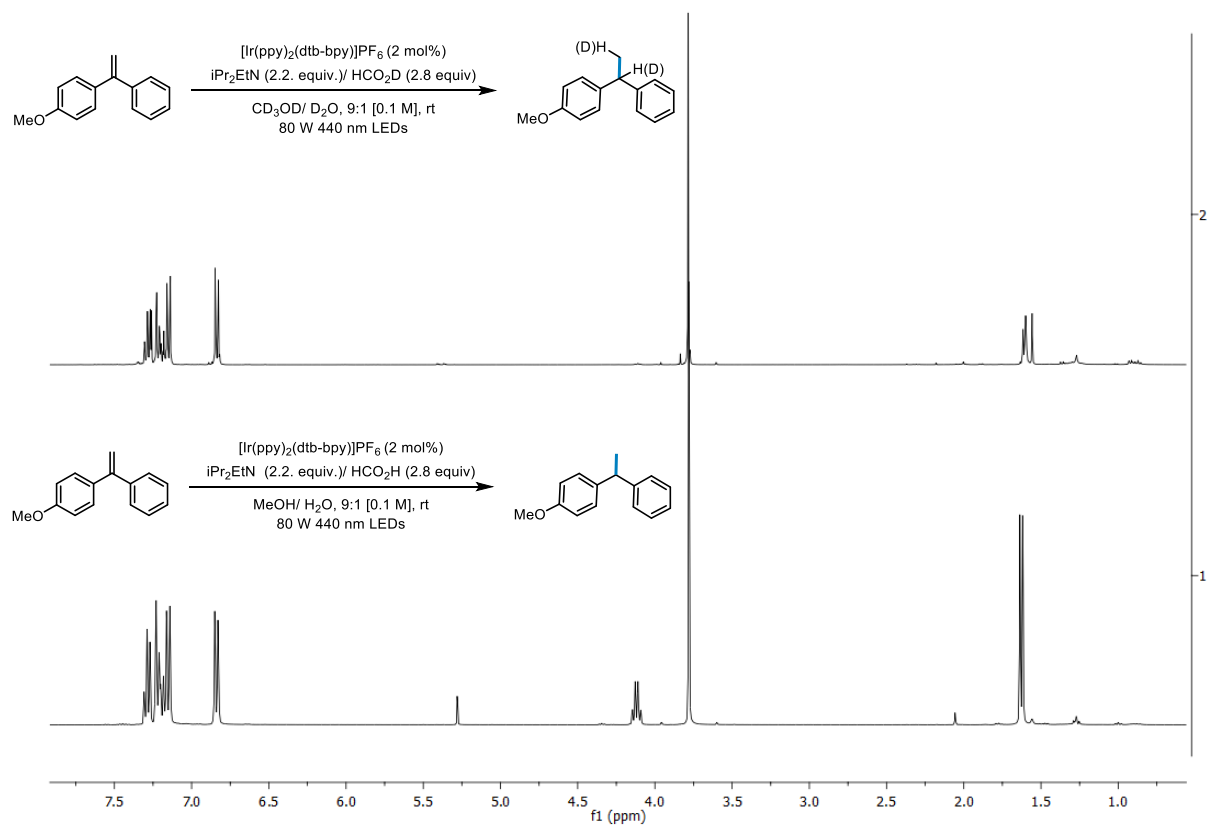

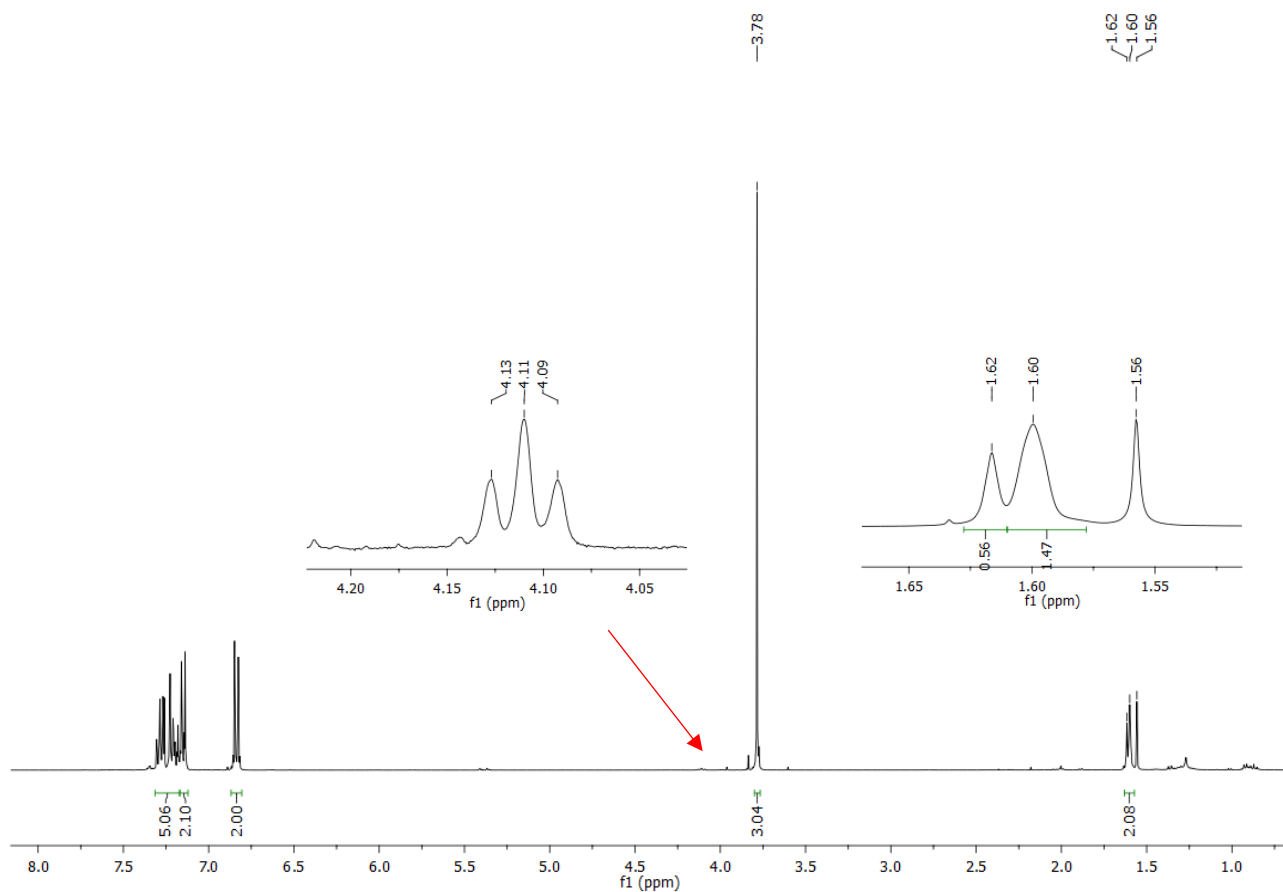

Baseline triplet at 4.11 ppm (Figure S9) suggested that compound **43** formed in trace quantities. This indicated that resonances at 1.62 ppm and 1.60 ppm, are both singlets corresponding to products **44** and **45**. ^{13}C NMR spectrum (Figure S10) confirmed that resonances at 44.5 ppm and 22.2 ppm both split into a singlet and a triplet, confirming incomplete deuterium incorporation at both distal and proximal positions, and ^1H - ^{13}C HSQC spectrum revealed 2D correlation between the major singlet in ^1H NMR spectrum at 1.60 ppm and a triplet in ^{13}C NMR spectrum at 21.8 ppm, verifying that bis-deuterated product **45** is the major product from this reaction.

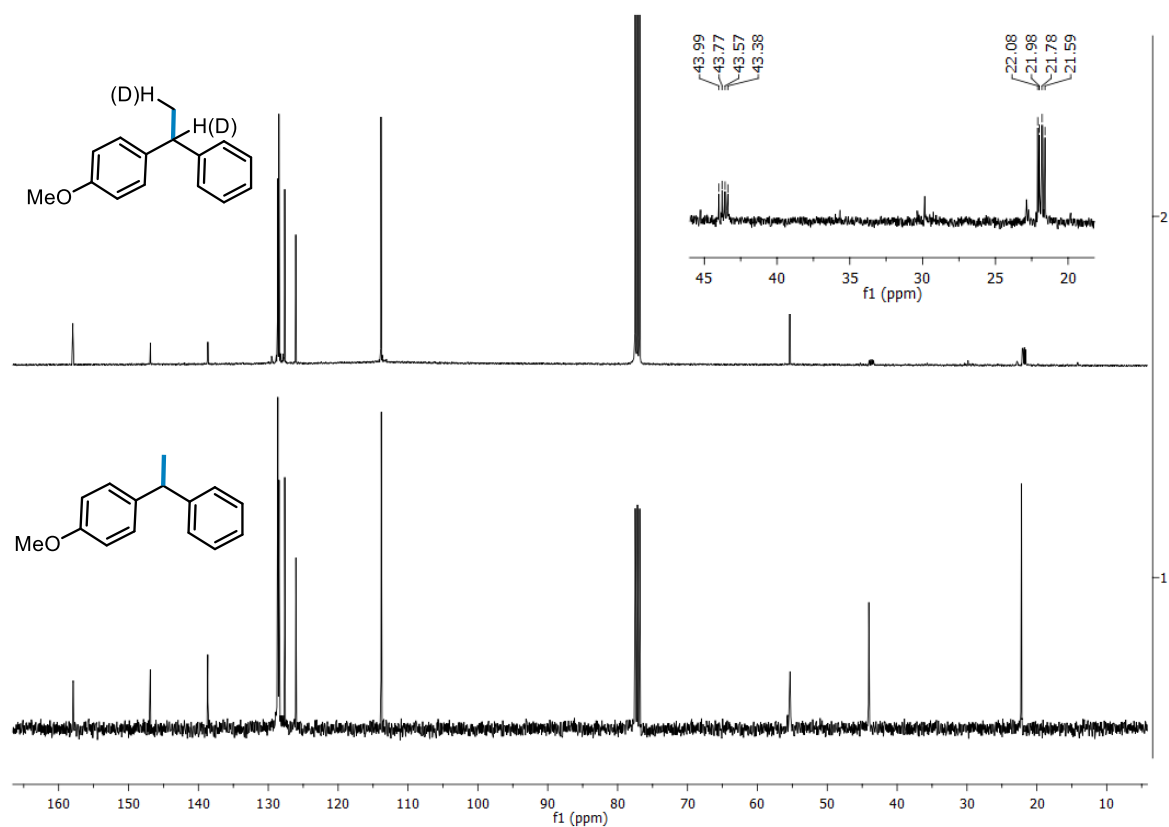

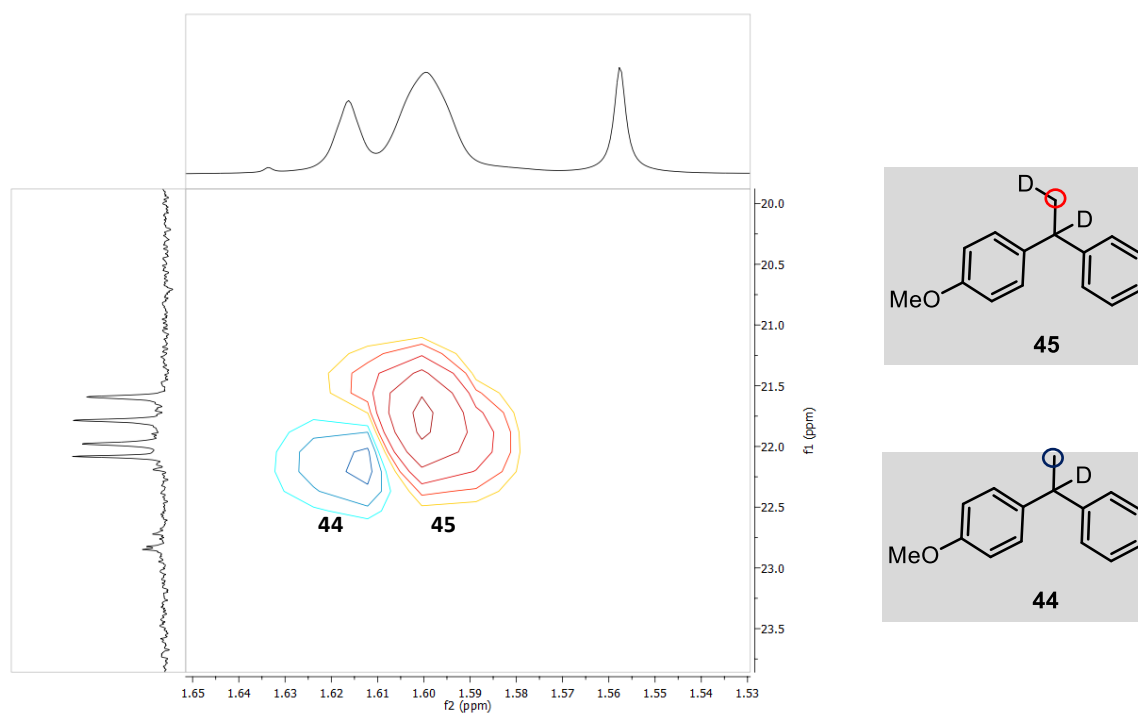

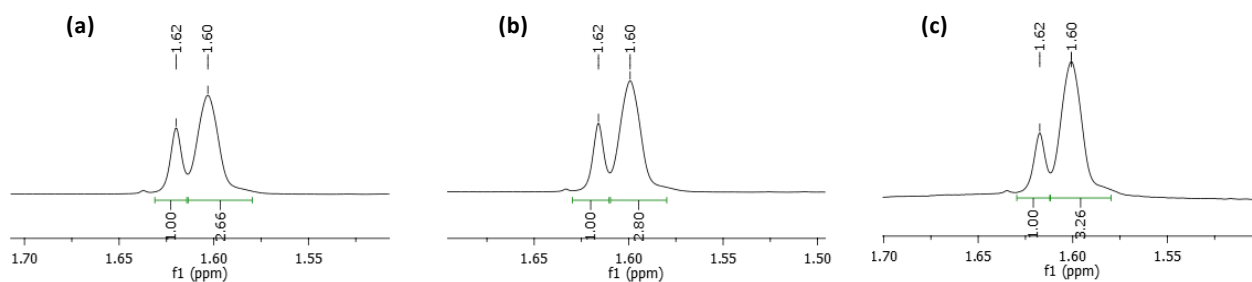


Figure S12: Comparison of partial ^1H NMR spectra (CDCl_3 , 400 MHz) of the crude reaction mixtures run with MeOD-d_4 and D_2O and (a) HCOOH (b) HCOOD and (c) DCOOH . The proportion of bis-deuterated product slightly increases from (a) to (b) to (c), suggesting that the ammonium formate complex can act as a HAT reagent (path c).

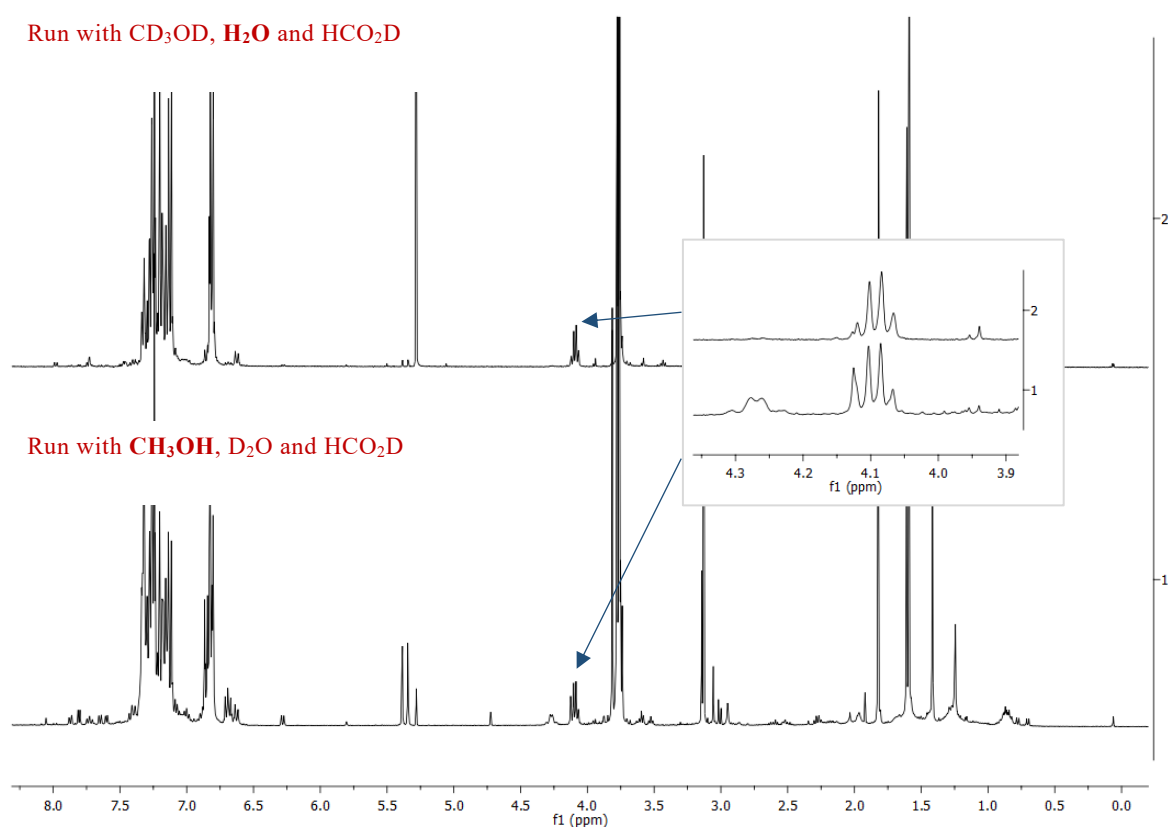

The characteristic quartet around 4.1 ppm shows the presence of non-deuterated reduced product **16**, signifying that solvents are the major sources of protons in this reaction.

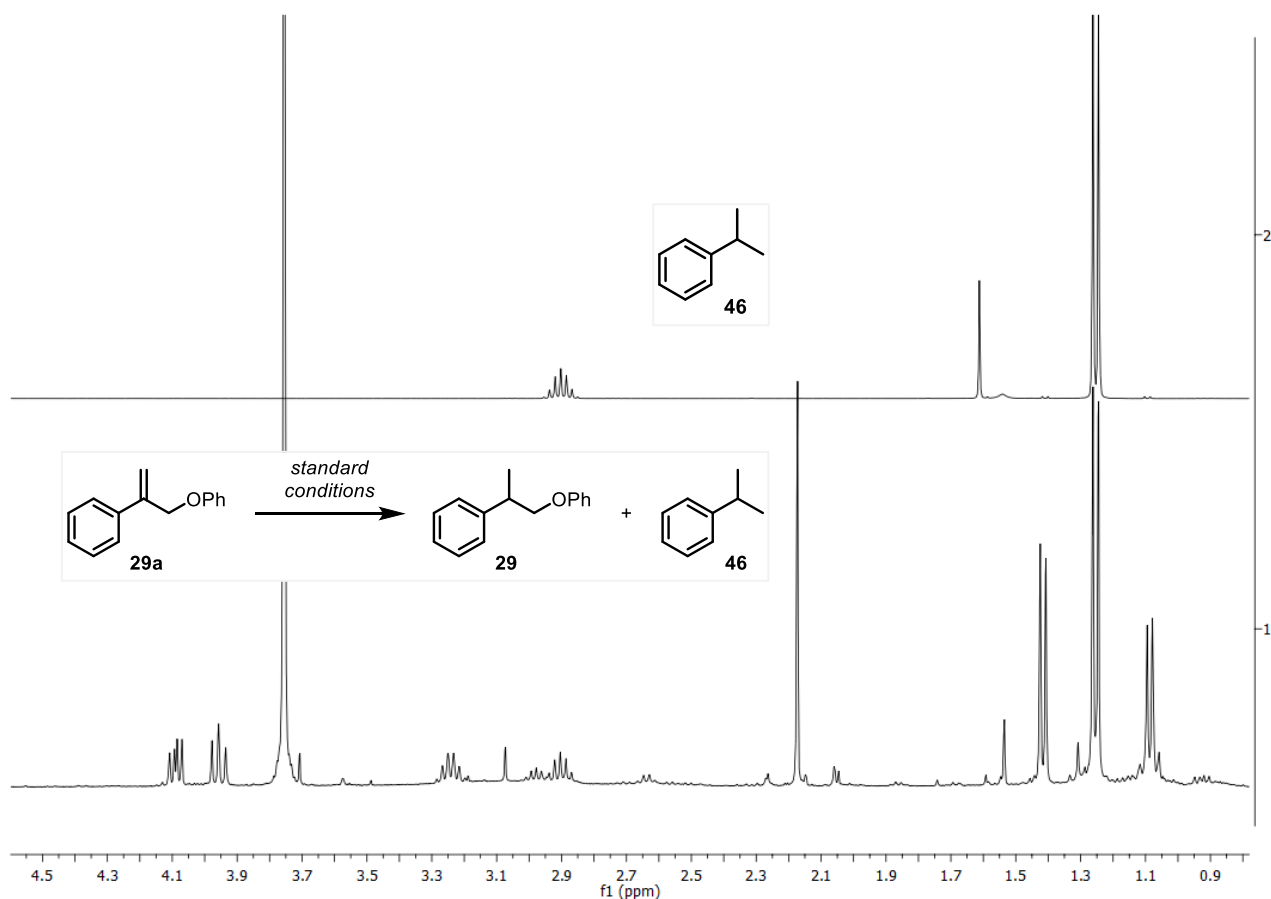

The presence of cumene **46** is consistent with the formation of **Int-C** and elimination of the phenoxy group, followed by reduction of the resulting α -methyl styrene.

Addition to Ketones: Mechanistic Hypothesis

We hypothesize that product **48** arises from the direct nucleophilic addition of Int-A to a carbonyl group, to generate a benzylic radical. As established previously, the resulting benzylic radical is further reduced to carbanion, which could be quenched by the amine radical cation, or be protonated by traces of water in the solvent. No side products were observed in the ^1H NMR of the crude reaction mixture, and we did not observe any difunctionalisation adducts. The reaction was slow and did not go to completion even after extended reaction times (60 hours).

Alternatively, product **48** could also arise from the radical addition to the carbonyl group, however this is known to be difficult, as the resulting alkoxyl radical undergoes facile β -fragmentation.¹¹

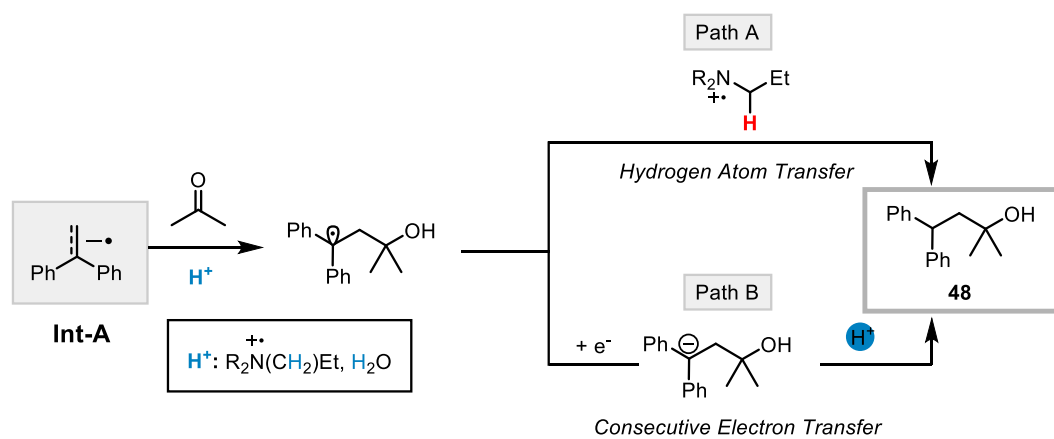
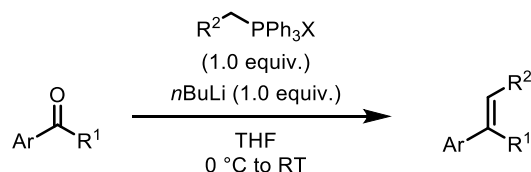

Synthesis and Characterization

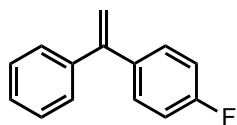
Preparation of styrene derivatives

Method A:¹²



A solution of *n*BuLi in hexanes (C = 1.6 M, 4.0 mmol, 1.0 equiv.) was added dropwise, at 0 °C, to a solution of a Wittig salt (4.0 mmol, 1.0 equiv.) in dry THF (30 mL). The reaction mixture was stirred at 0 °C for 30 minutes. A solution of the carbonyl compound (4.0 mmol, 1.0 equiv.) in dry THF (10 mL) was added dropwise at 0 °C, and the reaction mixture was stirred at room temperature overnight. It was then diluted with brine and extracted with EtOAc (3 × 40 mL). The combined organic extracts were washed with brine (3×) and dried with MgSO₄. The solvent was removed under reduced pressure and the residue was purified by flash chromatography on silica eluting with 1 - 5% EtOAc/*n*hexane to yield the desired product.

General procedure for the photoredox catalyzed hydrogenation reaction



Alkene (0.1 mmol, 1.0 equiv.) and photocatalyst (0.002 mmol, 2 mol%) were placed in a pressure relief sample vial and taken up in 9:1 methanol / water (1 mL). The reaction mixture was sparged with N_2 for 1 minute. *N,N*-Diisopropylethylamine (0.22 mmol, 2.2 equiv.) and formic acid (0.28 mmol, 2.8 equiv.) were added via an air tight syringe under a positive pressure of nitrogen, and the solution was sparged with N_2 for 30 seconds. The cap was wrapped in parafilm and the reaction mixture was stirred for 24 hours at room temperature, whilst being irradiated with 80W blue LEDs. The reaction mixture was diluted with CH_2Cl_2 and washed with saturated aqueous NaHCO_3 solution (1 \times 10 mL). The aqueous layer was extracted with CH_2Cl_2 (2 \times 10 mL) and the combined organic extracts were dried with MgSO_4 . The solvent was removed under reduced pressure and the residue purified by preparative TLC eluting with 1 - 5% $\text{EtOAc}/n\text{hexane}$ to yield the desired product.

Alkene (0.1 mmol, 1.0 equiv.), photocatalyst (0.002 mmol, 2 mol%) and amine **47** (0.2 mmol, 2.0 equiv.) were placed in a pressure relief sample vial and taken up in acetone (1 mL). The reaction mixture was sparged with N_2 for 1 minute. The cap was wrapped in parafilm and the reaction mixture was stirred for 60 hours at room temperature, whilst being irradiated with 80W blue LEDs.
