General Details. All reactions were done in flame-dried glassware under nitrogen unless otherwise noted. All reaction mixtures were magnetically stirred. Removal of solvents was achieved via rotary evaporation at 10 mm Hg.

Materials. Commercial grade reagents and solvents were used without further purification except as indicated below. Dichloromethane, diethyl ether, and tetrahydrofuran were purified using alumina drying columns. 4-Pentenal (**6**) was distilled under vacuum before use.

Compounds Previously Reported in the Literature. Compounds **5-19** and **34-35** were prepared according to Quintal, M. M.; Closser, K. D.; Shea, K. M. *Org. Lett.* **2004**, *6*, 4949-4952. Terminal alkyne **21** and the one carbon larger alkyne prepared from **29** (Scheme 7 – step #1) were prepared according to Denmark, S. E.; Yang, S.-M. *J. Am. Chem. Soc.* **2002**, *124*, 2102-2103. THP-protected alcohol **22** and the one carbon larger protected alcohol prepared beginning with **29** (Scheme 7 – step #2) were prepared according to Marino, J. P.; Nguyen, H. N. *J. Org. Chem.* **2002**, *67*, 6291-6296. Compounds **58-59** were prepared according to Shea, K. M.; Closser, K. D.; Quintal, M. M. *J. Org. Chem.* **2005**, *70*, 9088-9091.

General Procedure for the Synthesis of Secondary Alcohols via Acetylide Addition to 4-Pentenal: 12-(Tetrahydro-2H-pyran-2-yloxy)dodec-1-en-6-yn-5-ol (23). A 100-mL two-necked flask, equipped with a rubber septum and gas inlet adapter was charged with ethyl magnesium bromide (1 M in THF, 11.5 mL, 11.5 mmol, 1.5 equiv) and cooled at 0 °C. Meanwhile, 5 mL THF was added to a 25-mL pear flask containing alkyne **22** (1.50 g, 7.61 mmol, 1.0 equiv) and the alkyne solution was transferred via cannula into the reaction flask followed by a 1 mL THF rinse. The gas inlet adapter was replaced with a reflux condenser and the reaction mixture was heated at reflux for two hours. Another

25-mL pear flask was charged with 4-pentenal (1.21 mL, 12.2 mmol, 1.6 equiv) and 15 mL THF. The reaction flask was cooled at 0 °C and the aldehyde solution was cannulated into the reaction flask. The reaction was warmed to room temperature and stirred overnight. The reaction was quenched by the addition of 10 mL saturated ammonium chloride. The aqueous layer was extracted twice with ether and the combined organic layers were washed twice with brine, dried with magnesium sulfate, filtered, and concentrated to yield 2.33 g (109%) of crude product. This was applied neat to a 175 g silica gel column eluted with 20-35% diethyl ether in petroleum ether to afford 1.65 g (77%) of **23** as a yellow oil: IR (neat) 3431, 3076, 2941, 2864, 2230, 1641 cm⁻¹; ¹H NMR (400 MHz, CDCl₃) δ 5.83 (ddt, *J* = 16.8, 10.2, 6.8 Hz, 1H), 5.05 (dq, *J* = 17.2, 1.7 Hz, 1H), 4.97 (dm, *J* = 10.25, 1H), 4.56 (m, 1H), 4.36 (m, 1H), 3.85 (m, 1H), 3.73 (dt, *J* = 9.5, 6.8 Hz, 1H), 3.49 (m, 1H), 3.38 (dt, *J* = 9.5, 6.6 Hz, 1H), 2.21 (m, 4H), 1.88 (br s, 1H), 1.84-1.41 (m, 13H), 1.2 (m, 1H); ¹³C NMR (100 MHz, CDCl₃) δ 137.9, 115.0, 98.8, 85.1, 81.4, 67.4, 62.2, 61.8, 37.2, 30.7, 29.6, 29.2, 28.5, 25.52, 25.47, 19.6, 18.6; HRMS-FAB *m/z* [M+H]⁺ calcd for C₁₇H₂₉O₃ 281.2117, found 281.2131.

13-(Tetrahydro-2H-pyran-2-yloxy)tridec-1-en-6-yn-5-ol. According to the general procedure, the alkyne resulting from isomerization and THP protection of **29** (Scheme 7) (2.80 g, 13.3 mmol, 1.0 equiv) was placed in THF (8 mL) and reacted with ethyl magnesium bromide (1M in THF, 20 mL, 20 mmol, 1.5 equiv) and 4-pentenal (1.79 g, 21.3 mmol, 1.6 equiv) in 32 mL of THF to afford 4.49 g (114%) of crude product that was applied directly to a 340 g silica gel column eluted with 15-50% diethyl ether in petroleum ether. This yielded 2.08 g (53%) of the desired alcohol as a yellow oil: ¹IR (neat) 3450, 3075, 2940, 2857, 1641 cm⁻¹; ¹H NMR (400 MHz, CDCl₃) δ 5.82 (ddt, *J* =

General Procedure for the Synthesis of Methyl Ethers via Methylation and THP Deprotection: 8-Methoxydodec-11-en-6-yn-1-ol (24). A 50-mL two-necked flask was equipped with a rubber septum and gas inlet adapter and charged with sodium hydride (60% in mineral oil, 0.47 g, 11.8 mmol, 3.0 equiv) and 5 mL THF. The cloudy gray suspension was cooled at 0 °C and iodomethane (1.47 mL, 23.5 mmol, 6.0 equiv) was added. To a 25-mL pear flask containing enyne **23** (1.10 g, 3.92 mmol, 1.0 equiv) was added 4 mL THF. The enyne solution was cannulated into the reaction flask followed by a 1 mL THF rinse, and the reaction mixture was warmed to room temperature. After 30 min, the reaction was quenched with 20 mL saturated sodium thiosulfate. The aqueous layer was extracted twice with ether. The combined organic layers were washed with brine, dried with magnesium sulfate, filtered, and concentrated to yield 1.08 g (94%) of the desired methyl ether as a yellow oil: IR (neat) 3076, 3932, 2860, 2228, 1641 cm^{-1} ; ^1H NMR (400 MHz, CDCl_3) δ 5.80 (ddt, J = 16.8, 10.2, 6.6 Hz, 1H), 5.03 (dm, J = 16.8 Hz, 1H), 4.96 (dm, J = 10.2 Hz, 1H), 4.56 (m, 1H), 3.94-3.83 (m, 2H), 3.73 (dt, J = 9.5, 6.8 Hz, 1H), 3.48 (m, 1H), 3.38 (m, 1H), 3.38 (s, 3H), 2.25-2.16 (m, 4H), 1.84-1.42 (m, 14H); ^{13}C NMR (100 MHz, CDCl_3) δ 137.8, 114.9, 98.7, 86.3, 78.8, 70.7, 67.3, 62.1,

To a 100-mL round-bottomed flask containing the ether synthesized in the previous step (977 mg, 3.32 mmol, 1.0 equiv) was added absolute ethanol (27 mL) and pyridinium *p*-toluenesulfonate (58 mg, 0.23 mmol, 0.1 equiv). The reaction flask was equipped with a reflux condenser and gas inlet adapter and heated at 55 °C overnight. The reaction mixture was concentrated to yield 826 mg (118%) of a yellow oil which was deposited on 1.6 g silica gel and added to a 60 g silica gel column eluted with 25% diethyl ether in petroleum ether to afford 468 mg (67%) of enyne **24** as a yellow oil: IR (neat) 3392, 3076, 2936, 2862, 2228, 1641 cm⁻¹; ¹H NMR (400 MHz, CDCl₃) δ 5.80 (ddt, *J* = 16.8, 10.2, 6.6 Hz, 1H), 5.03 (dq, *J* = 16.8, 1.8 Hz, 1H), 4.96 (dm, *J* = 9.9 Hz, 1H), 3.91 (tt, *J* = 6.6, 1.8 Hz, 1H), 3.64 (t, *J* = 6.6 Hz, 2H), 3.37 (s, 3H), 2.24 (dt, *J* = 7.0, 1.8, 2H), 2.19 (m, 2H), 1.76 (m, 2H), 1.61-1.41 (m, 6H), 1.32 (br s, 1H); ¹³C NMR (100 MHz, CDCl₃) δ 137.8, 115.0, 86.5, 78.6, 70.8, 62.2, 56.1, 34.9, 32.1, 29.4, 28.5, 25.0, 18.6; HRMS-FAB m/z [M+H]⁺ calcd for C₁₃H₂₃O₂ 211.1698, found 211.1709.

9-Methoxytridec-12-en-7-yn-1-ol (30). According to the general procedure, combination of THF (10 mL), sodium hydride (60% in mineral oil, 0.82 g, 20.5 mmol, 3.0 equiv), iodomethane (2.55 mL, 41.0 mmol, 6.0 equiv), and the enyne available in three steps from **29** (Scheme 7) (2.01 g, 6.83 mmol, 1.0 equiv) in 5 mL THF furnished 2.13 g (101%) of the target ether as a yellow oil: IR (neat) 3076, 2833, 2855, 2818, 1641 cm⁻¹; ¹H NMR (400 MHz, CDCl₃) δ 5.81 (ddt, *J* = 16.8, 10.2, 6.6 Hz, 1H), 5.13 (dq, *J* = 17.2, 1.8 Hz, 1H), 4.96 (dm, *J* = 10.2 Hz, 1H), 4.56 (m, 1H), 3.92 (tt, *J* = 6.6, 1.8 Hz, 1H), 3.86 (m, 1H), 3.73 (dt, *J* = 9.5, 6.8 Hz, 1H), 3.49 (m, 1H), 3.37 (s, 3H), 2.20 (m,

Reaction of the ether prepared in the previous step (1.95 g, 6.32 mmol, 1.0 equiv), absolute ethanol (50 mL), and pyridinium *p*-toluenesulfonate (159 mg, 0.63 mmol, 0.1 equiv) yielded 1.39 g of crude product which was deposited on 3.7 g of silica gel and added to a 140 g silica gel column eluted with 30% diethyl ether in petroleum ether. General Procedure for the Synthesis of Cobalt-Complexed Alkynes: 8-Methoxydodec-11-en-6-yn-1-ol dicobalt hexacarbonyl complex (25). A 25-mL pear flask containing enyne **24** (159 mg, 0.76 mmol, 1.0 equiv) was equipped with a rubber septum and gas inlet needle. Dichloromethane (2 mL) was added, followed by dicobalt octacarbonyl (310 mg, 0.907 mmol, 1.2 equiv). The reaction was stirred for 30 min, and a second portion of dicobalt octacarbonyl (103 mg, 0.302 mmol, 0.4 equiv) was added. After another 30 minutes the reaction mixture was applied directly to a 38 g silica gel column eluted with 25-50% diethyl ether in petroleum ether to afford 334 mg (89%) of

9-Methoxytridec-12-en-7-yn-1-ol dicobalt hexacarbonyl complex (31). According to the general procedure, combination of alkyne **30** (103 mg, 0.46 mmol, 1.0 equiv), dichloromethane (1 mL), dicobalt octacarbonyl (188 mg, 0.55 mmol, 1.2 equiv then 63 mg, 0.18 mmol, 0.4 equiv) followed by direct addition to a 23 g silica gel column and elution with 25% diethyl ether in petroleum ether yielded 234 mg (100%) of **31** as a dark red oil: IR (neat) 3314, 3000, 2932, 2859, 2089, 2046, 2018 cm^{-1} ; ^1H NMR (400 MHz, CDCl_3) δ 5.83 (ddt, J = 17.0, 10.4, 6.6 Hz, 1H), 5.05 (m, 2H), 4.26 (dd, J = 9.1, 3.3 Hz, 1H), 3.66 (m, 2H), 3.51 (s, 3H), 2.82 (m, 2H), 2.29 (m, 2H), 1.79 (m, 2H), 1.60 (m, 4H), 1.56 (m, 4H), 1.25 (m, 1H); ^{13}C NMR (100 MHz, CDCl_3) δ 200.1, 137.9, 115.4, 98.3, 81.1, 62.8, 62.7, 58.7, 37.1, 34.0, 32.7, 32.0, 30.3, 29.5, 25.7.

N-(6-methoxydec-9-en-4-ynyl)-4-methylbenzenesulfonamide dicobalt hexacarbonyl complex (39). According to the general procedure, combination of the amine resulting from Mitsunobu reaction of alcohol **10** (92 mg, 0.28 mmol, 1.0 equiv), dichloromethane (2 mL), and dicobalt octacarbonyl (115 mg, 0.34 mmol, 1.2 equiv then 38 mg, 0.11 mmol, 0.4 equiv) followed by direct addition to an 18 g silica gel column and eluted with 25% diethyl ether in petroleum ether yielded 160 mg (90%) of **39** as a dark red oil: ^1H NMR (400 MHz, CDCl_3) δ 7.70 (d, J = 8.4 Hz, 2H), 7.30 (d, J = 7.7 Hz,

***N*-(7-Methoxyundec-10-en-5-ynyl)-4-methylbenzenesulfonamide dicobalt hexacarbonyl complex (43).** According to the general procedure, combination of the amine resulting from Mitsunobu reaction of alcohol **15** (100 mg, 0.286 mmol, 1.0 equiv), dichloromethane (1 mL), and dicobalt octacarbonyl (117 mg, 0.343 mmol, 1.2 equiv then 39 mg, 0.114 mmol, 0.4 equiv) followed by direct addition to an 18 g silica gel column and eluted with 25% diethyl ether in petroleum ether yielded 158 mg (87%) of **43** as a dark red oil: IR (neat) 3277, 3065, 2978, 2825, 2359, 2088, 2046, 2016, 1748, 1715, 1641, 1599 cm^{-1} ; ^1H NMR (400 MHz, CDCl_3) δ 7.74 (d, $J = 8.1$ Hz, 2H), 7.31 (d, $J = 8.1$ Hz, 2H), 5.89-5.79 (m, 1H), 5.09-5.01 (m, 2H), 4.40 (br s, 1H), 4.26-4.18 (m, 1H), 3.50 (s, 3H), 3.04-2.96 (m, 2H), 2.82-2.74 (m, 2H), 2.42 (s, 3H), 2.38-2.20 (m, 2H), 1.88-1.57 (m, 6H); ^{13}C NMR (100 MHz, CDCl_3) δ 200.0, 143.5, 137.8, 136.9, 129.8, 127.2, 115.5, 98.3, 81.1, 58.8, 53.6, 42.9, 37.1, 33.5, 30.4, 29.6, 28.8, 21.6.

***N*-(8-methoxydodec-11-en-6-ynyl)-4-methylbenzenesulfonamide dicobalt hexacarbonyl complex (47).** According to the general procedure, combination of the amine resulting from Mitsunobu reaction of alcohol **24** (164 mg, 0.47 mmol, 1.0 equiv), dichloromethane (1.5 mL), and dicobalt octacarbonyl (192 mg, 0.564 mmol, 1.2 equiv then 64 mg, 0.188 mmol, 0.4 equiv) followed by direct addition to a 30 g silica gel column and eluted with 25% diethyl ether in petroleum ether yielded 256 mg (84%) of **47** as a dark red oil: IR (neat) 3283, 3077, 2979, 2934, 2863, 2254, 2088, 2046, 2001, 1713,

hexacarbonyl complex (51). 8-Methoxydodec-11-en-6-ynoic acid dicobalt hexacarbonyl complex (61).

According to the general procedure, combination of the carboxylic acid resulting from oxidation of alcohol **24** (52 mg, 0.23 mmol, 1.0 equiv), dichloromethane (1 mL), and dicobalt octacarbonyl (95 mg, 0.28 mmol, 1.2 equiv then 31 mg, 0.09 mmol, 0.4 equiv) followed by direct addition to a 12 g silica gel column and eluted with 15-100% diethyl

General Procedure for the Nicholas Reaction of Cobalt-Complexed Alkynes: 2-(But-3-enyl)oxon-3-yne dicobalt hexacarbonyl complex (26). A 25-mL flask containing cobalt-complexed alkyne **25** (228 mg, 0.46 mmol, 1.0 equiv) was equipped with a rubber septum and gas inlet needle. Dichloromethane (20 mL) was added, the reaction flask was cooled at 0 °C, and boron trifluoride diethyl etherate (58 μL , 0.46 mmol, 1.0 equiv) was added. The reaction was stirred for 30 min then quenched by addition of 20 mL saturated sodium bicarbonate. The organic layer was removed and the aqueous layer was extracted twice with dichloromethane. General Procedure for the Pauson-Khand Reaction of Cobalt-Complexed Alkynes: 3,4,5,6,8a,9,10,10a-Octahydro-2H-pentaleno[1,6-bc]oxonin-7(8H)-one (27 + 28).

Acetonitrile:³ To a 25-mL round-bottomed flask containing cobalt complexed alkyne **26** (132 mg, 0.28 mmol, 1.0 equiv) was added acetonitrile (27 mL). The flask was equipped with a reflux condenser, left open to the air, and heated at reflux (100 °C) for 20 min.

The reaction mixture was then cooled to room temperature, added to a sintered glass funnel containing 5 g silica gel and 5 g celite, and rinsed with ethyl acetate. The filtrate was concentrated to yield 78 mg (136%) of crude products **27** and **28**. The crude product was deposited on 150 mg silica gel and added to a 6 g silica gel column eluted with 20% diethyl ether in petroleum ether to afford 21 mg (19%) of **27** and **28** as a viscous oil with a ratio of **27:28** of 12:1.

N-methylmorpholine-N-oxide (NMO):⁴ A 50-mL three-necked flask equipped with a rubber septum, glass stopper, and gas inlet adapter was charged with the cobalt-complexed alkyne **26** (142 mg, 0.31 mmol, 1.0 equiv) and dichloromethane (12 mL). The flask was cooled at 0 °C, NMO (108 mg, 0.92 mmol, 3.0 equiv) was added, and the reaction was warmed to room temperature. After 45 min, the reaction was again cooled at 0 °C and another portion of NMO (108 mg) was added. The reaction mixture was warmed to room temperature and stirred for 45 min. This process of cooling at 0 °C, adding NMO (108 mg) and stirring at room temperature for 45 min, was repeated a third time. TLC indicated that the reaction had gone to completion so the reaction mixture was added to a sintered glass funnel filled with celite and rinsed with dichloromethane. The filtrate was washed with water and saturated sodium bicarbonate, filtered, and concentrated to yield 70 mg (111%) of a yellow oil. General Procedure of the Pauson-Khand Reaction of Cobalt-Complexed Alkynes: 1-Tosyl-1,2,3,4,6a,7,8,8a-octahydropentaleno[1,6-bc]azepin-5(6H)-one (42).

Cyclohexylamine:⁵ A 20-mL round-bottomed flask containing Nicholas product **40** (93 mg, 0.16 mmol, 1.0 equiv) was equipped with a rubber septum and gas inlet needle. 1,2-Dimethoxyethane (5.5 mL) was added followed by cyclohexylamine (27 μL , 0.24 mmol, 1.5 equiv). The rubber septum was replaced with a reflux condenser and gas inlet adapter and the reaction was heated at 60 °C for 3 h. The heat was removed and the reaction was allowed to stir over night. The reaction mixture was added to a sintered glass funnel filled with celite and washed with ethyl acetate (50 mL) to yield 59 mg (113%) of a

yellow oil. The crude product was applied directly to a 6 g silica gel column and eluted with 30% diethyl ether in petroleum ether to yield 51 mg (98%) of **42**.

According to the general procedure using acetonitrile, combination of Nicholas product **40** (78 mg, 0.13 mmol, 1.0 equiv) with acetonitrile (13 mL) at reflux for 25 min afforded 48 mg of crude product that was deposited on 96 mg of silica gel and added to a 4.8 g silica gel column eluted with 30% diethyl ether in petroleum ether to afford 41 mg (93%) of **2**.

General Procedure for the Mitsunobu Reaction of Alcohols: *N*-(6-methoxydec-9-en-4-ynyl)-4-methylbenzenesulfonamide. A 50-mL two-necked flask equipped with a rubber septum and gas inlet adapter was charged with (fluorenyl)methyl tosylcarbamate⁷

(320 mg, 0.81 mmol, 1.5 equiv), triphenylphosphine (428 mg, 1.63 mmol, 3.0 equiv), and THF (4 mL), and cooled at 0 °C. A separate 25-mL pear flask was charged with alcohol **10** (99 mg, 0.54 mmol, 1.0 equiv) and 2 mL THF. This solution was transferred into the reaction flask via cannula followed by a 1 mL THF rinse. Diethylazadicarboxylate (232 mg, 1.36 mmol, 2.5 equiv) was added to the reaction flask, and the reaction was allowed to stir overnight. The reaction mixture was concentrated to yield 1.27 g (737%) of a yellow oil. General Procedure for the Oxidation of Alcohols to Yield Carboxylic Acids: 6-Methoxydec-9-en-4-ynoic acid.^{8,9} A 25-mL two-necked flask equipped with a rubber septum and gas inlet adapter was charged with Dess-Martin periodinane (717 mg, 1.69 mmol, 1.2 equiv) and dichloromethane (4.5 mL). A separate 25-mL pear flask containing alcohol **10** (257 mg, 1.41 mmol, 1.0 equiv) in 1.0 mL dichloromethane was cannulated

into the reaction flask followed by a dichloromethane (0.5 mL) rinse. The reaction mixture was stirred at room temperature for 2 h, diluted with 15 mL diethyl ether, and transferred to an Erlenmeyer flask containing 15 mL of a saturated sodium bicarbonate solution and 3 g of sodium thiosulfate, and stirred for 5 min. 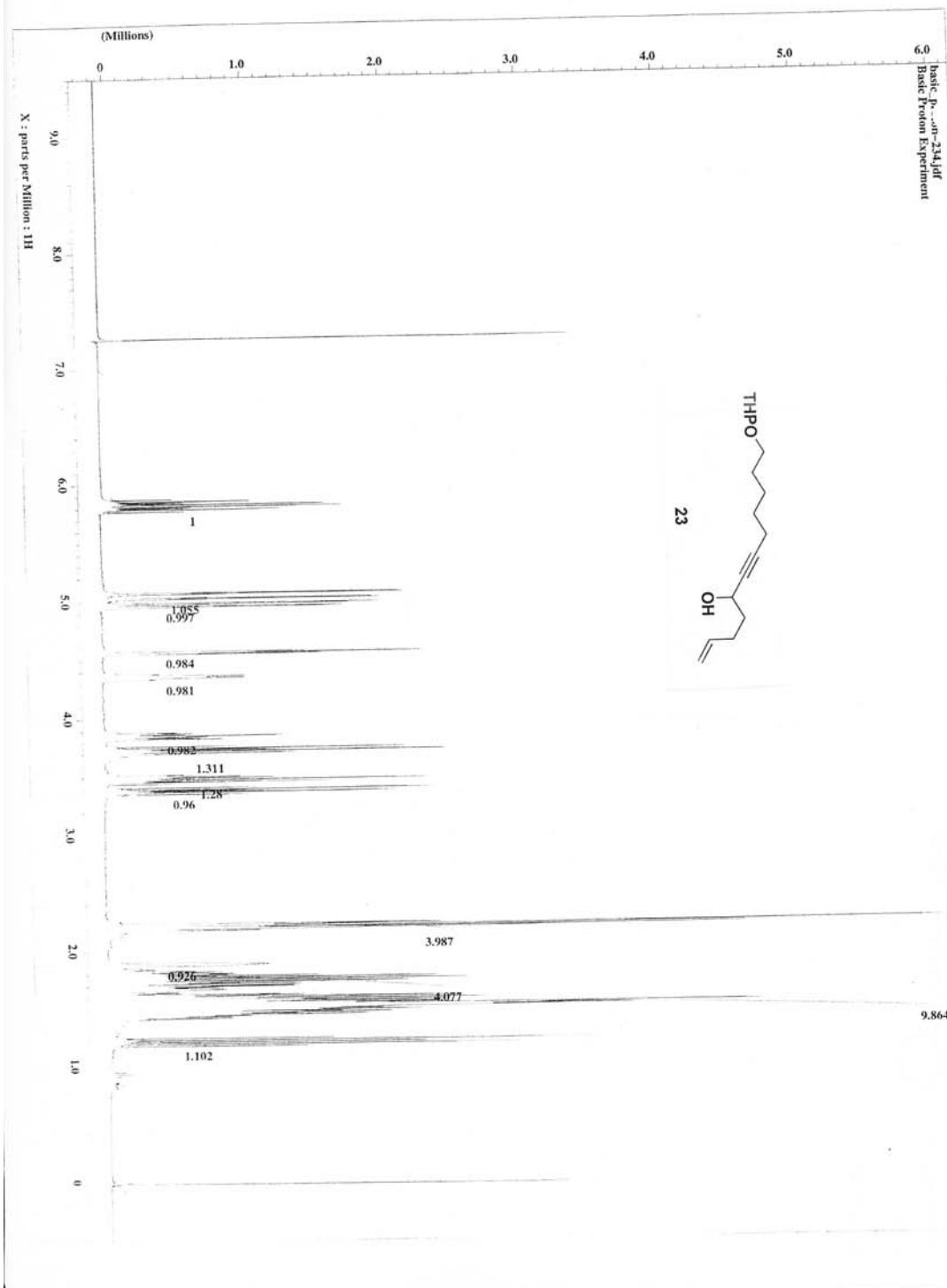
A 50-mL round-bottomed flask containing the previous prepared aldehyde (206 mg, 1.14 mmol, 1.0 equiv) was equipped with a rubber septum and gas inlet needle. Dimethylformamide (12 mL) was added followed by Oxone (703 mg, 1.14 mmol, 1.0 equiv) and the reaction was stirred at room temperature for two hours. The reaction mixture was added to a separatory funnel containing ethyl acetate (30 mL) and 1.0 M hydrochloric acid (30 mL).
