**General** All reactions were carried out under a nitrogen atmosphere in oven or flame dried glassware.

Tris(dibenzylideneacetone)dipalladium (0) and all phosphine ligands were purchased from Strem

Chemical Co. and used without further purification. All aryl bromides except for 4-bromobenzoic acid

tert-butyl ester were obtained from commercial sources (Aldrich Chemical CO or Acros Chemical CO)

and were used as obtained. 4-Bromobenzoic acid tert-butyl ester, 2-allylaniline, and 2-allyl-5-

methoxyaniline<sup>3</sup> were prepared according to literature procedures. Toluene was purified using a

GlassContour solvent purification system. Yields refer to isolated yields of compounds estimated to be

≥95% pure as determined by <sup>1</sup>H NMR, and/or combustion analysis. The yields reported in the

supporting information describe the result of a single experiment, whereas the yields reported in Tables

1 and 2 are average yields of two or more experiments. Thus, the yields reported in the supporting information may differ from those shown in Tables 1 and 2.

General procedure for the one-pot palladium-catalyzed synthesis of N-aryl-2-benzylindolines using two equivalents of a single aryl bromide (Table 1). An oven or flame-dried Schlenk tube was cooled under a stream of nitrogen and charged with Pd<sub>2</sub>(dba)<sub>3</sub> (1 mol % complex, 2 mol % Pd), dpe-phos (2 mol %), NaOtBu (2.2 equiv), and the aryl bromide (2.05 equiv). The tube was purged with nitrogen and a solution of the aniline substrate (1.0 equiv) in toluene (4 mL/mmol substrate) was added. The mixture was placed in a pre-heated oil bath at 105 °C with stirring until the starting material had been consumed as judged by GC or ¹H NMR analysis. The reaction mixture was cooled to room temperature, quenched with saturated aqueous NH<sub>4</sub>Cl (2 mL) and diluted with ethyl acetate (10 mL). The layers were separated and the aqueous layer was extracted with ethyl acetate (2 X 10 mL). The combined organic extracts were dried over anhydrous sodium sulfate, filtered, and concentrated in vacuo. The crude product was then purified by flash chromatography on silica gel.

**2-Benzyl-1-phenyl-2,3-dihydro-1***H***-indole** (Table 1, Entry 1). **1-Naphthalen-1-yl-2-naphthalenylmethyl-2,3-dihydro-1***H***-indole** (Table 1, Entry 3). Reaction of 34 mg (0.25 mmol) of 2-allylaniline with 1-bromonaphthalene (71 μL, 0.51 mmol) and NaOtBu (53 mg, 0.55 mmol) following the general procedure afforded 90 mg (93 %) of the title compound as a colorless viscous oil. This material was obtained as a 2.3:1 mixture of rotamers as judged by <sup>1</sup>H NMR. The signals for the two rotamers coalesced when dissolved in t<sup>8</sup>-toluene and heated to 75 °C. General procedure for the one-pot palladium-catalyzed synthesis of N-aryl-2-benzylindolines using two different aryl bromides (Table 2). An oven or flame-dried Schlenk tube was cooled under a stream of nitrogen and charged with Pd<sub>2</sub>(dba)<sub>3</sub> (0.5 mol % complex, 1 mol % Pd), *t*-Bu<sub>2</sub>P(*o*-biphenyl) (2 mol %), NaO*t*Bu (2.1 equiv), and the first aryl bromide (1.0 equiv). The tube was purged with nitrogen and a solution of the aniline substrate (1.0 equiv) in toluene (4 mL/mmol substrate) was added. The mixture was placed in a pre-heated oil bath at 80 °C with stirring until the starting material had been consumed as judged by GC or <sup>1</sup>H NMR analysis. While maintaining the reaction mixture at 80 °C, a solution of a catalytic amount (2 mol %) of dpe-phos in toluene (0.5 mL)

was added to the reaction mixture, and after 10 min of stirring at 80 °C, the second aryl halide (1.0 equiv) was added neat. When the intermediate arylamine had been consumed (as judged by GC or <sup>1</sup>H NMR analysis), the reaction mixture was cooled to room temperature, quenched with saturated aqueous NH<sub>4</sub>Cl (2 mL) and diluted with ethyl acetate (10 mL). The layers were separated and the aqueous layer was extracted with ethyl acetate (2 X 10 mL). The combined organic extracts were dried over anhydrous sodium sulfate, filtered, and concentrated in vacuo. The crude product was then purified by flash chromatography on silica gel.
