## Help Beat Cancer Green Flexi SR August 2024 DM1

**Terms & Conditions** 





- 1. For this tariff, certain elements of the unit rate and standing charge payable by you are calculated by reference to applicable industry indices. These elements include network, social and environmental obligation costs that we are required to pay as an energy supplier but you can find all of the relevant elements, indices, applicable rates and the most recent prices on our website scottishpower.co.uk/flexi.
  - The charges payable by you may increase or decrease by reference to the applicable indices, which are updated on a quarterly basis on 1st January, 1st April, 1st July and 1st October. When these charges are updated they will apply for that quarter until the next quarterly update. The initial charges payable for this tariff will be as set out in the tariff confirmation letter. Whilst this tariff is for a fixed term, the charges payable by you will be updated and adjusted in accordance with the terms above. You understand and agree that any such adjustments of charges do not constitute a change to your disadvantage for the purposes of clause 19 of the ScottishPower Gas and Electricity General Terms and Conditions for Domestic Customers. If there is any conflict or inconsistency between these terms and the ScottishPower Gas and Electricity General Terms and Conditions for Domestic Customers, these terms take precedence. Where any of the applicable industry indices ceases to be published, we may replace them with an appropriate equivalent index or, where there is no appropriate equivalent index, we will, acting reasonably, calculate the appropriate charge or fix that charge. The first charges update for this tariff will be on 1st July 2022.
- 2. ScottishPower Limited pursues its activities in the United Kingdom through ScottishPower UK Plc, a company which owns and controls the following companies (hereinafter collectively referred to as the "ScottishPower Group"): ScottishPower Energy Networks Holdings Limited, which engages in the activities of transmission and distribution of electricity; ScottishPower Retail Holdings Limited, which engages in the activity of supplying energy to domestic and non-domestic customers; and ScottishPower Renewable Energy Limited, which engages in the activities of investing in and generating renewable energy. This tariff is provided by ScottishPower Energy Retail Limited (hereinafter referred to as "ScottishPower", "us", "we" or "our"), a subsidiary of ScottishPower Retail Holdings Limited and a part of the ScottishPower Group.
- 3. The Help Beat Cancer Green Flexi SR August 2024 DM1 tariff ("Tariff") will be available until the date when the Tariff is withdrawn from sale by us.
- 4. This Tariff is available to new and existing customers. You must be aged 16 years or over and must contract to pay, and continue to pay, for the energy supply under the Tariff by monthly Direct Debit, quarterly Direct Debit, Monthly Bill, online Debit Card, quarterly by Cash, Cheque or Postal Order and their electricity meter is a single, two or multi rate meter. All applicants agree that all contact between the parties will be managed and facilitated electronically through our online system or by email.
- 5. The Tariff ends on 31st August 2024 ("End Date") unless the actions or requirements of any governmental, statutory or licensing authority means that we need to change the End Date.
- 6. A donation will be made by ScottishPower to Cancer Research UK Trading Limited, which gives its taxable profits to Cancer Research UK, for every month you are on the Tariff up to a maximum donation of £5 per fuel per annum for each completed 12 month period until the end of the Tariff term. If you are not on this tariff for the full Tariff term a pro-rata amount will be donated based on the number of complete calendar months you were on the Tariff. The donations will be paid as soon as reasonably practicable after each calendar quarter end.
- 7. ScottishPower will match 100% of your electricity consumption to renewable energy generated by the ScottishPower Group. We will do this by matching every MWh of electricity consumed on this tariff with a Renewable Energy Guarantee of Origin (REGO) certificate sourced directly from the ScottishPower Group's own renewables generation of over 7.2TWh. Ofgem issue a REGO certificate for every MWh of eligible renewable output to generators of renewable electricity in the UK, including the ScottishPower Group's own installed renewable generation capacity.
  - Based on the national average fuel mix for 2020-2021, a UK consumer with medium typical domestic annual consumption of 2,900kWh of electricity will produce CO2 emissions totalling 528kg. As we will match your consumption with a ScottishPower Group sourced REGO certificate, the annual CO2 emissions under your tariff for electricity will be zero. - 8. If you cancel your Tariff by switching to another energy supplier, with the transfer fully completing more than 49 days before the End Date, we will apply exit fees. The current exit fees are £150.00 per fuel.



These exit fees will be amended if there is a change in the VAT treatment, or rate, at any time or times more than 49 days before the End Date by an amount equivalent to the applicable change in the VAT treatment or rate. These exit fees will not be applied if the agreement is cancelled due to a home move. However, you have the freedom to move to an alternative tariff at any point without paying any exit fees.

- 9. We will write to you before the end of the Tariff to let you know what will happen next. Unless you choose another option, we will move you to another tariff on the same payment method and will provide further details of this tariff and the impact to you in this communication. At the end of the Tariff you will also have the option to cancel your contract with us without being required to pay exit fees.
- 10. The prices given in this leaflet are those you pay under your contract for your Tariff and replace any mains gas and/or electricity prices which you may currently pay.
- 11. The obligations on ScottishPower under the Tariff and these terms and conditions will not come into effect until we have been registered as the supplier of mains gas and/or electricity to the property.
- 12. If you leave the property to which this Tariff applies, you will not be able to transfer this current Tariff to another property. However, you will be entitled to apply for any ScottishPower tariff, for which you meet the eligibility criteria, that is available when you move property.
- 13. Any quote given to you for this Tariff is based on the information you have provided to us. If we become aware this is not accurate, we will advise you of the correct prices in writing.
- 14. If you pay by Monthly Direct Debit and fail to make a payment to us under this payment method when it is due, we shall be entitled to transfer you to an appropriate cash payment method on this Tariff. This will increase your unit rates by 1.103p per kWh for electricity and 0.393p per kWh for gas (both inclusive of VAT). If you have more than one unit rate for electricity, each unit rate will increase by the same amount. If you pay by another payment method and fail to make a payment to us under your payment method when it is due, we shall be entitled to transfer you to an appropriate cash payment method on our Standard tariff. We will notify you of any changes to your payment method and prices should this be necessary.
- 15. These terms and conditions are in addition to the ScottishPower Gas and Electricity General Terms and Conditions for Domestic Customers.
- 16. By taking the Tariff, you agree to ScottishPower or Cancer Research UK contacting you, including by email, for the duration of the Tariff to thank you for your continuing support and to update you on news relating to the work of Cancer Research UK.
