

THE FORESTRY ORDINANCE (Cap. 86)

THE FORESTRY (DEMBELIA MUSAIA ROADSIDE PROTECTED FOREST) ORDER IN COUNCIL, 1956

In exercise of the powers conferred upon the Governor in Council by section 14 of the Forestry Ordinance, the following Order is hereby made at the request of the Tribal Authority of the Dembelia-Musaia Chiefdom, Koinadugu District, Northern

1. This Order may be cited as the Forestry (Dembelia Musaia Roadside Protected Forest) Order in Council, 1956.

2. The lands described in the Schedule to this Order are hereby constituted a Protected Forest within the meaning of the Forestry Ordinance.

SCHEDULE

All that land comprising 173.50 acres or thereabouts lying within 710 feet on the right hand of the centre of the motor road from Kabala to Musaia in Dembelia Musaia Chiefdom;

Commencing at the junction of the Kabala-Musaia road with the road from Kabala to Sinkunia and ending at a stone cairn about 266.50 chains from the starting point measured along the centre of the road in the direction of Musaia town provided that the following areas shall be excluded from the Protected Forest.

Those areas lying on the right hand side and within 710 feet of the centre of the motor road as defined in the following table-

(1) All distances in the above table are approximate in Gunter's chain of 66 feet and are measured along the centre of the motor road in the direction

(2) All that Land lying on the right hand side of and within 50 feet of the centre of the road and not excluded above.
