

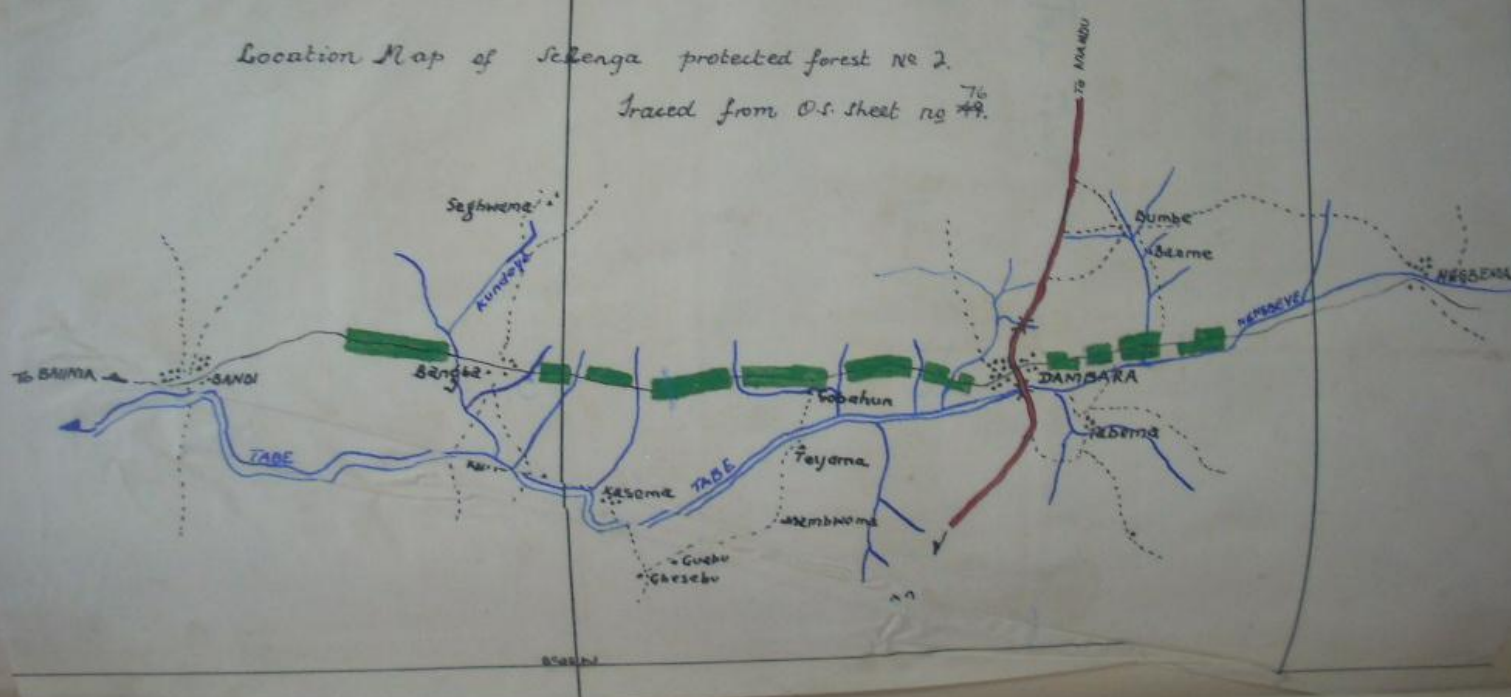

PUBLIC NOTICE No. 16 OF 1976

*Published 3rd June, 1976***THE FORESTRY ACT**
(Cap. 189)

Short title. THE FORESTRY (SELENGA NO. 2 PROTECTED FOREST) (AMENDMENT) ORDER, 1976

In exercise of the powers conferred upon him by section 15 of the Forestry Act, the President acting in accordance with the advice of Cabinet hereby makes the following Order:—

Amendment of Schedule Vol. VII Page 1624. 1. The Schedule to the Selenga No. 2 Protected Forest is hereby revoked and replaced by the following new Schedule—

THE SCHEDULE

All that land comprising 245.28 acres or thereabouts lying within 210 feet on either side of the Hammock trail starting from the Negbei River which is the Niawa Lenga Chiefdom boundary and ending on the Pambaye Stream which is the Baima Chiefdom boundary:

Provided that the following areas shall be excluded from the Protected Forest as shown in the following table:
