Your privacy is hugely important to us.

Here at CNG we're all about putting you, the customer (or potential customer – come on, what're you waiting for?!) first. You're our Numero Uno. The Batman to our Robin.

Our Number 1.

More than anything, we want you to be confident that the information you provide to us when accessing our website is protected. So in this Privacy Policy we'll explain how we, CNG, use your data to give you the best and safest browsing experience around.

CONTROLLER

CNG is made up of different legal entities: CNG (Group) Ltd, CNG Ltd, CNG Electricity Ltd, TEGS Ltd, CNG Software Ltd, CNG 2 Ltd and CNG Marketing Ltd.

This Policy is issued on behalf CNG Group Ltd, so when we mention 'CNG Group Ltd', 'we', 'us' or 'our', we are referring to the relevant company in CNG Group responsible for processing your data. This will be made known to you once you buy a product or service from us. CNG Group Ltd is the controller and responsible for this website.

COLLECTION AND PROCESSING OF PERSONAL DATA

Personal data is information that can identify you, such as your name, email address or postal address. This data will only be saved by CNG if you make it available to us in the places identified in this Privacy Policy.

We may collect, use, store and transfer different kinds of personal data about you which we have grouped together:

- **Identity Data** includes first names, maiden name, last name, username or similar identifier, marital status, title, data of birth and gender
- **Contact Data** includes billing address, other site address, email address and telephone numbers
- **Consumption Data** includes meter readings, invoices and site data
- **Financial Data** includes bank account and payment card details
- **Transaction Data** includes details about payment to and from you
- **Technical Data** includes IP address, login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform and other technology on the devices you use to access this website
- **Usage Data** includes information about how you use our website
- **Marketing and Communications Data** includes preferences in receiving marketing from us and our third parties and your communication preferences.

FREEDOM OF CHOICE

Any information that you provide to CNG is always under your full control.

Where we need to collect personal data by law, or under the terms of a contract we have with you and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (i.e. to provide you with a good or service). Here, we may have to cancel a product or service you have with us but we will notify you if this is the case at the time.

INFORMATION YOU CAN PROVIDE TO US

We may collect and process information you provide in the following forms found on the CNG website:

QuoteTool (<https://www.cngltd.co.uk/contact/get-a-quote>)

Allows you to receive a quote for a gas and/or electricity contract when you provide the following data:

- Postcode
- Address selection from a drop-down menu
- MPRN (gas meter) and/MPAN (electric meter) details

Meter Readings (<https://www.cngltd.co.uk/customers/submit-reading>)

Customers can submit current and actual meter readings to CNG through a secure website. The following mandatory data must be provided when submitting a meter reading:

- Name
- Account Reference
- Meter Reading (gas or electric)
- Email address
- Telephone number

Live Chat

You can chat live with a CNG Operator on the CNG website. These conversations are automatically emailed to you as a full transcript from the following email address: info@cngltd.co.uk.

Information provided here may be processed for the sole purpose it was provided, and not for any other purpose.

Feedback (<https://www.cngltd.co.uk/contact>)

You can leave feedback for CNG at any time. The following personal data can be submitted:

- Name
- Telephone number
- Postcode
- Email address
- Any information provided in a free-form message

AMR and Partner Login (<https://partners.cngltd.co.uk/agentportal/>)

CNG operates a portal for our agents, brokers and Third Party Intermediaries (“TPIs”) to access data and reports applicable to them.

Your credentials for gaining access to this secure site are not saved by CNG and are private to you. There is no facility to submit data within the secure website.

And the following ways outside of the website:

Direct interactions

You may give us Identity, Contact and Financial Data by completing forms or speaking with us via post, phone, email or otherwise. This includes when you:

- Sign a contract to receive services from us
- Request marketing to be sent to you
- Give us feedback
- Call us

Third parties or publicly available sources

We may receive personal data about you from various third parties and public sources, as set out below:

- Identification, Contact and Marketing and Communications Data from Brokers, agents and third-party intermediaries. CNG operates a broker model, so in all likelihood your first contact with CNG will be via one of these three
- Identification, Financial and Transaction Data from providers of payment providers
- Technical and Usage Data from analytics providers such as Google as set out below
- Identity and Contact Data from publicly available sources – such as Companies House, social media platforms and the Electoral Register based inside the EU

WHERE WE STORE YOUR PERSONAL DATA

All information you provide to us is stored on our secure servers.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the absolute security of your data transmitted to our site; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

USE AND TRANSMISSION OF PERSONAL DATA

Generally, CNG will only use your personal data to answer your queries, process your quotes, and provide meter readings or store feedback and communications from you. We will NEVER use your personal data other than as permitted via data protection law, or in a way that doesn't fit in with CNG values.

Data transferred to countries outside of the United Kingdom, but within the EEA, will only occur where it is permissible under data protection law. Specifically here, the data importer must guarantee an equivalent or better level of data protection in accordance with EU standard data protection clauses.

Where data needs to be transferred outside of the EEA, we will not only get your explicit consent to do this but also ensure that this country has equivalent protections as the UK.

Generally, we do not rely on consent as a legal basis for processing your personal data other than in relation to sending marketing communications to you via email or text message. PURPOSES FOR WHICH WE'LL PROCESS YOUR PERSONAL DATA

Below you'll find a description of the ways in which CNG plans to use your personal data, and what legal basis we rely on to do this. We have also identified what our legitimate interests are, where appropriate. To find out what a legitimate interest is further, please see the Glossary.

Please be aware that CNG may process your personal data for more than one lawful ground depending on the specific purpose for which we are using your data. DISCLOSURE OF YOUR INFORMATION

We may have to share your personal data with the parties set out below for the purposes set out in the table directly above.

- Specific third parties – listed in the table above
- Third parties to whom we may choose to sell, transfer or merge parts of our business or our assets. Alternatively, we may seek to acquire other businesses or merge with them. If a change happens to our business, then the new owners may use your personal data in the same way as set out in this Privacy Policy.

We require all third parties to respect the security of your personal data, treat it in accordance with data protection law and to live to the same values as CNG. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

INFORMATION ON WEB ANALYSIS

Google Analytics

This website uses Google Analytics, a service provided by Google, Inc.

This service allows CNG to analyse how users use the site. The tool uses “cookies,” which are text files placed on your computer, to collect anonymised Internet log information and visitor behaviour information. The information generated by the cookie about your use of the website (including your IP address) is transmitted to Google. This information is then used to evaluate visitors’ use of the website and to compile statistical reports on website activity for Contract Natural Gas Limited.

We will never (and will not allow any third party to) use the statistical analytics tool to track or to collect any Personally Identifiable Information of visitors to our site. Google will not associate your IP address with any other data held by Google. Neither we nor Google will link, or seek to link, an IP address with the identity of a computer user. We will not associate any data gathered from this site with any Personally Identifiable Information from any source, unless you explicitly submit that information via a fill-in form on our website.

COOKIES & RETARGETING

The website www.cngltd.co.uk uses cookies to offer users a simplified browsing experience, by automatically entering data on forms.

CNG uses the following cookies, no personal information is stored in them:

- CngPhpSession

Most browsers are set by default to accept cookies, but you are prompted to opt out of the use of cookies at the bottom of this page. Individuals who do not wish to use cookies on their visit to the CNG website may be unable to access certain parts of the website.

Cookies allow CNG to collect and store anonymous information such as: device type, operating system, browser version and geographic location.

Cookies do not collect personal data, or any data which could identify you. Cookies disappear after 60 days of no interactions, unless deleted by you on your person computer settings. If you revisit the site then the cookie’s lifespan is reset to a further 60 days.

HOW LONG WE WILL STORE YOUR DATA FOR

To ensure your data is not processed for longer than is necessary, CNG will only store personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting or reporting requirements.

To determine the appropriate retention period for personal data, we consider the amount, nature and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.

YOUR RIGHTS

Right to withdraw consent

CNG makes sure that you can withdraw consent as easily as providing it.

Simply contact the DPO team on DPO@cngltd.co.uk should you wish to withdraw consent for data that we process on your behalf.

The ability to withdraw your consent is subject to CNG not requiring this for a lawful basis as listed above. For example, if you are a customer and you withdraw your consent from us credit checking you, then this can only be aided where we have previously taken a credit check or we have other evidence of your creditworthiness.

Right to object or restrict our processing

You have the right to ask us not to process your personal data for marketing purposes. We will request consent from you (before collecting your data) if we intend to use your data for such purposes or if we intend to disclose your information to any third party for such purposes.

You can exercise your right to prevent such processing by checking certain boxes on the forms we use to collect your data.

You also have the right to restrict our processing for certain companies that we use to assist us in providing an amazing service to you.

Right to Access

You can request access to any of your information, at any time, free of charge as long as the request is not unduly burdensome to CNG.

To submit a request for access to your data, CNG offers an easy-to-use (non-obligatory) form to make sure you get exactly the data you want. To receive this form, or submit a request for access without using the form, please email the CNG Data Protection team at DPO@cngltd.co.uk.

Right to rectify

If any data we hold about you is incorrect, or your personal details change for whatever reason, please contact CNG at info@cngltd.co.uk or call on 01423 502 554.

Right to erase

Under certain conditions, our customers can request any personal data we hold on them be erased. Such requests are considered alongside CNG's overarching right to keep data for retention purposes.

Right to data portability

We will always offer your data, where requested, in a format that is easily accessible by you. The formats offered are:

- Large request – a minimum of recorded delivery or an encrypted USB Drive
- Small request – an encrypted email or secure file sharing provider

Automated decision-making and profiling

Automated decision-making is a decision made automatically without any involvement from a human – typical examples here would be for when you apply for a loan, or a credit card.

CNG does not use automated decision making internally, but our external partners may use it for when we request a credit check for you. We will always share this data with you, including the logic used in the decision making, the significance and potential consequences and give you the right to request human intervention and challenge the decision.

We do not make any decisions based solely on automated decision-making.

NO FEE USUALLY REQUIRED

You will not have to pay a fee to access your personal data, or to exercise any of your other rights. However, we have the right to charge a reasonable fee if your request is clearly unfounded, repetitive or excessive. We may also refuse to comply with your request in these circumstances.

WHAT WE MAY NEED FROM YOU

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data. This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.

TIME LIMIT TO RESPOND

We try to respond to all legitimate requests within one month. It may, on occasion, take us longer than a month if your request is particularly complex or you have made a number of concurrent requests. In this case, we will notify you and keep you updated.

EXTERNAL INTERNET SITES

CNG is not responsible for the content of external internet sites.

GLOSSARY

Lawful basis:

Legitimate interest means the interest of our business in conducting and managing our business to enable us to give you the best service and the most secure experience. We make sure we consider and balance any potential impact on you and your rights before we process your personal data for our legitimate interests. We do not use your personal data for activities for our legitimate interests. We do not use your personal data for activities where our interests are overridden by the impact on you unless we have your consent or are otherwise permitted by law.

Performance of a Contract means processing your data where it is necessary for the performance of a contract which you have signed, or to take steps at your request before entering into such a contract.

Comply with a legal or regulatory obligation means processing your personal data where it is necessary for compliance with a legal or regulatory obligation that we are subject to.

Internal Third Parties:

Other companies in the CNG Group (who act as joint controllers or processors) and who are based in the United Kingdom and provide IT and system administration services, leadership reporting and Ofgem licensed activities.

External Third Parties:

- Service providers acting as processors based in the United Kingdom who provide IT and system administration and operational administration services.
- Professional advisors acting as processors or joint controllers including lawyers, bankers, auditors and insurers based in the United Kingdom who provide consultancy, banking, legal, insurance and accounting services.
- HM Revenue and Customs, regulators and other authorities acting as processors or joint controllers based in the United Kingdom who require reporting of processing activities in certain circumstances.
