This Chart includes the respective positions of the Lender and the Manager without a position of the Owner. The Owner should be interested in the negotiation of the SNDA, but generally, the Owner simply wants Lender and Manager to agree on a document to permit the Owner to close on its financing and move forward. The Owner's desire is that there is peace between Lender and Manager so that the financing transaction can close.

Lender may sell the Hotel at foreclosure to the highest bidder.
